- 2. Tenure of one of the presently nominated member of NSEZ Authority is going to expire on 14.03.2024. Accordingly, NSEZ Authority is in process to nominate a representative from Trade, NSEZ. It may be noted that as per Instruction No. 82 dated 10.09.2014, units fulfilling the following criteria shall only be eligible to further ascertain their eligibility as per weightage system in terms of their performance in export, investment, and employment as prescribed in Instruction ibid for consideration of nomination
 - i. The member proposed for nomination should be a Proprietor / Partner / Chairman / Managing Director / Director of the concerned unit;
 - ii. The said unit should be operational for a minimum period of 5 years;
 - iii. There should be no dues pending against the said unit;
 - iv. The said unit should not have violated any provision of SEZ Act and Rules;
 - v. No penalty should have been imposed on the said unit in last 3 year and
 - vi. The member proposed for nomination should be available to attend the meeting and participate in the decision making process of the Authority.
- 3. You are requested to forward requisite information as per Annexure enclosed herewith (after ensuring fulfillment of primary criteria mentioned in the Para 2 above) to this office latest by **06.03.2024** for considering nomination in terms of guidelines prescribed in Instruction No. 82 dated 10.09.2014.
