Minutes of the Approval Committee meeting in respect of 100% Export Oriented Units held under the chairmanship of Shri A. Bipin Menon, Zonal Development Commissioner, NSEZ, Noida at 12:00 PM on 12.06.2025 through Video Conferencing.

The following members of the Approval Committee were present during the meeting: -

- i. Shri Surender Malik, Joint Development Commissioner, Noida Special Economic Zone, Noida.
- ii. Ms. Hemlata Hendau, Assistant DGFT, Office of the Additional DGFT, Central Licensing Authority, New Delhi.
- iii. Shri Jeewan Ram Dhaka, Assistant Commissioner (Tech), O/o of Commissioner of Customs (Preventive), Jodhpur.
- iv. Shri Siya Ram Meena, Assistant Commissioner of Customs, Noida, ICD Dadri.

Besides, during the Approval Committee meeting Shri Gya Prasad (Deputy Development Commissioner), Shri Mohan Veer Ruhella (Assistant Development Commissioner) and Shri Sunil Gulyani (Steno), NSEZ were also present to assist the Approval Committee. It was informed that the quorum was available and the meeting could proceed.

At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well, as interaction with the applicants/units wherever required, the following decisions were taken: -

1. Ratification of the Minutes of the Approval Committee meeting held on 07.04.2025-

It was informed to the Committee that no reference in respect of the decisions of the Approval Committee held on 07.04.2025 was received from any of the members of the Approval Committee or Trade, Hence the minutes of the meeting held on 07.04.2025 were unanimously ratified.

2 . Application of M/s Exotic Marbles LLP at Madri, Devasthan, N.H. 8, Rajsamand, Udaipur, Rajasthan -313001 for setting up a new 100%EOU Unit.

2.1 It has been informed to the committee that M/s Exotic Marbles LLP, a partnership firm, submitted an application dated 28.11.2024 for setting up a 100% Export Oriented Unit (EOU) at Madri Devsthan, N.H. 8, Rajsamand, Rajasthan, for the manufacture and export of "**Marble Blocks / Tiles and Granite Blocks / Tiles (ITC HS Codes: 68022110 and 68022310)**". The proposed investment of the unit



is Rs. 135.00 lakhs and proposed employment is 15 persons.

2.2 Earlier, the proposal was placed before the Unit Approval Committee (UAC) meeting held on 13.02.2025. As per minutes of the said meeting, the proposal was deferred for completion of necessary compliances i.e. construction of boundary wall, separate entry and exit, provision of security guards, cameras and fire-fighting equipment then re-verification was conducted by the Customs authorities (Preventive Wing, Jodhpur), vide their letter no. CUS/LIC/EOU/62/2024-Tech dated 03.06.2025, confirmed that the unit now met all infrastructural and security requirements as per Para 6.01 of the Handbook of Procedures under the Foreign Trade Policy.

2.3 Now, after the above compliance's, unit's application was placed before the Approval Committee. Shri Rajendra Vaishnav, Partner of the unit attended the meeting through video conferencing and explained the proposal in detail. He informed that they will import rough marble and granite blocks and slabs and after re-furbish, they will export the same.

2.4 The Committee, after detailed deliberations, approved the proposal of the unit subject to submission of revised Form ANF-6A with revised Investment in imported machinery.

3 . Application of M/s Braber Equipment India LLP-at Plot No A-11, Sector-84, Noida, for setting up a new 100%EOU Unit.

3.1 It has been informed to the committee that M/s Braber Equipment India LLP, a partnership firm, submitted an application dated 08.01.2025 and 27.05.2025 for setting up a 100% Export Oriented Unit (EOU) at **Plot No A-11, Sector-84, Noida**, for the manufacture and export of 330 Numbers of "**Parts, Assembly and Accessories for equipment of Agricultural, Construction, Forestry, Lawn Garden and Industrial and allied products**". The proposed investment in plant and machinery of the unit is Rs. 750.00 lakhs and proposed employment is 28 persons. It was also informed to the Committee that on observation of reply dated 27.05.2025 submitted by the Unit, following deficiencies still observed:-

- i. Unit has marked Application is for: BOARD OF APPROVAL, whereas earlier marked as AUTOMATIC APPROVAL.
- ii. Proposed Export projections in USD at Column (VIII) and (XII) found mismatch.



- iii. Column (XVII) and (XVIII) of ANF-6A completely left blank.
- iv. Only signatures are mentioned at the end of the application. Name, designation, Tel. No., email, website, Full residential Address, Place and Date left blank.
- v. Unit has submitted Income Tax Returns in respect of one Designated partner Sh. Velu Karuppiyah for the last 3 years of the partners. ITRs in respect of other partners may be requested.
- vi. Copy of PAN, Passport and brief introduction in respect of (i)**Mrs. Jackie McAleese; and (ii) Mr. Rory Bjarnason may be requested;**
- vii. As per List of proposed Item of Manufacture, unit has now submitted list of 330 items. Upon going through the list, it has been noted that the HSN Codes and Item Names do not completely matched against a number of entries. Hence, it may be advised the unit to mention 'Item of Manufacture' as per details given mentioned against each HSN Code in the Export Policy 2022. This list of items contains HSN code and Item Name. Capacity against each items may also be requested. Further, this list should be self-certified.
- viii. Copy of Memorandum of Articles in respect of M/s Niccur Holdings LLP may be obtained. As per LLP Agreement, M/s Niccur Holdings LLP has been registered in Canada.
- ix. Unit has stated that they have an operational DTA unit with the same name in Ludhiana, Punjab. Copy of Balance Sheet in respect of the existing business for last three years may be obtained.

3.2 It was also informed to the Committee that as per the Visit Report dated 28.03.2025 forwarded vide letter dated 15.04.2025 by the Assistant Commissioner (EOU), Noida Customs Commissionerate, the declared premises was found safe and secure with nothing adverse being noticed during the visit.

3.3 Shri R.P. Chouhan and Shri Sunil Sharma, Representatives of the unit joined physically and Shri Velu Karuppiyah joined the meeting through video conferencing and explained the proposal in detail.

3.4 The Committee, after detailed deliberations, approved the proposal of the unit subject to submission of satisfactory reply of all deficiencies as mentioned at para 3.1 above.

The Meeting was ended with a vote of thanks to the Chair.
