Minutes of the Approval Committee meeting in respect of 100% Export Oriented Units held under the chairmanship of Shri A. Bipin Menon, Zonal Development Commissioner, NSEZ at 10:00 AM on 15.10.2024 through Video Conferencing.

The following members of the Approval Committee were present during the meeting:-

- (i) Shri Sugriva Meena Principal Commissioner of Customs, Jaipur.
- (ii) Shri Surender Malik, Joint Development Commissioner, NSEZ.
- (iii) Shri Jagdish Chander, Assistant DGFT, Office of the Additional DGFT, Central Licensing Authority, New Delhi.

Besides, during the Approval Committee meeting Shri Gya Prasad, Deputy Development Commissioner, NSEZ, to assist the Approval Committee. It was informed that the quorum was available and the meeting could proceed.

At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants/units wherever required, the following decisions were taken:-

1. Ratification of the Minutes of the Approval Committee meeting held on 07.10.2024:-

It was informed to the Committee that no reference in respect of the decisions of the Approval Committee held on 07.10.2024 was received from any of the members of the Approval Committee or Trade, Hence the minutes of the meeting held on 07.10.2024 were unanimously ratified.

2. Inclusion of additional items in Annexure-I of LUT M/s Vaibhav Global Limited

M/s Vaibhav Global Limited was issued LOP No. 10-21/99-100%EOU-I/308 dated 03.06.1999 for manufacture and export of Cut & Polished Precious / Semi - Precious / Synthetic Stones / Diamonds, Jewellery of Gold / Silver / Platinum / Copper / Bronze / German Silver, Stainless Steel Gillette (Plain and Studded with Stones and Diamonds. The date of commencement of production was 22.03.2000, current five year block was from 01.04.2020 to 31.03.2025 and the unit had maintained positive NFE during the current block upto 31.03.2024. As per APR for 2024-24, the Unit's total exports were Rs. 20865.65 Lakhs.

2.1 Vide letter dated 18.09.2024 informed that they were exporting gift boxes of \$3 Lacs per months. Moreover, in the upcoming festival season, like Christmas and New Year the export orders were expected to increase. Vide this office letter dated 30.01.2024, the unit was granted permission for broad banding the following products as are under:-

2.2 Due to some unavoidable circumstances and some external reasons, the unit was not able to start manufacturing these products. As per current export order in hand and upcoming festival session unit have request to allow above products for import with the process of clubbing, packing and subsequent exports in "Gift Boxes".

2.3 The Approval Committee after due deliberations taking into account the definition of manufacturing (para 9.31 of FTP) and provision of consolidation (para 6.01(k) of FTP) approved the proposal of the unit barring imitation jewellery. The export of gift boxes would occur under HS 95059090.
