**NOIDA SPECIAL ECONOMIC ZONE Minutes of the Approval Committee meeting in respect of 100% Export Oriented Units held under the chairmanship of Shri A. Bipin Menon, Zonal Development Commissioner, NSEZ at 12.30 PM on 18.07.2024 through Video Conferencing.**

The following members of the Approval Committee were present during the meeting:-

1. Shri Surender Malik, Joint Development Commissioner, NSEZ.
2. Shri Jagdish Chander, Assistant DGFT, Office of the Additional DGFT, Central Licensing Authority, New Delhi.
3. Shri Rajesh Yadav, Assistant Commissioner of Customs, Preventive Office of the Commissioner of Customs, Jodhpur 'C' Scheme, Jaipur-302005.

Besides, during the Approval Committee meeting i) Shri Gya Prasad, Deputy Development Commissioner, NSEZ, ii) Shri M. V. Ruhella, Assistant Development Commissioner AND (iii) Shri Sunil Gulyani, Stenographer were also present to assist the Approval Committee. It was informed that the quorum is available and the meeting can proceed.

At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants/units wherever required, the following decisions were taken:-

1. (2024) Ratification of the Minutes of the Approval Committee meeting held on 20.05.2024:-

It was informed to the Committee that no reference in respect of the decisions of the Approval Committee held on 20.05.2024 was received from any of the members of the Approval Committee or Trade, Hence the minutes of the meeting held on 20.05.2024 were unanimously ratified.

**2 (2024) Application of Renewal of LOA for next five year M/s Rishabh Green marbles Pvt. Ltd.**

It has been informed that M/s Rishabh Green Marble Pvt. Ltd. is a 100%EOU of Udaipur, having LOP No. 12-222/2000-100%EOU-I dated 23.03.2000 for manufacture and export of marble slabs /tiles and marble blocks. As per record, the unit's DCP was 31.03.2000 with the last block valid upto 31.03.2020. The unit, vide letter dated 27.07.2020, applied for extension of validity of LOP which was



extended upto 31.03.2021.

2.2 Since, the LOP of the unit was valid up to 31.03.2021 and the LOP of the unit was not extended, the proposal of the unit was placed before Unit Approval Committee in its meeting held on 27.02.2024 and the Committee deliberated on the proposal and directed to seek a report from jurisdictional Customs Authorities that how the unit had exported its goods despite lapse in the validity of LOP. The Committee also directed to seek a report from the unit on the export and import figures till date, mechanism of export when the LOP is not valid and also call for latest APR.

2.3 In compliance, unit vide letter dated 27.03.2024 has informed that they had never imported any input without payment of Customs duty till date. Further main raw material was marble block which was non excisable till 30.06.2017 and thereafter there was no exemption of GST on procurement of Marble Blocks. Likewise, they have not availed any exemption of duty on other inputs till date. Further neither they nor their supplier had claimed any benefit of deemed export of the supplies of inputs procured from domestic market till date.

2.4 The Jurisdictional Customs authorities were also requested to provide a detailed report as to whether the unit had exported its goods despite lapse in the validity of LOP at the earliest, vide this office letter dated 18/03/2024 & 25/04/2024. In response, a letter dated 29.05.2024 was received from Assistant Commissioner Customs Division, Paanch Batti Circle, Ratanada, Jodhpur with an enclosed report received from the Jurisdictional Customs Range office vide letter F.No. CUS/EP/MISC/310/2024-Range-UDZ-CUS-Prev-Div-Jodhpur dated 13.05.2024. This letter indicates that M/s Rishabh Green Marbles Pvt. Ltd. vide reply dated nil (copy enclosed) have provided the following details regarding import and export made by them during the period 2020-21 to 2023-24

2.5 It has also been informed that no imports of capital goods/inputs has been made by the unit in the above period.

2.6 In view of above, the deliberated upon and noted that the unit had made exports despite lapse of validity of LOP and hence the Committee decided to seek a legal opinion. The specific opinion is



sought as to whether this office should adjudicate the matter to regularise the validity of LOP. Moreover, the unit may be asked to submit documentary evidence of third party exports made including the type of transaction.

**3) M/s Green Shield Protective Pvt. Ltd. for conversion of existing DTA unit into 100%EOU at floor No. 1<sup>st</sup> and 2<sup>nd</sup> (New Building) E-1007, Phase-III, Sitapura Industrial Area Sanganer Jaipur-302022.**

It was informed to the Committee that M/s Green Shield Protective Private Limited had applied for conversion of existing DTA unit into 100%EOU at floor No. 1<sup>st</sup> and 2<sup>nd</sup> (New Building) E-1007, Phase-III, Sitapura Industrial Area Sanganer Jaipur-302022. for manufacturing and export of following items:-

3.2 It was also informed to the committee that the antecedent verification report from Indore and Falta SEZ had been received and nothing adverse was reported. Further, it was observed that the proposal of the unit was sent to jurisdictional Customs Authorities vide this office letter dated 10.06.2024 and subsequent reminder e-mail dated 15.07.2024 for site inspection and feasibility report. However, the same had not been received yet. The company has projected investment of Rs. 108.64 lakhs NFE of Rs. 989.00 lakhs over the period of five years.

3.3 Mr. Mahendra Raka Accountant & Mr. Manish Bhartia authorized representative appeared before the Committee and explained the proposal. They informed that they specialise in protective clothing and work wear. Their capital investment in plant and machinery is Rs.108.64 lakhs which are indigenously procured. Their unit is already in production since 2019.

3.4 The Committee deliberated and gave an "in principle"" approval



The approval is also subject to the unit submitting a statement of Net worth in respect of all the Directors to check the veracity of financial soundness of the project. It directed the office of DC, Noida SEZ to deliberate on file based on the submissions above and provide the final approval.
