The Committee ratified the Minutes of the 7th UAC meeting (2016 Series).

1.1(16) Proposal for setting up of 100%EOU for manufacture and export of various types of Bathroom fittings by M/s Induhaibaa Private Limited.

The Unit Approval Committee (UAC) deliberated the proposal and noted that the proposal of the unit was approved "in-principle" by the Committee in its 7th meeting (2016) series) held on 14.12.2016 subject to furnishing the following details:-

- i) Registered lease deed as per 6.01 (h) of HBoP;
- ii) Background of the unit situated in China including name of the promoter, turnover etc. with documentary evidence;
- iii) Background of the unit situated in Saudi Arabia including name of the promoter, turnover etc. with documentary evidence;
- iv) Background of Shri R.S. Chauhan, General Manager of the Company:

UAC was informed that the details sought have been furnished by the unit.

After due deliberations the UAC approved the proposal subject to the condition that the business would be carried out in a transparent manner and that the unit will not engage in any activity which has not been authorized under Foreign Trade Policy.

1.2(16) Proposal for setting up of 100%EOU for manufacture and export of Mobile viewable, Camera Lenz, Mobile cover plastic of printing by M/s Prinpia Components Private Limited.

The Unit Approval Committee (UAC) deliberated the proposal and noted that one of the Director of the firm namely, Mr. Bong Sik Park is also director in another 100% EOU unit i.e. M/s Cometech Components, which has been granted LOP No. 01-08/2013-100% EOU dated 27.01.2014 for manufacture and export of Mobile Parts.

The Committee also noted that M/s Cometech Components had commenced commercial production w.e.f. 02.04.2014 and had made deemed export worth of Rs. 20.65 crore for the period 2014-15 and 2015-16. The Committee, after due deliberations, approved the proposal.
