2<sup>nd</sup> meeting (2015 Series) of Unit Approval Committee for EOU scheme (UAC) was held on 30.03.2015 under the Chairmanship of Shri Sumeet Jerath, IAS, Development Commissioner, Noida SEZ. The following members of UAC were present in the meeting:

The Chairman welcomed all participants of the UAC and thereafter agenda was taken up for discussion.

2.0(15) Confirmation of minutes of 1<sup>st</sup> meeting (2015 series) of the UAC held on 12.02.2015.

The Committee ratified the minutes of the 1<sup>st</sup> UAC meeting (2014 Series).

2.1(15) Proposal for setting up 100%EOU by M/s Ishan Textiles Mills (P) Ltd. ITM Village Khasa, G.T. Road, Amritsar, Punjab.

The Committee noted that the jurisdictional Central Excise have sought some more time to furnish site inspection report for the proposed location. In view of this, the Committee decided to defer the proposal till report is received.

2.2(15) Proposal for setting up 100%EOU by M/s Hariom TradExim Private Limited Plot No. 11, Sector Udyog Kendra, Extension-I Echotech-III, Greater Noida.

The Committee noted that the site inspection report for the proposed location of the unit is awaited from the jurisdictional Central Excise, Greater Noida. The Joint Commissioner of Central Excise also informed that they will furnish the report soon. Once the report is received, further action would be taken.

## 2.3(15) Adjudication of Show Cause Notice in respect of M/s Abhishek Exports, H-280, Udyog Vihar, Sukher, Udaipur-313004 (Raj.)

The Committee noted that due to slow down in international market, unit unable to export their goods inspite of that unit maintained the positive NFE for the last five years. Therefore, the facts mentioned above is genuine, accordingly Development Commissioner took a lenient view in the matter and decided to withdraw the show cause notice and to accede to unit's request for extension of LOP for next five years w.e.f. 01.04.2015 to 31.03.2020 under the usual terms & conditions.

2.4(15) Adjudication of Show Cause Notice in respect of M/s Galaxy Exports, Araji No. 934, Brahmno ka Guda, Vill - Partapura, Tehsil-Girva (Next to M/s Pacific Industries Ltd.), Udaipur-313001 (Raj.)

The Committee noted that due to slow down in international market, unit unable to export their goods. However, unit has maintained the positive NFE during last five years. Therefore, the facts mentioned above is genuine and Development Commissioner took a lenient view in the matter and decided to withdraw the show cause notice and to accede to unit's request for debonding under para 6.18 (e).

2.5(15) Adjudication of Show Cause Notice in respect of M/s Lodha Jewellery Exports (I) (P) Ltd. 31/3192, 4<sup>th</sup> Floor, Beadon Pura, Karol Bagh, New Delhi-110005.

The Committee noted that the unit had undertaken the activities of repair/remaking in addition to the approved items in the LOP without valid approval from the appropriate authority and for this lapse, unit was issued a show cause notice to explain the reasons in reply unit has accepted the mistake and requested for lenient view and also requested for ex-post facto approval of unauthorized activities. Accordingly, Development Commissioner adjudicated the show cause notice and imposed a penalty of Rs. 1.00 lakh (One Lakh Only) under FT D&R Act, 1992.

Development Commissioner
