- 2. The Chairman welcomed all participants of the UAC and thereafter agenda was taken up for discussion.
- 4.0(16) Confirmation of minutes of 3^{rd} meeting (2016 series) of the UAC held on 08.06.2016.

The Committee ratified the Minutes of the 3rd UAC meeting (2016 Series).

4.1(16) Proposal for sale/transfer of unutilized/surplus raw material to their Group Companies (EOUs) by M/s Roulunds Braking India (P) Ltd., Village-Livaspur, P.O. Bahalgarh, DistricT-Sonepat, Haryana.

The Unit Approval Committee (UAC) was informed that M/s Roulunds Braking India Private Limited along with their group companies were engaged in manufacture of Disc Brakes. It was further informed that other Group companies (EOUs) working under the same management are:

- 1. M/s Danblock Brakes India (P) Ltd., Sonepat
- 2. M/s Mat Brakes, Sonepat
- 3. M/s Alliance Friction, Sonepat

The Committee was also apprised that since most of the inputs are common to all their group companies, they had submitted a proposal for sourcing input centrally and interunit transfer of the same in terms of para 6.13 (d) of FTP.

The Committee deliberated upon the proposal of the unit for sourcing the inputs common for all its group companies centrally and approved inter-unit transfer of goods in terms of para 6.13 (d) in respect of inputs which are sourced centrally subject to the condition that inputs so sourced are imported and then transferred to another unit. The UAC further directed that the value of the goods so transferred shall be taken as inflow for the unit transferring these goods and as outflow for the unit receiving these goods, for the purpose of calculation of NFE.
