## Minutes of 5<sup>th</sup> Meeting (2016 Series) of Unit Approval Committee for EOU Scheme held under the Chairmanship of Dr. L.B. Singhal, Development Commissioner, NSEZ, Noida on 29.09.2016 at 03.30 PM at NSEZ, Noida.

5<sup>th</sup> meeting (2016 Series) of Unit Approval Committee for EOU scheme (UAC) was held on 29.09.2016 under the Chairmanship of Dr. L.B. Singhal, Development Commissioner, Noida SEZ.

The following members of the Unit Approval Committee were present in the meeting:

Besides during the meeting of UAC, Smt. Mala Rangarajan, DDC, Shri Ram Baboo, ADC & Shri Subodh Kumar Jha, ADC were also present to assist the UAC.

- 2. The Chairman welcomed all participants of the UAC and thereafter agenda was taken up for discussion.
- 5.0(16) Confirmation of minutes of 4<sup>th</sup> meeting (2016 series) of the UAC held on 13.07.2016.

  The Committee ratified the minutes of the 4<sup>th</sup> UAC meeting (2016 Series).
- 5.1(16) Proposal for conversion of existing DTA unit into 100%EOU by M/s Marvellous Exports, Araji No. 887/727, Bhilon Ka Bedla, Amberi, Tehsil Badgaon, Udaipur (Rajasthan) for manufacture and export of Granite Slabs/Tiles, Marble Slabs/Tiles, Natural Stones Slabs/tiles and Dressed Marble/Granite/Natural Stone Blocks.

The Unit Approval Committee (UAC) noted that cumulative exports and NFE projections for five years are Rs. 6885.00 lakh and Rs. 4444.25 lakh respectively.

Jurisdictional Central Excise Officer informed the UAC that the unit is mainly engaged in manufacture/export of granite slabs/tiles. The manufacture of marble slabs/tiles and sandstone tiles/slabs in comparatively less. UAC was also informed that the unit has installed one gangsaw machine, two multi-cutters, two single cutters and one line polishing machine for carrying out manufacturing activity.

Representative of the unit, Shri Sanjay Kumar Jhanwar informed the Committee that their exports for 2015-16 and 2016-17 (upto June) were Rs. 39.03 lakh and Rs.

176.88 lakh respectively. He mentioned that the unit will be doing mainly granite export and export of marble and natural stone will be around 35% only.

The Committee deliberated upon the proposal and decided to approve the proposal subject to the following conditions:-

- i) The unit shall maintain positive NFE for each item i.e. marble, granite and natural stone separately and NFE for all the three items will be calculated separately.
- ii) Central Excise would carry out periodical inspection of the unit and ensure the quantity of input imported is commensurate with the quantity used for production.
- iii) No DTA sale of marble would be allowed.
- 5.2(16) Proposal for addition of accessories of finished products in LOP for manufacture and export as well as for DTA sale by M/s Groz Engineering Tools (P) Ltd.

The Unit Approval Committee was informed that M/s Groz Engineering Tools (P) Ltd., which is engaged in manufacture and export of lubrication tools, accessories pumps, hose reels etc. was allowed by UAC in its meeting held on 08.06.2016 to include Penetrating Rust Solvent and release agent, Rust removal Gel and Rust preventive lubricant spray in their LOP through broad-banding. However, UAC had imposed restriction on DTA sale of broad-banded items as UAC felt that proposed activity for manufacture and export of broad banded items was covered under para 6.16 of FTP. The UAC was further informed that the unit has sought re-consideration of earlier decision of imposing restriction on DTA sale.

The Committee was apprised by the unit representative that they would be carrying out substantial manufacturing activity to produce the new items. The representative explained through flow chart various manufacturing activity that would be undertaken by the unit for manufacture of new items. Further, they informed they propose to install new machinery to carry out these activities.

The Committee after due deliberation decided to remove the restriction on DTA sale of the broad banded items
