Minutes of 6th Meeting (2016 Series) of Unit Approval Committee for EOU Scheme held under the Chairmanship of Dr. L.B. Singhal, Development Commissioner, NSEZ, Noida on 02.11.2016 at 01.00 PM at NSEZ, Noida.

6th meeting (2016 Series) of Unit Approval Committee for EOU scheme (UAC) was held on 02.11.2016 under the Chairmanship of Dr. L.B. Singhal, Development Commissioner, Noida SEZ.

The following members of the Unit Approval Committee were present in the meeting:

Besides during the meeting of UAC, Smt. Mala Rangarajan, DDC, Shri Ram Baboo, ADC were also present to assist the UAC.

2. The Chairman welcomed all participants of the UAC and thereafter agenda was taken up for discussion.

6.0(16) Confirmation of minutes of 5th meeting (2016 series) of the UAC held on 29.09.2016.

The Committee ratified the Minutes of the 5th UAC meeting (2016 Series).

6.1(16) Proposal for conversion of existing DTA unit into 100% EOU for manufacture and export of Polished Granite Slabs and Polished Granite Slabs by M/s Global Stones Private Limited.

The Unit Approval Committee (UAC) noted that export performance of the DTA unit, which is proposed to be converted to EOU, were Rs. 33.23 crore, Rs. 37.58 crore and Rs. 39.50 crore for the year 2013-14, 2014-15 and 2015-16 respectively. The Committee noted that the unit has been issued EPCG Licenses. Shri Mayank Shah, Director of the unit informed that Export Obligation (EO) under EPCG have already been fulfilled. The Committee directed him to furnish statement to this effect duly certified by the Chartered Accountant. The representative of the unit also stated that their proposal is for manufacture and export of marble slabs/tiles also but he will not import marble slabs and also no marble slab would be sold in DTA. He further submitted 100% export of items proposed to be manufactured will be done. The unit was asked to file revised application.

The Committee deliberated the proposal and approved the proposal subject to the following conditions:-


1. Unit would file revised application indicating details of items proposed to be manufactured.
2. No DTA sale of "marble" would be allowed.

6.2(16) Proposal for setting up of 100% EOU for manufacture and export of Native Silk fabric by M/s Hanol Textiles (P) Ltd.

The Committee was informed that the unit had earlier submitted the proposal for grant of LOA for setting up unit under SEZ Scheme for manufacture and export of the above items Approval Committee in its meeting held on 08.07.2016 approved the proposal subject to removal of deficiencies. Accordingly, ^{for removal of deficiencies} LOA dated 26.08.2016 was issued. Approval Committee was further informed that earlier the unit was willing to set up unit at the ground floor SDFs in NSEZ. But now due to operational difficulties particularly on account of likely noise due to deployment of proposed machinery, they have decided to set up 100%EOU at Greater Noida on a rented space. They have executed rent agreement for 5 years. Shri Chintan Raghuvanshy, Assistant Commissioner, Central Excise informed to the Approval Committee that the site has been inspected by the jurisdictional Central Excise, which has given its 'NOC' in favour of setting up of EOU unit.

Shri Yangjin Jeong appeared before the Approval Committee and explained the project.

The Committee deliberated upon the proposal and approved the proposal of the unit subject to removal of deficiencies already pointed out to them vide letter dated 27.10.2016.
