Minutes of the Approval Committee meeting in respect of SEZs located in the State of Haryana, held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner, NSEZ at 10:30 AM on 04/09/2025.

The following members of Approval Committee were present during the meeting:-

Besides, during the meeting i). Shri Gya Prasad, DDC, ii). Shri Rajesh Kumar Srivastava, Specified Officer, iii). Shri Prakash Chand Upadhyay, ADC & iv) Shri Sunil Gulyani, Stenographer /Dealing hand, were also present to assist the Approval Committee. It was informed that the quorum was available and the meeting could proceed.

At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken unanimously:-

1. Ratification of the Minutes of the Approval Committee meeting held on 06.08.2025:-

As no reference in respect of the decisions of the Approval Committee held on 06.08.2025 was received from any of the members of the Approval Committee or trade, the Minutes of the Meeting held on 06.08.2025 were unanimously ratified.

Item No. 2: Merger of LOAs:-

2.1: M/s. M/s. Tata Consultancy Services Limited (Unit-I, II, III & IV).

2.1.1. Shri Devendra Sharma, AGM of M/s. Tata Consultancy Services joined the meeting through video conferencing and explained the proposal.

2.1.2. The Approval Committee discussed the proposal in detail and after due deliberations, approved the proposal of M/s. Tata Consultancy Services Limited for merger of LOA No. STPI/SEZ/Unit/03/20/185 dated 27.05.2008 (Unit-II), LOA No. STPI/SEZ/Unit/03/60/753 dated 08.12.2010 (Unit-III) & LOA No. 10/50/2014-SEZ/10332 dated 29.09.2014 (Unit-IV) into LOA No. STPI/SEZ/Unit/03/13 dated 15.01.2008 of Unit-I of its units located in the DLF Cyber City Developers Limited IT/ITES SEZ at Sector-24 & 25A, DLF Phase-III, Gurugram (Haryana), in terms of proviso 4 to Rule 19(2) of SEZ Rules, 2006. After merger, block period for calculation of Net Foreign Exchange shall be from the date of commencement of production of the Unit-I i.e. 02.05.2008 which commenced first and the Income Tax exemption shall be considered from the date of start of operation of the Unit-I i.e. 02.05.2008. The current block period of merged LOA shall be from 02.05.2023 to 01.05.2028. Further, this approval is subject to submission of the following documents:-

- i. Unit is required to submit consolidated revised export, forex outgo & NFE projections as



well as combined projections for imported & indigenous capital goods & input services for current block period from 02.05.2023 to 01.05.2028. Authorised operations to be retained in LOA No. STPI/SEZ/Unit/03/13 dated 15.01.2008 of Unit-I after merger in other three LOAs, also required to be given.

- ii. Employment projections for merger unit also required to be given.
- iii. The unit needs to submit 'NOC' from the SEZ Developer for merger of LOAs.
- iv. The unit has shown pending foreign exchange realization in APRs of Unit-I, Unit-II & Unit-III. Therefore, the unit needs to submit the permission for extension of time from RBI/AD Bank for realization of such pending remittance along with present status of such pending remittance duly certified by CA, required to be submitted.
- v. Unit needs to submit copy of board resolution for deciding merger of all SEZ units into LOAs LOA No. STPI/SEZ/Unit/03/13 dated 15.01.2008 of Unit-I.

3. Inclusion of additional authorized operation in LOA / Change in projections:

3.1: M/s. Acccertify India Solutions Private Limited

3.1.1. Ms. Madhuri & Shri Sahil Babbar, Authorised Representatives of M/s. Acccertify India Solutions Private Limited joined the meeting through video conferencing and explained the proposal. Ms. Madhuri informed to the Approval Committee that there would be changes in the export / NFE projections of the unit due to inclusion of proposed additional authorised operation in LOA. They will submit the same within a week.

3.1.2. The Approval Committee discussed the proposal in detail and after due deliberations, approved the proposal of M/s. 5.1. M/s. Amdocs Development Centre India LLP

5.1.1. Ms. Deepika Daryani, Regional Tax Manager of M/s. Amdocs Development Centre India LLP joined the meeting through video conferencing and explained the proposal.

5.1.2. The Approval Committee observed that though the unit has achieved positive NFE during all previous block periods. However, various observations have been found in APRs for FY 2008-09 to 2025-26 by CA, NSEZ.

5.1.3. The Approval Committee discussed the proposal in detail and after due deliberations, approved the proposal of M/s. Amdocs Development Centre India LLP for transfer of fit-outs including furniture & fixtures except IT and fire hazardous goods installed in the premises of the unit i.e. 9th & 10th floor, Tower-A, Building No.2, 9th floor, Tower-B, Building No.2 & 1st floor, Tower-B, Building No.3, Gurgaon Infospace Limited IT/ITES SEZ, Village Dundahera, Sector-21, Gurugram (Haryana), on 'as is where is' basis to SEZ Co-Developer, M/s. Candor Kolkata One Hi-Tech Structures Private Limited, upon exit from SEZ Scheme, on payment of applicable tax / duties. The Approval Committee also monitored the performance of the unit in terms of Rule 54 of SEZ rules, 2006 and in-principal took note of the positive NFE earned by the unit. The Committee empowered the O/o. DC, NSEZ to take final decision on monitoring of performance after receipt of rectified APRs, as per observations of CA firm along with details of DTA sales & pending foreign exchange during FY 2013-14 to 2017-18, from the unit.
