Minutes of the Approval Committee meeting in respect of SEZs located in the State of Haryana, held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner, NSEZ at 10:30 AM on 06/06/2024.

The following members of Approval Committee were present during the meeting:-

- 1. Shri Y.K. Kanwaria, Assistant Commissioner (Customs), Gurugram.
- 2. Shri Ashok Kumar, IEO, Department of Industries, Gurugram.
- 3. Shri Jagdish Chander, Assistant DGFT, O/o DGFT, CLA, New Delhi.
- Besides, during the meeting i). Shri Gya Prasad, Deputy Development Commissioner, ii). Shri Surender Singh Yadav, Specified Officer, iii). Shri Prakash Chand Upadhyay, Assistant Development Commissioner & iv) Shri Sunil Gulyani, Stenographer /Dealing hand, were also present to assist the Approval Committee. It was informed that the quorum was available and the meeting could proceed.
- At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken unanimously:-
 - 1. Ratification of the Minutes of the Approval Committee meeting held on 02.05.2024:-

As no reference in respect of the decisions of the Approval Committee held on 02.05.2024 was received from any of the members of the Approval Committee or trade, the Minutes of the Meeting held on 02.05.2024 were ratified.

Item No. 2: Proposal for setting up of new unit:-

2.1: M/s. Accertify (India) Solutions Private Limited.

- 2.1.1. M/s. Accertify (India) Solutions Private Limited had submitted proposal for setting up a unit over a built-up area of 4644.31 Square meter (49991 Square feet) in the ITPG Developers Private Limited, Electronics Hardware, IT/ITES SEZ at Village Bahrampur, Gurugram (Haryana). This was to undertake service activities namely 'Information Technology Enabled Services in the nature of support services (CPC 879), Information Technology Services (CPC 842). The applicant had proposed export of Rs.45995.79 lakhs and a cumulative NFE of Rs.39121.05 lakhs over a period of five years. The projected investment of Rs.4574.96 lakhs was towards imported capital goods and Rs.1143.74 lakhs towards indigenous capital goods. The applicant had also proposed imported input services of Rs.2299.79 lakhs and indigenous input services of Rs.8746.64 lakhs. The applicant had submitted copy of provisional offer of space dated 17.05.2024 issued by SEZ Co-Developer for allotment of the proposed space.
- 2.1.2. It was informed to the Committee that following shortcomings have been observed in the application in the first instance, which has been communicated to

the applicant:-

- i. Copy of Import-Export Code (IEC) not submitted.
- ii. Complete profile of directors namely Mr. Ankur Vohra and Mr. Andrew Paul Bronstein required to be submitted.
- iii. Reply in respect of Para XII (ii) & (iv) of Form-F have to be given in 'Yes' or 'No'.
- iv. Copy of Article of Association of the applicant company required to be submitted.
- v. In provisional offer of space dated 17.05.2024, the name of ITPG Developers Phase-I Private Limited had been mentioned as 'Developer', whereas ITPG Developers Phase-I Private Limited is 'Co-developer' of the said SEZ.
- vi. Total value of proposed imported capital goods & imported input services comes to Rs.6874.75 lakhs, whereas total foreign exchange outgo has been given as Rs.6874.74 lakhs. This needs to be rechecked & corrected.
- vii. Total proposed investment on Plant & Machinery is Rs.57.19 Crore. Whereas Nature of Industry Undertaking at Para III of Form-F has been mentioned as 'Small Scale', which is not as per the criteria for classification of industries given in Notification dated 01.06.2020 of Ministry of Micro, Small and Medium Enterprises, Govt. of India.
- viii. Form-F has not been signed by the applicant & official seal/stamp has not been affixed at the end of Form-F at proper place.
- ix. CPC of proposed service activities required to be given as per CPC Provisional.
- x. CA Certified shareholding pattern of the applicant company required to be submitted.
- 2.1.3. Shri Ayan Patel, Manager, Shri Dave Arlt, Manager & Shri Ashish Jhagrawat, Consultant of M/s. Accertify (India) Solutions Private Limited joined the meeting through video conferencing and explained the proposal. Besides, Shri Ankur Vohra, Director & Shri Rohit Singh, Consultant of M/s. Accertify (India) Solutions Private Limited appeared before the Approval Committee. The representatives informed that they will obtain Import-Export Code after receipt of Letter of Approval for SEZ unit as the applicant company doesn't have any DTA unit. Further, the representatives requested to accept the CS certified shareholding pattern submitted by them in place of CA certified. The Committee accepted the same.
- 2.1.4. The Approval Committee discussed the proposal in detail and after due deliberations, <u>approved</u> the proposal of M/s. Acertify (India) Solutions Private Limited for setting up of new unit, subject to submission of documents as pointed out at Para 2.1.2 above except (i) & (x).

3.1. M/s. Amdocs Development Center India LLP

- 3.1.1. Ms. Deepika Daryani, Regional Tax Manager of M/s. Amdocs Development Center India LLP joined the meeting through video conferencing and explained the proposal.
- 3.1.2. The Approval Committee discussed the proposal in detail and after due deliberations approved the proposal of M/s. Amdocs Development Center India LLP for expansion of area by addition of '36693 Square feet. This addition would be in the 9th floor, Tower-A, Building No.6' in Gurgaon Infospace Ltd. IT/ITES SEZ at Village Dundahera, Sector-21, Gurugram (Haryana).

Item No.9: unit: Request for adjudication on DTA Procurement by SEZ

9.1. M/s. Restreator Comparador Correduria de Seguros S.L.

- 9.1.1. Shri Tajinder Singh Country Head, Shri Vijay Goel & Shri Ajay Goel, authorized representatives of M/s. Restreator Comparador Correduria de Seguros S.L. joined the meeting through video conferencing and explained the matter. The representatives of the unit informed that the goods related to Issue-1 & Issue-2 were procured from DTA during the period July' 2017 to December' 2018, when the SEZ unit was located in Gurgaon Infospace Limited, SEZ, Gurugram (Haryana). The Issue-3 related to services procured by the unit from DTA during the period July' 2017 to March' 2022. The representatives referred to NSEZ Customs Public Notices dated 02/2018 & 06/2019 and requested to allow either by manual submission and to endorsement of the relevant DTA invoices or the online SEZ portal be unblocked to enable the SEZ unit to upload and get endorsed from A.O. The Committee was of the view that the matter is apparently related to Customs Division of SEZ.
- 9.1.2. The Approval Committee discussed the proposal in detail and after due deliberations <u>deferred</u> the matter and directed the representatives of the unit to submit copies of Public Notice dated 02/2018, 06/2019 and other supporting documents which have been referred by them during the discussions. Further, the Committee directed the Specified Officer to explore the supporting document / provisions to resolve the issue. The Committee also directed to obtain a legal opinion on the matter.
