Minutes of the meeting of the Unit Approval Committee (UAC) of private SEZs in the State of Haryana held under the chairmanship of Dr. L.B. Singhal, Development Commissioner (DC), NSEZ at 02.15 PM on 04/09/2015 in the Conference Hall of NSEZ.

- 2. Besides, during the meeting i) Shri Rakesh Kumar, DDC, NSEZ, ii) Ms. Jyoti Wadhawan, Specified Officer, iii) Shri H.S. Rawat, Specified Officer & iv) Shri Prakash Chand Upadhyay (ADC) were also present to assist the UAC.
- 3. At the outset, DC, NSEZ welcomed the participants. After brief introduction, each items included in the agenda were taken up for deliberation one by one. After detailed deliberations as well as interaction with the applicants / representatives of the units, the following decisions were taken:-
- (i) Ratification of Minutes of last meeting of the Approval Committee:-

DDC, NSEZ informed the Committee that no reference against the decisions of the UAC held on 07/08/2015 has been received from any of the members or the Trade and therefore, Minutes of the meeting held on 07/08/2015 may be ratified. Accordingly, the said Minutes of the meeting were ratified.

- (ii) Item wise decisions on proposals included in agenda:
- 1. Ratification of the approval for change of name/ constitution of the company from 'M/s. NTT DATA Global Delivery Services Ltd.' (Public Limited Company) to 'M/s. NTT DATA Global Delivery Services Pvt. Ltd.' (Private Limited Company).

/ DDC, NSEZ informed the Committee that M/s. NTT DATA Global Delivery Services Pvt. Ltd. Unit-I & Unit-II in the IT/ITES SEZ of M/s. Unitech Realty Projects Ltd., Village Tikri,

Gurgaon (Haryana) had applied for change of name/ constitution of the company from 'M/s. NTT DATA Global Delivery Services Ltd.' (Public Limited Company) to 'M/s. NTT DATA Global Delivery Services Pvt. Ltd.' (Private Limited Company) and DC approved the proposed change of name/ constitution of the company subject to ratification by UAC, which has been conveyed to both the units vide letter dated 20.08.2015.

Unit Approval Committee ratified the approval of change of name/ constitution of the company as approved by DC and conveyed to the unit vide letter dated 20.08.2015.

Gurgaon Infospace Ltd. at Dundahera, Gurgaon (Haryana). He further informed that the unit is presently operating over an area of 526445 Sqft. at 2nd floor, Tower A, Building no.2, 8th floor, Tower-B, Building No.1, 11th floor, Tower-B, Building No.1, Ground to 5th floor, Tower-A, Building No. 6, 8th & 9th floor, Tower-A, Building No. 6, Ground & 1st floor, Tower-B, Building No.6, Ground to 2nd floor, Tower A, Building No.7 and has requested for addition of 50071 Sqft. at 3rd floor, Tower-A, Building No. 7. DC, NSEZ intimating that there is no 'Tower-A' in Building No. 7. He also produced a copy of APR for the year 2014-15 submitted vide letter dated 03.09.2015.

After due deliberations, UAC approved the expansion of area as well as revised projections of the unit subject to execution of Bond-Cum-LUT.

3. Proposal of M/s. Ericsson India Global Services Pvt. Ltd. for expansion of area & revision in projection of the unit in IT/ITES SEZ of M/s. ASF Insignia SEZ Pvt. Ltd. at Vill. GwalPahari, Tehsil Sohna, Distt. Gurgaon (Haryana).

DDC, NSEZ informed the UAC that M/s. Ericsson India Global Services Pvt. Ltd. has applied for expansion of area & revised projections in respect of its unit located in IT/ITES SEZ of M/s. ASF Insignia SEZ Pvt. Ltd. Ltd. at Village Gwal Pahari, Gurgaon (Haryana). He further informed that the unit is presently operating over an area of 619993 Sqft. at Ground to 14th Floor, Block – A, Kings Canyon Building (B2), Ground to 17th Floor, Block-A, Grand Canyon Building (B3) & Ground to 3rd floor Block-B, Kings Canyon Building (B2) and has requested for addition of 8239 sqft. at 1st floor, Block-B, Kings Canyon Building (B2). He further informed the UAC that the developer has not indicated appropriate Unit of Measurement (UOM) in respect of 'Door frame metal detector' & 'Hand held metal detector' proposed under 'Access Control & Monitoring Systems' which has been communicated to the developer.

Shri A.K. Singh, Sr. Manager appeared before UAC on behalf of the developer and explained the requirement of proposed material. He informed that they have submitted revised list for 'Access Control & Monitoring Systems' indicating Unit of Measurement (UOM) in respect of 'Door frame metal detector' & 'Hand held metal detector' in 'Number'.

After due deliberations, UAC approved the list of material.

5. M/s. G.M.T. Infotech Pvt. Ltd. a unit in IT/ITES SEZ of M/s. DLF Cyber City Developers Ltd., Gurgaon – Matter for Non-filing of Softex form and renewal of LOA for next five years.

DDC, NSEZ informed the UAC that M/s. G.M.T. Infotech Pvt. Ltd. a unit in the IT/ITES SEZ of M/s. DLF Cyber City Developers Ltd., Gurgaon had applied for renewal of LOA for further period of five years. The unit was requested to submit copy of intimation letter of DCP along with copy of first invoice submitted by them to this office to ensure validity of LOA. It was also observed that the unit had not filed any Softex form during its first five

years of operation. In this regard, the unit had informed that they are unable to trace the DCP intimation letter submitted by them to O/o. DC, SEZ. Besides, copy of first invoice dated 24.05.2010 had been submitted by the unit accordingly LOA appears to be valid upto 23.05.2015. Besides, as per APRs the unit has achieved positive NFE. As regard non-filing the softex form, the unit has informed that they had not submitted Softex form till August 2013 as filing of Softex form for the Invoice below USD 25000 was not mandatory and its all invoices were within this limit. Further, due to change in account team they had not submitted Softex Form from September, 2013 onwards.

Shri Naresh, Director appeared before the UAC to explain the case. He apologized for non-submission of Softex form and assured that such lapse shall not occur in future.

DC, NSEZ informed that as per section 11(4) of the Foreign Trade (Development & Regulation) Act, as amended, there is a penalty provision to settle the cases where a person admits any contravention. In the light of facts & circumstances of the case, DC, NSEZ on the recommendation of UAC imposed a penalty of Rs. 10000/- on the unit, for which promoters of the unit gave their consent.

After due deliberations, UAC approved the proposal of M/s. GMT Infotech Pvt. Ltd. for renewal of LOA upto 23.05.2020 subject to payment of penalty of Rs.10000/- under Section 11(3) of FT(D&R) Act.
