Minutes of the meeting of Approval Committee in respect of SEZs located in the State of Haryana held on 09.04.2013 at Conference Hall, NSEZ, Noida.

The meeting was chaired by Shri Jayant Misra, Development Commissioner. The following officers / representatives also attended the meeting:-

M/s. Gurgaon Infospace Ltd., IT/ITES SEZ at Gurgaon.

(i). Review of the performance of last five years by M/s. Evalueserve SEZ (Gurgaon) Pvt. Ltd.

The performance of M/s. Evalueserve SEZ (Gurgaon) Pvt. Ltd. during last five years was placed before the UAC in terms of Rule 54 of SEZ Rules, 2006. It was brought to the notice of UAC that the unit has performed FOB value of export for Rs. 29390.26 lacs with NFE achievement of Rs. 29122.78 lacs during the five years. Therefore, DC, NSEZ has extended the validity period of LOA for further five years in terms of Rule 19(6) of SEZ Rules, 2006. UAC accordingly taken note of the same.

(ii). Issue of Occupancy Certificate in respect of Block No. 8 (Part) of SEZ.

The examination report submitted by M/s. Nexus Creations for issue of occupancy certificate in respect of Block No. 8(part) in the processing area of SEZ was placed before the UAC. Sr. Town Planner, Haryana was of the view that examination report of architect does not cover all the aspects required for issuance of occupancy certificate. Accordingly, UAC deferred the proposal with the advice to STP to provide a check-sheet being used by them for scrutiny of the proposals for issuance of occupancy certificate.

M/s. ASF Insignia SEZ Pvt. Ltd., IT/ITES SEZ at Vill-Gwal Pahari, Gurgaon.

Proposal of M/s. ASF Insignia SEZ Pvt. Ltd., developer for approval of list of goods.

After deliberations, UAC approved the list of goods required by the developer, M/s. ASF Insignia SEZ Pvt. Ltd., for the period of six months, to carry on following authorized operations in its IT/ITES SEZ at Village- Gwal Pahari, Gurgaon (Haryana):-

Proposal of the developer to allot built up space to M/s. Indian Entertainers Pvt. Ltd. to operate 'Executive Dining and F&B Outlet (Restaurant)' in the processing area of SEZ.

After due deliberations, UAC approved the proposal of the developer to allot built-up space approx 2950 sqft at Ground Floor, Block B, Building No. B2 in the processing area of SEZ on lease basis to M/s. Indian Entertainers Pvt. Ltd. to operate a restaurant, subject to condition that no tax / duty benefits shall be available to M/s. Indian Entertainers Pvt. Ltd. for such activity. M/s. Indian Entertainers Pvt. Ltd. shall not serve Cigarette & Alcoholic beverages without appropriate clearances and permissions.

(iii). Proposal of the developer to allot built up space to M/s. Bharti Airtel Ltd. to provide Communication Services in the processing area of SEZ.

After due deliberations, UAC approved the proposal of the developer to allot built-up space approx 100 sqft in Basement 1, Block B, Building No. B2 in the processing area of SEZ on lease basis to M/s. Bharti Airtel Ltd. to provide 'Communication Services' subject to condition that no tax / duty benefits shall be available to M/s. Bharti Airtel Ltd. for such activity.

(iv). Proposal of the developer for amendment / modification in the value of approved list of material.

After due deliberations, UAC approved the proposal of the developer for following amendments/medication in the value of duty free procurement of goods granted to carry on authorized operation in SEZ:-

(v). Proposal of the developer for for amendment in the approval granted to allow use of Hume pipe by M/s. Vodafone South Ltd. for laying Optical Fiber Cable in the processing area of SEZ.

After due deliberations, UAC approved the proposal of the developer for amendment in the approval granted by UAC to allow using Hume pipe by M/s. Vodafone South Ltd. for laying Optical Fiber Cable at Block-C instead of Block-B, Building No. B2 in the processing area of SEZ.

The proposal of M/s. Geiper Consulting Pvt. Ltd. for setting up of unit over an area of 557.784 sqmt. in the IT/ITES SEZ of M/s. DLF Cyber City Developers Ltd. at Gurgaon was placed before the UAC. The unit shall be engaged in authorised operation viz. 'IT/ITES namely Knowledge process outsourcing (KPO)'. The project envisages investment of Rs. 500 lacs. Projected FOB value of exports has been shown as Rs.11123.44 Lacs with NFE earnings of Rs.10500.15 lacs over a period of five years. The representative of the unit informed that there will be fresh investment and they shall be doing a fresh business. After due deliberations, UAC approved the project.

Proposals of M/s. Cvent India Pvt. Ltd. for setting up of unit (Unit-I) in IT/ITES SEZ of M/s. DLF Cyber City Developers Ltd. at Gurgaon.

The proposal of M/s. Cvent India Pvt. Ltd. for setting up of unit (Unit-I) over a built-up area of approx. 25597 sqft in the IT/ITES SEZ of M/s. DLF Cyber City Developers Ltd. at Gurgaon was placed before the UAC. It was brought to the notice of UAC that the applicant has proposed to consolidate its existing business operations under this project without availing Income Tax exemption complying the provisions of Instruction No. 70. Jt. Commissioner, Income Tax requested UAC that they need time to examine the proposal. Accordingly, UAC deferred the proposal.

(iii) Proposals of M/s. Cvent India Pvt. Ltd. for setting up of unit (Unit-II) in IT/ITES SEZ of M/s. DLF Cyber City Developers Ltd. at Gurgaon.

The proposal of M/s. Cvent India Pvt. Ltd._for setting up of unit (Unit-II) over a built-up area of approx. 40103 sqft in the IT/ITES SEZ of M/s. DLF Cyber City Developers Ltd. at Gurgaon was placed before the UAC. The unit shall be engaged in authorized operation viz 'IT/IT Enabled Services namely Back Office Operations, Data Processing and Support Centre'. The representative of the unit informed that there will be fresh investment and they shall be doing a fresh business. The project envisages investment of Rs. 1462 Lacs. Projected FOB value of exports has been shown as Rs. 41011 Lacs with NFE earnings of Rs. 39168 Lacs over a period of five years. After due deliberations, UAC approved the project.

2. M/s. Gurgaon Infospace Ltd., IT/ITES SEZ, Gurgaon.

(i). Proposal of the developer to allot built-up space on lease basis to M/s. Unitech Hospitality Ltd. to setup & operate a food court in the processing area of SEZ.

After due deliberations, UAC approved the proposal of the developer to allot built-up space of approx. 2440.80 sqft area at Unit No. 14 & 15, Ground floor, Amenity Block in the processing area of IT/ITES SEZ at Village-Dundahera, Gurgaon on lease basis to M/s. Unitech Hospitality Ltd. to setup & operate a 'Food court', subject to condition that space shall be allotted within the constructed area for Aminity Block and no tax / duty benefits shall be available to M/s. Unitech Hospitality Ltd. for such activity.

(ii). Proposal of M/s. Ernst & Young Pvt. Ltd. for change of name and entrepreneurship of the company in the name of 'Ernst & Young LLP'.

The proposal of M/s. Ernst & Young Pvt. Ltd. for change of name & entrepreneurship of the company in the name of 'Ernst & Young LLP' was placed before the UAC pending following documents from the unit: -

- 2. Copy of PAN & IEC in the name of M/s. Ernst & Young LLP.

UAC felt that the proposal is premature. Accordingly, defer the proposal with the direction to place in next UAC meeting on receipt of aforesaid documents.
