Minutes of the meeting of Approval Committee in respect of SEZs located in the State of Haryana held on 30.07.2013 at Conference Hall, NSEZ, Noida.

1. UAC ratified the minutes of meeting held on 28.05.2013.

2. **M/s. DLF Cyber City Developers Ltd., IT/ITES SEZ, Gurgaon.**

(i) Proposal of M/s. DLF Utilities Ltd., Co-developer for approval of list of materials.

After due deliberations, UAC approved the list of goods for a value of Rs.5.25 lacs required by the co-developer, M/s. DLF Utilities Ltd., for a period of six months, to carry on approved authorized operation namely 'Fire protection system with sprinklers, fire and smoke detectors' in the IT/ITES SEZ of M/s. DLF Cyber City Developers Ltd. at Sector-24 & 25A, DLF Phase-III, Gurgaon.

(ii) Proposal of the developer, M/s. DLF Cyber City Developers Ltd. for approval of Job-work.

The proposal of the developer for approval to send 40 Nos. Aluminium Composite Panel (210 Kg) in DTA to M/s. Star Alubuild Pvt. Ltd., Gurgaon (Haryana) for job-work i.e. 'Cutting & Blending' was placed before UAC. After due deliberations, UAC approved the proposal for job-work, subject to the condition that the quantity of wastage/scrap, if any, generated during the process of job work / sub-contracting shall be brought back in the zone for further disposal and no goods shall be removed from SEZ to DTA except with the permission of the Specified Officer.

(iii) Half Yearly report in From-E for the period ending March, 2013 submitted by the developer.

UAC observed that the half yearly report submitted by the developer is not in prescribed format. UAC directed the developer to submit half yearly report in prescribed format duly verified by the Specified Officer.

(iv) Half Yearly report in From-E for the period ending March, 2013 submitted by the co-developer, M/s. DLF Utilities Ltd.

UAC observed that the half yearly report submitted by the co-developer is not in prescribed format. UAC directed the developer to submit half yearly report in prescribed format duly verified by the Specified Officer.

(v) Half Yearly report in From-E for the period ending March, 2013 submitted by the co-developer, M/s. DLF Assets Pvt. Ltd.

UAC observed that the half yearly report submitted by the co-developer is not in prescribed format. UAC directed the developer to submit half yearly report in prescribed format duly verified by the Specified Officer.

(vi) Review of the performance of last five years by M/s. BT e-Serv (India) Pvt. Ltd.

The performance of M/s. BT e-Serv (India) Pvt. Ltd. during last five years (2008-2013) was placed before the UAC in terms of Rule 54 of SEZ Rules, 2006. It was brought to the notice of UAC that the unit has performed FOB value of export for Rs. 22395.56 lacs with NFE achievement of Rs. 22207.14 lacs during the five years. Therefore, DC, NSEZ has extended the validity period of LOA for further five years in terms of Rule 19(6) of SEZ Rules, 2006. However, the unit has shown pending foreign exchange realization for Rs.28.63 Crores. After deliberations, UAC deferred the issue with direction to the representative of the unit to submit month-wise bifurcation of pending foreign exchange realizations beyond six months alongwith audited APR for the year 2012-2013.

(vii) Proposal of M/s. Macquarie Global Services Pvt. Ltd. for movement of backup tapes to its 100% EOU location.

After due deliberations, UAC approved the proposal of the unit for movement of data backup tapes to its 100%EOU location at 'Level-1, DLF Building No. 9B, DLF Cyber City, Phase-III, Gurgaon (Haryana)' for the purpose of storage of backup data subject to compliance of guidelines issued by MOC vide letter no. D.12/25/2012-SEZ dated 26.02.2013.

(viii) Proposal for transfer of LOA granted to M/s. Mercer India Pvt. Ltd. in the name of M/s. Mercer Consulting (India) Pvt. Ltd. under scheme of amalgamation.

The proposal of M/s. Mercer India Pvt. Ltd. for amalgamation with M/s. Mercer Consulting (India) Pvt. Ltd. was placed before the UAC. The representative of the unit informed that Hon'ble High Court of Delhi and High Court of Punjab & Haryana at Chandigarh has approved the said amalgamation. As per the approved scheme of amalgamation all licenses, municipal and other statutory permissions, approvals including in particular approvals from Development Commissioner Special Economic Zone etc. obtained by M/s. Mercer India Pvt. Ltd. would be transferred / and or deemed to be transferred to and be vested in M/s. Mercer Consulting (India) Pvt. Ltd. so as to become properties and assets of M/s. Mercer Consulting (India) Pvt. Ltd.

After due deliberations, UAC approved the proposal for transfer of LOA No. STPI/SEZ/Unit/03/15/46 dated 25.02.2008 in the name of M/s. Mercer Consulting (India) Pvt. Ltd. Ltd. in place of M/s. Mercer India Pvt. Ltd., subject to execution of revised Bond-Cum-LUT by M/s. Mercer Consulting (India) Pvt. Ltd. and submission of amended IEC showing location of SEZ unit in branch list.

3. M/s. DLF Ltd., IT/ITES SEZ, Silokhera, Gurgaon.

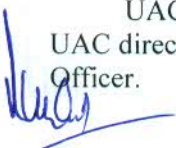

5. M/s. Gurgaon Infospace Ltd., IT/ITES SEZ at Gurgaon.

(i) Half Yearly report in From-E for the period ending March, 2013 submitted by the developer.

UAC took note of the half yearly report for the period ending 31st March, 2013 submitted by the developer in respect of IT/ITES SEZ at Dundahera, Gurgaon.

- (ii) Half Yearly report in Form-E for the period ending March, 2013 submitted by the co-developer, M/s. Unitech Developers & Projects Ltd.

UAC took note of the half yearly report for the period ending 31st March, 2013 submitted by the co-developer in respect of IT/ITES SEZ of M/s. Gurgaon Infospace Ltd. at Dundahera, Gurgaon.

- (iii) Issue of Occupation Certificate for Block No.8 (part) of IT/ITES SEZ by M/s. Gurgaon Infospace Ltd.

It was brought to the notice that proposal for issuance of completion / occupation certificate for Block No.8 (part) submitted by the developer was forwarded to M/s. Nexus Creations, Architect on panel of NSEZ, for examination. M/s. Nexus Creations has submitted their report as per check list provide by STP, Gurgaon and recommended that the proposal is technically correct as per the prescribed norms. After due deliberations, UAC decided to issue completion / occupation certificate in respect of Block No.8 (part) subject to condition that the developer shall deposit compounding charges of Rs.17,53,530/-

- (iv) Proposal of the developer to allot builtup space to M/s. Sunshine Teahouse Pvt. Ltd. to setup & operate 'Chaayos Restaurant' in the processing area of SEZ.

After due deliberations, UAC approved the proposal of M/s. Gurgaon Infospace Ltd., developer to allot built-up space of approx 873 sqft. at Unit No. 10, Aminity Block on lease basis to M/s. Sunshine Teahouse Pvt. Ltd. to setup & operate 'Chaayos Restaurant' in the processing area of IT/ITES SEZ at Village Dundahera, Gurgaon.

- (v) Proposal of M/s. Sapiient Consulting Pvt. Ltd. for merger of two SEZ units (Unit-II & Unit-III) located in IT/ITES SEZ of M/s. Gurgaon Infospace Ltd. at Gurgoan (Haryana)

It was brought to the notice of UAC that in the absence of specific provision in SEZ Act / Rules the proposal of M/s. Sapiient Consulting Pvt. Ltd. for merger of two SEZ units (Unit-II & Unit-III) having LOA No. 10/113/2011-SEZ/8785 dated 03.11.2011 & LOA No. 10/114/2011-SEZ/8786 dated 03.11.2011 was referred to BoA, however, BoA in its meeting held on 14.09.2012 has remanded back the proposal to UAC for consideration & decision. The proposal was discussed by UAC in the meeting held on 25.10.2012 and decided to examine the proposal at legal angle. Accordingly, the matter was forwarded to M/s. Rajeev Sharma & Associates, CA firm of NSEZA for legal opinion. M/s. Rajeev Sharma & Associates vide its letter dated 20.05.2013 has given its opinion that the Company may be permitted for the merger of its two SEZ units subject to the fulfillment of the procedural compliances and the submission of documents that deductions under Section 10AA of the Income Tax Act, 1961 may not be available to the unit.

The proposal was accordingly once again placed before UAC and after due deliberations, UAC decided to approve the merger of LOA No. 10/113/2011-SEZ/8785 dated 03.11.2011 granted to Unit-II with LOA No. 10/114/2011-SEZ/8786 dated 03.11.2011 granted to Unit-III subject to execution of a revised Bond-Cum-LUT & further subject to condition that the unit shall not be entitled for income tax benefits. The existing projections of both LOAs be merged and LOA granted to Unit-II be stand cancelled for all intent and purposes.

- (vi) Request of M/s. Sapiient Consulting Pvt. Ltd. (Unit-I) for movement of data backup tapes to its SEZ unit location at Noida.

After due deliberations, UAC approved the proposal of the unit for movement of data backup tapes to its another SEZ unit location at 'Ground to 3rd floor, Tower-C, Achvis Softech Pvt. Ltd. SEZ, Plot No. 7, Sector-144, Noida' for the purpose of storage of backup data subject to compliance of guidelines issued by MOC vide letter no. D.12/25/2012-SEZ dated 26.02.2013.

(vii) Request of M/s. Sapiant Consulting Pvt. Ltd. (Unit-II) for movement of data backup tapes to its SEZ unit location at Noida.

After due deliberations, UAC approved the proposal of the unit for movement of data backup tapes to its another SEZ unit location at 'Ground to 3rd floor, Tower-C, Achvis Softech Pvt. Ltd. SEZ, Plot No. 7, Sector-144, Noida' for the purpose of storage of backup data subject to compliance of guidelines issued by MOC vide letter no. D.12/25/2012-SEZ dated 26.02.2013 after completing the requisite formalities in respect of merger of Unit-II with Unit-III as approved by UAC at point no. 5(v) above.

(viii) Proposal of M/s. EUI Ltd. & M/s. Inspop.com Ltd. for sharing of common area for administrative & other non-core activities.

After due deliberations, UAC decided to allow sharing of common area at 4th floor, Building No. 6, Tower-B, IT/ITES SEZ of M/s. Gurgaon Infospace Ltd., Gurgaon by M/s. EUI Ltd. & M/s. Inspop.com Ltd. for the purpose of administrative and non-core activities only, subject to condition that no duty free goods shall be allowed neither in establishing the said common area nor in maintaining the same.

6. M/s. Unitech Realty Projects Ltd., IT/ITES SEZ at Vill-Tikri, Gurgaon.

(i) Proposal of M/s. Unitech Realty Projects Ltd., developer for approval of list of goods.

After due deliberations, UAC approved the proposal of the developer, M/s. Unitech Realty Projects Ltd. for approval of list of goods require by them for a period of six months to carry on following default authorized operations in its IT/ITES SEZ at Village Tikri, Gurgaon (Haryana):-

UAC took note of the half yearly report for the period ending 31st March, 2013 submitted by the developer in respect of IT/ITES SEZ at Village Tikri, Gurgaon.

(iii) Proposal of M/s. NTT DATA Global Delivery Services Ltd. for setting up of unit (Unit-II) in IT/ITES SEZ of M/s. Unitech Realty Projects Ltd. at Tikri, Gurgaon.

The proposal of M/s. NTT DATA Global Delivery Services Ltd. for setting up of its 2nd unit to consolidate its existing STPI business operations in the IT/ITES SEZ of M/s. Unitech Realty Projects at Tikri, Gurgaon was placed before the UAC. The unit has indicated that the existing business operations and plant & machinery would be consolidated in accordance with the provisions of Instruction No. 70 and the proposed SEZ unit will not avail Income Tax benefits as laid down under the Income Tax Regulations and provisions under SEZ Act / Rules. The unit shall be engaged in authorised operation viz. 'Computer Software Development and Information Technology Enabled Services such as Business Process Outsourcing and Call Centre Operations including transaction processing, Internet & Voice based Customer Care Services'. The project envisages investment of Rs.206 lacs. Projected FOB value of exports has been shown as Rs.15586 Lacs with NFE earnings of Rs.14437 lacs over a period of five years. After due deliberations, UAC approved the proposal as Unit-II, subject to submission of a copy of Board Resolution and requisite Affidavit-cum-Undertaking for not claiming Income Tax benefits and also that this unit shall ensure to operate as a distinct identity with separate books of accounts. The assessing officer of the Income Tax Department has the powers to take final decision regarding the Income Tax exemption.

(iv). Proposal of M/s. Genpact India for expansion of area alongwith revised projections.

The proposal of M/s. Genpact India for addition of space in its unit located in IT/ITES SEZ of M/s. Unitech Realty Projects Ltd. at Tikri, Gurgaon was placed before UAC. It was brought to the notice of UAC that the unit is currently operating from an area of 141851 sqft. at 5th, 6th, 7th, 8th & 9th Floor, Building No. 3 and requested for addition of 26971 sqft. in 10th Floor, Building No.3 of SEZ. Unit has also submitted revised projections by the virtue of proposed expansion of unit as given below:-

After due deliberations, UAC approved the expansion as well as revised projections proposed by the unit.

(iv) Proposal of M/s. Evalueserve.com Pvt. Ltd. for setting up of unit in IT/ITES SEZ of M/s. Unitech Realty Projects Ltd. at Tikri, Gurgaon.

The proposal of M/s. Evalueserve.com Pvt. Ltd. for setting up of unit over a builtup area of in IT/ITES SEZ of M/s. Unitech Realty Projects Ltd. at Village Tikri, Gurgaon (Haryana) was placed before the Approval Committee. The unit shall be engaged in authorized operation viz 'Knowledge Process Outsourcing (KPO)'. The applicant has indicated that they are they are operating unit under STPI Scheme and some of the capital goods required for this SEZ project will be shifted from the STPI unit as per provisions of Instruction No. 70. Besides, the STPI units will continue to operate in parallel with the SEZ unit. The proposed SEZ unit will not avail income tax benefits available under SEZ Act / Rules. Projected FOB value of exports has been shown as Rs. 43200 Lacs with NFE earnings of Rs.40242 lacs over a period of five years. After due deliberations, UAC approved the project.

7. M/s. Mayar Infrastructure Development Pvt. Ltd., Biotechnology SEZ at Gurgaon.

(i). Half Yearly report in From-E for the period ending March, 2013 submitted by the developer.

UAC took note of the half yearly report for the period ending 31st March, 2013 submitted by the developer in respect of Biotechnology sector specific SEZ at Village Rahka & Nimoth, Gurgaon(Haryana).

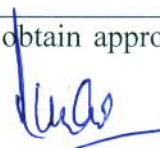
