# 1. Proposal of M/s. ZS Associates India Pvt. Ltd. for setting up a unit in IT/ITES SEZ of DLF Ltd. at Sector - 30, Silokhera, Gurgaon (Haryana).

The proposal of M/s. ZS Associates India Pvt. Ltd. for setting up of unit over an area of 132161 Sqft. on 3<sup>rd</sup> to 8<sup>th</sup> floor, Block A-4 in the IT/ITES SEZ of M/s. DLF Ltd. at Silokhera, Gurgaon was placed before the UAC. The unit shall be engaged in authorised operation viz. 'Software Development and Information Technology Enabled Services such as Product support, Analytics support, Process reengineering, Knowledge management'. The project envisages investment of Rs.3338 lacs. Projected FOB value of exports has been shown as Rs.89933 Lacs with NFE earnings of Rs.87929 lacs over a period of five years. The import of capital goods has been proposed for Rs.33.16 crores including Rs.11.87 crores to be transferred from STP Unit, Rs.8.68 crores for new procurement and Rs.12.59 crores for Laptops on lease for which payment to be made in INR. The applicant has submitted an Affidavit-Cum-Undertaking w.e.f. that unit will not avail benefits under Section 10AA of the Income Tax Act, 1961. After due deliberations, UAC approved the project.
