

JAIPUR SPECIAL ECONOMIC ZONE

Minutes of the meeting of the Approval Committee (UAC) of Jaipur SEZ held under the Chairmanship of Dr. L.B. Singhal, Development Commissioner, NSEZ on 09/12/2016 at 2.30 PM in Conference Hall, Service Centre Building, NSEZ, Noida.

The following members of UAC were present during the meeting:-

2. Besides, during the meeting i) Shri R.K. Srivastava, DDC, Noida ii) Shri H.K. Meena, ADC, iii) Shri J.C. Gupta, Specified Officer (Customs) were also present to assist the Approval Committee.

3. At the outset, DC, NSEZ welcomed the participants. After brief introduction, each items included in the agenda were taken up for deliberation one by one. After detailed deliberations amongst the members of Approval Committee as well as based on interaction with the applicants / representatives of the developers / units, the following decisions were taken:-

1. Ratification of Minutes of last meeting of the Approval Committee:-

It was informed that no reference against the decisions of the Approval Committee held on taken on 21.10.2016 was received and therefore, Minutes of the meetings of Approval Committee held on 21.10.2016 were ratified.

Item -wise decisions on proposals included in agenda are as under:

2 Proposal of M/s Naman Exports for Renewal of LOA No. 1-20-SEZ-I (J) Proj. 2174 dated 01.11.2003 for remaining period of five years.

It was informed to the Approval Committee that M/s. Naman Exports has submitted proposal for renewal of LOA dated 01.11.2003 for next five years beyond 16.05.2016. It was



informed that the unit has completed ten years of operation on 16.05.2016 and thereafter Approval Committee in its meeting held on 17.06.2016 had extended the validity period of LOA for a period upto 30.11.2016 subject to condition that further extension of LOA will be considered only after satisfactory performance of the unit during the extended period. The Approval committee was informed that the unit has not made any export during the extended validity period of LOA (i.e. from 17/05/2016 to 30/11/2016).

However, the unit vide letter dated 08.12.2016 has requested for extension of their LOA as they are in constant touch with many international buyers and are hopeful for positive results very soon. They also requested that since there is a marriage in the family they may kindly be excused from attendance before the Approval Committee. Therefore no one from the unit was present before the Approval Committee.

After due deliberations, the Approval Committee decided to renew the LOA for a period up to 31.05.2017 with the direction that further extension of LOA will be considered only after satisfactory performance of the unit failing which their LOA shall be liable to be cancelled under section 16 of the SEZ Act, 2005.
