**Minutes of the Approval Committee Meeting of Jaipur Special Economic Zone, Sitapura (Multi Product SEZ) held at 10:30AM on 09.07.2025 under the chairmanship of Shri A. Bipin Menon, Development Commissioner through Video Conferencing.**

The following members of Approval Committee were present during the meeting through video conferencing:-

i) Shri R.S. Dharwal, Senior RM (RIICO) and ii) Shri Pankaj Sharma, ADC were also present through video conferencing in the meeting to assist the Approval Committee. It was informed that the quorum was complete and the meeting could proceed.

At the outset, the Chairman welcomed the participants and then the agenda taken up for sequentially. After detailed deliberation amongst the members of the Approval Committee as well as interaction with Developer/ Representatives of the Units/ Applicants, the following decisions were unanimously taken:

**Agenda Ratification of Minutes of Approval Committee meeting No. 1 held on 27.05.2025:**

It was informed that no reference had been received against the decisions of the Approval Committee Meeting held on **27.05.2025** from any of the members of the Approval Committee/ Trade/ Unit. Therefore, the Minutes of the meetings of Approval Committee held on **27.05.2025** were unanimously ratified.

**Agenda Ratification of proposal of Change of Constitution from No. Proprietorship to Private Limited & change of name of Firm 1(b) from M/s Soni International Jewellery Manufacturing Company to M/s SONI INTERNATIONAL JEWELRY PRIVATE LIMITED**

1(b).1. 
**Agenda Proposal of M/s RIDDHIMA EXPORTS, for renewal of LOA No. 3 with Broad-banding of Authorized items (addition of new items) & Monitoring of Export Performance:**

3.1 The proposal of M/s Riddhima Exports, Plot No. H1-74(A), SEZ-II, for renewal of LOA with broad-banding of items (additional of new items) & Monitoring of Export Performance in LOA No. 2-164-SEZ-II (J) Proj./ 1343dt.12.07.2007 with broad-banding of authorized items was discussed in the meeting.

**3.2 No one appeared before the Approval Committee.**

3.3. Accordingly, after due deliberations, the Approval Committee unanimously decided to **defer** the proposal for next UAC and also decided to direct the unit to rectify the deficiencies already conveyed & deposition of pending RIICO dues to the tune of Rs. 25,470/-.

6.1. The proposal of M/s Naman Exports, Plot No. G1-32, SEZ-I, Sitapura, Jaipur for exit from SEZ Scheme and transfer of its assets & liabilities including building at Plot No. G1-32, SEZ-1, Sitapura SEZ, Jaipur to M/s. 
7.2. Shri Sanjay Gupta, Partner & Shri I.S. Poonima, Vice President of M/s Manglam Gems & Jewellery (**Transferor**) and Smt. Ritu Soni, Shri Kshitij Soni & Shri Dhruv Soni, Partners of M/s Soni International Jewelry Co. (**Transferee**) appeared before the Approval Committee through video conferencing on behalf of the unit and explained the proposal.

7.3 After due deliberations, the Approval Committee unanimously approved following:-

1. The Committee approved Exit & transfer of assets & liabilities of M/s Manglam Gems & Jewellery (**Transferor**) including building at Plot No. F-89, SEZ-I1, Sitapura Jaipur to M/s. Soni International Jewelry Co (**Transferee**), Plot No. E-14 & E-1(A), SEZ-II, Sitapura, Jaipur under Rule 74A of SEZ Rules.
2. The Committee also approved extension of LOA of M/s Manglam Gems & Jewellery for a further period of six months i.e. **upto 10.02.2026** for the purpose of completion of exit formalities. **Henceforth no DTA procurements / imports will be allowed to the transferor unit.**
3. The Committee also directed the transferee unit to rectify the deficiencies already conveyed **along with deposition of RIICO dues to the tune of Rs. 1,67,680/-.**
