

Minutes of the Approval Committee Meeting of Jaipur Special Economic Zone, Sitapura (Multi Product SEZ) held at 11:00 AM on 18.07.2024 under the chairmanship of Shri A. Bipin Menon, Development Commissioner (physical mode in Mahindra SEZ, Jaipur).

The following members of Approval Committee were present during the meeting through video conferencing:

It was informed that the quorum was complete and the meeting could proceed.

The Chairman welcomed the participants at the outset and then the agenda taken up for sequentially. After detailed deliberation amongst the members of the Approval Committee as well as interaction with Developer/ Representatives of the Units/ Applicants, the following decisions were unanimously taken:

Agenda Ratification of Minutes of Approval Committee meeting No. 1 held on 21.06.2024:

It was informed that no reference has been received against the decisions of the Approval Committee Meeting held on **21.06.2024** from any of the members of the Approval Committee/ Trade/ Unit. Therefore, Minutes of the meetings of Approval Committee held on 21.06.2024 were unanimously ratified.

Agenda Proposal of M/s GEM EXCEL, for renewal of LOA with No. 2 Broad-banding of Authorized Items (Enhancement of Capacity):

2.1. The proposal of M/s GEM EXCEL, Plot No. H-54, SEZ-II, for renewal of LOA with broad-banding of items (Capacity enhancement) in LOA No. in LOA No. 2-9/2004-SEZ-II (J) Proj./515 dated: 26.05.2004 was discussed in the meeting.

2.2. Shri Dinesh Malpani, Partner & Shri P.K. Mishra, Manager, appeared before the Approval Committee on behalf of the unit and explained the proposal. On being asked by the committee, Shri Malpani informed that Unit will submit revised Form-F1 with correct details & replies to the observations for further course of action.

2.3. After due deliberations, the Approval Committee took a serious note on the export performance of unit. However, in light of the export order for Tourmaline from M/s Passion Gems Co. Limited., Japan, it was agreed to provide an opportunity by extending the LOA for six months until **18.1.2025**. This extension is however subject to rectification of deficiencies. Further, the committee also approved manufacturing of only the following product in the extended LOA:

2.4. Further, the committee also decided that the export performance of the unit shall be reviewed in the UAC during January, 2025 and if the performance of unit is not found satisfactory during the said stipulated period, appropriate action would be taken against the unit.

2.5. The approval of the proposal is subject to rectification of observations already conveyed to the unit. The unit shall strictly follow the Instruction No. 88 dated 16.08.2017. Moreover, the unit will also execute BLUT for aforesaid purposes.

Agenda Proposal of M/s Mangalam Gems & Jewellery for No. 3. renewal of LOA with broad-banding of authorized items:-

3.1. The proposal of M/s Manglam Gems & Jewellery, Plot No. F-89, SEZ-II, for renewal of LOA with broad-banding of items in LOA No. 2-127-SEZ-II (J) Proj./489 dated: 03.07.2006 with broad-banding of authorized items was discussed in the meeting.

3.2. Shri Ajay Gupta, Partner, & Shri I.S. Poonima, Manager, appeared before the Approval Committee through video conferencing and explained the proposal. On being asked by the committee, they informed that the Unit would submit revised Form-F1 with correct details & replies to the observations for further course of action.

3.3 After due deliberations, the Approval Committee unanimously **approved in principle** the proposal for renewal of LOA **up to 31.12.2024**. The committee also empowered the office of Development Commissioner for approval of authorized products on file after submission of full name/description of stones mentioned in the export order of Jewel Palate LLC, UAE.

3.4. Further, the committee also decided that export performance of the unit shall be reviewed in the UAC during December-2024 and if the performance of unit is not found satisfactory during the said stipulated period, appropriate action shall be taken against the unit.

Agenda Proposal of M/s Vaibhav Global Limited, for addition / No. 4 revision of new items:

4.1. The Proposal of M/s Vaibhav Global Limited, Plot No. E-1 & E-2, SEZ-II, Sitapura, Jaipur for addition / revision of new items in existing LOA No. 2-5/2014-SEZ-II (J) Proj./ 1118 dated: 18.12.2014 was discussed in the meeting.

4.2. Shri Mr. Subhanshu Mishra, Manager & Authorized representative appeared before the Approval Committee on behalf of the unit and explained the proposal. On being asked by the committee, he informed that the Unit will submit revised Form-F3 with correct details & replies to the observations for further course of action.

4.3. After due deliberations, the Approval Committee unanimously approved the proposal of addition/revision of items based on the credible export performance & export orders given by unit except the following:

4.5. The approval is subject to rectification of observations already conveyed to the unit. The unit shall strictly follow the Instruction No. 88 dated 16.08.2017 related to FTP 2015-20 issued by DoC. Further, the unit will also follow SOP issued by the O/o the DC, NSEZ, Noida vide letter No.1158 dated 31.01.2023 in respect of handling of silver jewellery studded with diamonds. The sourcing of products restricted for imports such as Coral etc. from DTA will not be allowed & it will be subject to conditions of CITES. Further, no export of restricted/prohibited items will be allowed without an appropriate approval/license. The unit will also execute BLUT for aforesaid purposes.

5. Proposal for change of entity name in existing LOA:-

5.1 The Proposal of M/s JEWELUM INDIA PRIVATE LIMITED, Plot No. H-62(A), SEZ-II, Sitapura, Jaipur for change of entity name in existing LOA No. 1-6/2021-22-SEZ-II (J) Proj./ 143 dated: 13.05.2022 was discussed in the meeting. The LOA of the unit is valid upto 12.05.2025.
