
The Approval Committee observed that the services listed at S.No. 2, 5 & 7 are not related to the Authorized operations of SEZ Developer.

Shri Sunil Agarwal, AVP, Shri D.K. Sharma, General Manager-Commercial, Shri Sanjeev Shukla, AGM Projects & Shri Neeraj Kumar, Dy. Manager- Finance appeared before the Approval Committee on behalf of the developer and explained the requirement of proposed list of materials. It was informed by them that items proposed under the authorized operations namely 'Electrical, Gas and Petroleum Natural Gas Distribution Network including necessary sub-stations of appropriate capacity, pipeline network etc.' are not required for power generation and these items are electrical items which are required to be used as electrical fittings inside the building.

It was informed by them that the SEZ is proposed to be developed in a phased manner and proposed items are required for development of Phase-I of the SEZ.

After due deliberations, the Approval Committee approved the proposal of developer.
