Minutes of the meeting of the Approval Committee of IT/ITES SEZ of M/s. HCL IT City Lucknow Pvt. Ltd., Lucknow (Uttar Pradesh) held under the Chairmanship of Dr. L.B. Singhal, Development Commissioner, Noida SEZ at 12:00 Noon on 16.05.2016 in the Conference Hall of NSEZ.

The following members of the Approval Committee were present during the meeting:-

- 2. Besides, during the meeting Shri Prakash Chand Upadhyay, ADC was also present to assist the Approval Committee.
- 3. At the outset, DC, NSEZ welcomed the participants. After brief introduction, each items included in the agenda were taken up for deliberation. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the representatives of the developer, the following decisions were taken:-
- (i) Ratification of Minutes of last meeting of the Approval Committee:-

The Approval Committee was informed that no reference against the decisions of the Approval Committee held on 18/02/2016 was received from any of the members of the Approval Committee or Trade and therefore, Minutes of the meeting held on 18/02/2016 were ratified.

- (ii) Item wise decisions on proposals included in agenda are as under:
- 1. Proposal of M/s. HCL IT City Lucknow Pvt. Ltd., developer for approval of list of material to carry on authorized operations in their IT/ITES SEZ at Village Kanjehara & Mastemau, Chack Gajaria Farms, Sultanpur Road, Lucknow (Uttar Pradesh).

It was brought to the notice of the Approval Committee that M/s. HCL IT City Lucknow Pvt. It was brought to the notice of the Approval Committee that in Chartered Engineer Certificate, it has been mentioned that the proposed list of goods/material is also required for development of Energy Center. However, it was informed that no energy center has been approved to the developer as yet.

It was also informed that, Department of Commerce, Govt. of India vide letter No.P.6/3/2006-SEZ (Vol.III) dated 16.02.2016 has issued a new guidelines in supersession of all previous Power guidelines issued by the ministry. In Para IV of said guidelines it is prescribed that, "with respect to the IT/ITES SEZs, which require continuous quality power, wherever generation of power has been approved by the BoA, as authorized operation, to the Developer/Co-developer within the processing area, and in respect of which there is a statutory requirement on developer/co-developer to supply 24 hours uninterrupted quality power supply at stable frequency in the Zone, in terms of Rule 5A of SEZ Rules, 2006; in such cases generation of power will be carried out as a unit within the processing area, and such a power plant including non-conventional energy power plant, will be entitled to all the fiscal benefits covered under section 26 of the SEZ Act including the benefits for initial setting up, maintenance and the duty free import of raw materials and consumables for the generation of the power. Such duty free imports of capital goods, raw material and consumables etc. would be counted towards the NFE obligations of the unit".

Shri Sunil Agarwal, AVP, Shri D.K. Sharma, General Manager-Commercial & V. Rajesh, Associate Director, appeared before the Approval Committee on behalf of the developer. It was informed by them that the SEZ is proposed to be developed in phased manner & proposed items are required for development of Phase-I of the SEZ.



After due deliberations, the Approval Committee approved the proposal of developer, except list of material proposed under 'Power (including power back up facilities) for captive use only', with the advice to the developer to apply afresh as per the provisions of new power guidelines issued by Department of Commerce, Govt. of India vide letter No.P.6/3/2006-SEZ (Vol.III) dated 16.02.2016. The Approval Committee has also advised the developer to submit the revised Chartered Engineer Certificate.

It was brought to the notice of Approval Committee that services listed at S. No.2,4,5,7,8,21 & 22 above are not covered in either the default services already approved by UAC or Instruction No.79 dated 19.11.2013.

Shri Sunil Agarwal, AVP, Shri D.K. Sharma, General Manager-Commercial & V. Rajesh, Associate Director, appeared before the Approval Committee on behalf of the developer and explained the requirement of proposed services.

After due deliberations, the Approval Committee approved the uniform list of 66 nos. of default services (as already approved by different UACs to other SEZs) to the Developer in terms of DOC letter no. D-12/19/2013-SEZ dated 19th June, 2014 & subsequent letter dated 9th July, 2014. The Committee also directed the representative of developer to submit the fresh proposal with specific justification for requirement of services listed at S.No. 2,4,5,7,8,21 & 22 of its proposal.

It was informed that in Chartered Engineer Certificate submitted by the developer, it has been mentioned that the proposed list of goods/material is required for development of Energy Center also. However, it was informed that no energy center has been approved to the developer as yet. It was further informed that the value of material for authorized operation "Electrical, Gas and Petroleum Natural Gas Distribution Network including necessary sub-stations of appropriate capacity, pipeline network etc." has been mentioned as Rs. 59.11 Lacs however the same is seen to be mentioned as Rs. 1225.98 in the summary of requirement of proposed goods attached with CE certificate.



Shri Sunil Agarwal, AVP, Shri D.K. Sharma, General Manager-Commercial & V. Rajesh, Associate Director, appeared before the Approval Committee on behalf of the developer. It was informed by them that the SEZ is proposed to be developed in phased manner & proposed items are required for development of Phase-I of the SEZ.

After due deliberations, the Approval Committee has approved the proposal of developer subject to submission of revised/rectified Chartered Engineer Certificate.
