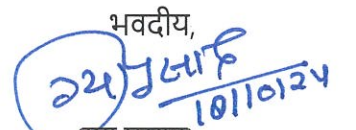

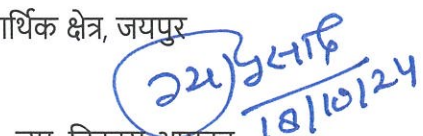

Agenda No.2 Proposal of M/s Mahindra World City (Jaipur) Limited for approval of "Food Court Services"

2.1. M/s Mahindra World City (Jaipur) Limited had submitted a request to add one more vendor for providing food services in the "M/s Mahindra World City (Jaipur) Limited" at the food court in "Evolve" building covering area 223 square feet (built-up space). This was in the name of "M/s JB FOOD" , a proprietorship firm, situated at Floor No. 7, Flat No. 16/764, Ashiana Umang, Ajmer Road, Aldia Real State, Chhatarpura, Lalya Ka Bas, Jaipur.

3.1. M/s Atelier Pinkcity Private Limited, Plot No. PA-009- 001,015 & 016, Mahindra World City (Jaipur) Limited SEZ, Jaipur had submitted a request for broad banding and enhancement capacity of production and revision of HSN code in the LOA.

3 . 2 . **Shri Mohit Gupta**, Company Secretary & Authorized representative appeared before the approval committee through video conferencing on behalf of the unit and explained the proposal. On being asked by the committee, he informed that Unit will submit revised Form-F3 with correct details & replies to the observations for further course of action.

3.2.
