Minutes of the Approval Committee meeting of Mahindra World City (Jaipur) Ltd. Multi-Product SEZ, Jaipur, held under the Chairmanship of Shri A. Bipin Menon, Zonal Development Commissioner, NSEZ at 11:30 AM on 21.06.2024 in Hybrid mode at Conference Hall at 2nd Floor of O/o DC, NSEZ, Noida and through Video Conferencing.

The following members of Approval Committee were present during the meeting through video conferencing:-

Besides, during the meeting (i) Shri Buddhi Prakash, Specified Officer, Mahindra World City SEZ, Jaipur; (ii) Shri Nitin Gupta, Deputy Development Commissioner, NSEZ; (iii) Shri Pankaj Sharma, Assistant Development Commissioner, NSEZ and (iv) Shri Sunil Gulyani, Stenographer Gr.II, NSEZ were also present to assist the Approval Committee. It was informed that the quorum is available and the meeting can proceed.

At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken:-

1. Ratification of the Minutes of the Approval Committee meeting held on 17.05.2024:-

As no reference in respect of the decisions of the Approval Committee held on 17.05.2024 was received from any of the members of the Approval Committee and therefore, the Minutes of the Meeting held on 17.05.2024 was unanimously ratified.

Agenda Item 2 : Proposal for approval of list of materials in the case of M/s. Mahindra World City (Jaipur) Limited

2.1 M/s. Mahindra World City (Jaipur) Limited, Developer, Multi Product SEZ, Village Kalwara, Jhal, Bhambhoriya, Bagru Khurd & Newta, Tehsil- Sanganer, District-Jaipur (Rajasthan) had submitted a proposal for approval of list of materials to carry on following approved authorized operations in SEZ:-

2.2 Shri Vimal Mishra, representative of the Developer joined the meeting through video conferencing and explained the proposal.

2.3 After due deliberations, the Approval Committee unanimously approved the list of materials.

Item No. 3: Sub: Addition/revision of items & HSN codes of M/s. Yaseen Lighting Pvt. Ltd in existing LOA No. 10/11/2018-SEZ/3078 dated 21.03.2018 -Reg.

3.1. M/s. Yaseen Lighting Private Limited, is an SEZ unit in the Mahindra World City (Jaipur) Ltd. Developer, Multi Product SE at, Village Kalwara, Jhai, Bhambhoriya, Bagru Khurd & Newta, Tehsil- Sanganer, District-Jaipur (Rajasthan). They had been granted LOA No. 10/11/2018-SEZ/3078 dated 21.03.2018 for setting up a unit in the Mahindra World City (Jaipur) Limited, Multi Product SEZ, Jaipur, Rajasthan, for the manufacturing of LED Lighting, Lighting Fixtures, and LED Smart Systems. The unit had executed a bond-cum-legal undertaking, which was accepted by the competent authority. The unit had commenced its operation w.e.f. 29.06.2025 and accordingly, their LOA was validated up 28.06.2025. There was no product for which trading was allowed in the LOA dated 21.03.2018.

3.2. The unit, vide its letters dated nil received on 04.06.2024 and letter dated 05.06.2024, had requested for addition of HSN code in the existing LOA. The unit has informed that their existing LOA includes HSN codes 8539, 8536, 8544, 8525, and 9405. Further, the unit had informed that they have categorized their authorization into two categories i.e. manufacturing and trading. The Unit had submitted a detailed HSN-Code wise list for products for manufacturing and trading.

3.3. Shri Sunil Puri, Director of the Unit attended the Meeting. He informed that for ease of business, they wanted to add the HSN Codes in the LOA for hassle free exports at the port. Further, they planned to enter into trading activities in near future.

3.4. The Committee noted that in the HSN list of products provided, there were consumables and raw materials too. The Unit's representative replied that as per their client's requirements, these were for replacement of defective or broken pieces in the original export consignment.

3.5. The Committee deliberated on the proposal and was not convinced on the unit's reply. The Committee advised the unit to submit a revised list of HSN Codes

for the products to be included in the LOA. The Committee empowered the office of DC to examine/approve the matter on file and inform the same to Approval Committee in its next meeting.

The meeting ended with a vote of thanks to the Chair.
