

## **NOIDA SPECIAL ECONOMIC ZONE**

**Minutes of the Approval Committee meeting of Mahindra World City (Jaipur) Ltd. Multi-Product SEZ, Jaipur, held under the Chairmanship of Shri A. Bipin Menon, Zonal Development Commissioner, NSEZ at 12.00 Noon on 25.11.2024 in Hybrid mode at O/o Development Commissioner, Noida Special Economic Zone, Noida and through Video Conferencing.**

Besides, during the meeting (i) Shri Buddhi Prakash, Specified Officer, Mahindra World City SEZ, Jaipur; (ii) Shri Gya Prasad, Deputy Development Commissioner, NSEZ; (iii) Shri Pankaj Sharma, Assistant Development Commissioner, Jaipur SEZ and (iv) Shri Sunil Gulyani, Stenographer were also present to assist the Approval Committee. It was informed that the quorum was available and the meeting could proceed.

At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants/representatives of the developers/units, the following decisions were taken:-

**1 . Ratification of the Minutes of the Approval Committee meeting held on 14.10.2024:-** As no reference in respect of the decisions of the Approval Committee held on 14.10.2024 was received from any of the members of the Approval Committee, the Minutes of the Meeting held on 14.10.2024 was unanimously ratified.

**2. Proposal of M/s Aussimmelba Makhan Private Limited for setting up of SEZ unit M/s. Mahindra World City (Jaipur Ltd., Multiproduct SEZ, Jaipur:**

It was informed to the Committee that M/s Aussimmelba Makhan Private Limited has applied for setting up of SEZ unit in M/s. Mahindra World City (Jaipur Ltd., Multiproduct SEZ, Jaipur for manufacture and export of following items:-

The applicant unit had proposed export of Rs.27000/- lakh over a period of five years. The proposed investment of Rs. 1700/- lakh as indigenous capital goods and Rs.150/- lakh in Indigenous Input Services. The applicant had submitted



provisional allotment letter dated 04.10.2024 from the SEZ Developer.

2.1. Shri Manik Yash Yandamuri and Moudem Goutham Nag, Directors of the applicant unit appeared before the Approval Committee and explained the proposal. They informed that out of three directors two are residents of Australia and currently their manufacturing units are situated in Australia that they want to shift to MWC SEZ, Jaipur, India. Presently, they are making exports through third party and well known the procedures and norms for export of food items. The proposed project will manufacture and export Sweets, Namkeen etc. they proposes to export products designed and developed by them to more than fifteen countries namely Australia, New Zealand, USA, Norway etc. They will obtain the FSSAI and other required certificates if Letter of Approval issued to them.

2.2. It was informed to the Committee that some discrepancies had been communicated to the unit and the unit had submitted its brief reply that is under process.

2.3. The Approval Committee discussed the proposal in detail and after due deliberations, **approved the proposal** of M/s Aussimmelba Makhan Private Limited for setting up a new unit. This approval is subject to ratification of discrepancies already communicated to the unit.
