Minutes of the Approval Committee meeting of Mahindra World City (Jaipur) Ltd. Multi-Product SEZ, Jaipur, held under the Chairmanship of Shri A. Bipin Menon, Zonal Development Commissioner, NSEZ at 12.00 Noon on 27.05.2025 in Hybrid mode at Conference Hall at 2nd Floor of O/o DC, NSEZ, Noida and through Video Conferencing.

The following members of Approval Committee were present during the meeting through video conferencing:-

- Besides, during the meeting (i) Shri Salil Gopal Kansal, Specified Officer, Mahindra World City SEZ, Jaipur; (ii) Shri Pankaj Sharma, Assistant Development Commissioner, NSEZ and (iii) Shri Sunil Gulyani, Stenographer Gr.II, NSEZ were also present to assist the Approval Committee. It was informed that the quorum is available and the meeting can proceed.
- At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken:-

Item No. 1. Ratification of the Minutes of the Approval Committee meetings held on 22.04.2025:-

As no reference in respect of the decisions of the Approval Committee held on 22.04.2025 was received from any of the members of the Approval Committee, Minutes of the Meetings held on 22.04.2025 were unanimously ratified.

Item No. 2: Proposals for setting up SEZ unit in M/s Mahindra World City (Jaipur) Limited Multi-product SEZ:

2.1 M/s Prachit Technology Services Private Limited

2.1.1. It was informed to the Committee M/s Prachit Technology Services Private Limited has applied for setting up of SEZ unit at Plot No. IT-B-11 of 2546.70 Square Meter in M/s Mahindra World City (Jaipur) Limited Multi-



product SEZ at Jaipur for export of 'Information Technology & Related Services (CPC-8313)'.

2.1.2. The applicant had proposed export of Rs.9392.00 lakhs over a period of five years and proposed NFE is Rs.9337.00 lakhs. The proposed investment of Rs.70.00 lakhs in indigenous capital goods and Rs. NIL in imported capital goods. The applicant has submitted provisional allotment letter for Plot No. IT-B-11 of 2546.70 Square Meter in M/s Mahindra World City (Jaipur) Limited Multi-product SEZ at Jaipur.

2.1.3 Shri Vivek Gupta, CEO of the applicant Unit appeared virtually before the Approval Committee and explained the proposal. He elaborated about the project.

2.1.4 It was informed to the Committee that the unit has submitted reply of the deficiencies observed which are under consideration.

2.1.5 The Approval Committee discussed the proposal in detail and after due deliberations, **approved** the proposal of M/s Prachit Technology Services Private Limited for setting up a new unit at Plot No. IT-B-11 of 2546.70 Square Meter in M/s Mahindra World City (Jaipur) Limited Multi-product SEZ at Jaipur. This approval is subject to rectification of discrepancies.

2.2 M/s. Triumph Motorcycles Private Limited

2.2.1. It was informed to the Committee that M/s. Triumph Motorcycles Private Limited had applied for setting up of SEZ unit at Tower B-1, First Floor, Mahindra World City (Jaipur) Limited, Village Kalwara, Tehsil- Sanganer, Jaipur-302037 for export of 'Engineering and design services (CPC Code 8391)'.

2.2.2. The applicant has proposed export of Rs.7050.00 lakhs over a period of five years and proposed NFE is Rs.6985.00 lakhs. The proposed investment of 100.00 lakhs in indigenous capital goods and Rs. 50.00 lakhs in imported capital goods. The applicant has submitted provisional allotment letter for Tower B-1, First Floor, Mahindra World City (Jaipur) Limited, Village Kalwara, Tehsil-Sanganer, Jaipur-302037.

2.2.3 Shri Sh. Pravin Ananda Kolekar, Head of Projects of the applicant Unit appeared in person before the Approval Committee and elaborated the project before the Approval Committee.

2.2.4 It was informed to the Committee that the unit has submitted reply of the deficiencies observed which are under consideration.


2.2.5 The Approval Committee discussed the proposal in detail and after due deliberations, **approved** the proposal of M/s. Triumph Motorcycles Private Limited for setting up a new unit at Tower B-1, First Floor, Mahindra World

City (Jaipur) Limited, Village Kalwara, Tehsil-Sanganer, Jaipur-302037 This approval is subject to rectification of discrepancies.
