

**Minutes of meeting of Unit Approval Committee of Mahindra World City (Jaipur) Ltd. (MWCIL)**

At the outset Development Commissioner welcomed the members and representatives of SEZ developer & SEZ Units.

1. UAC ratified the minutes of the meeting held on 17.03.2015.
2. **SEZ : Mahindra World City (Jaipur) Ltd. (IT/ITES SEZ)**
  - (i). Proposal of M/s. Mahindra World City (Jaipur) Ltd. for approval of list of materials to carry on authorized operation in the IT/ITES SEZ at Jaipur.

After due deliberations, UAC approved the list of materials (Annexure-A) required by the developer to carry on following authorized operations in the IT/ITES SEZ at Village Kalwara, Tehsil-Sanganer, Distt-Jaipur:-



After due deliberations, the Committee directed the unit to submit timeline and investment plans for implementation of the project for forwarding the proposal to Board of Approval.

- (iii) M/s. Systweak Software.- Execution of additional Bond-Cum-LUT to cover the excess import made by the unit.

The proposal of M/s. Systweak Software for execution of additional Bond-Cum-LUT to cover the excess import made by them in respect of its unit located in the IT/ITES SEZ of M/s. Mahindra World City (Jaipur) Ltd., Jaipur was placed before the Approval Committee. It was brought to the notice of UAC that



unit has made import of Rs.40415.70 lacs against the approved limit of imported raw materials/components/consumables for Rs.210.00 lacs. The representative of the unit could not explain the reasons for imports in excess of approved limits before the Committee. Accordingly, the Committee decided to issue Show Cause Notice for violation of terms & conditions of the Letter of Approval & the Bond-cum-LUT. The Committee also directed the representative of unit to submit the rectified APRs.

(iv) Proposal of M/s. Infosys BPO Ltd., Co-developer for approval of list of materials.

(ii). M/s. Rainbow Texfab Pvt. Ltd. – Proposal for setting up of new unit.

The proposal of M/s. Rainbow Texfab Pvt. Ltd. for setting up of unit over an area of 8162.94 sqmt. at Plot No. PA-012-010 in the Handicraft SEZ of M/s. Mahindra World City (Jaipur) Ltd. at Village – Kalwara, Tehsil- Sanganer, Distt- Jaipur (Rajasthan) was placed before the Approval Committee. The applicant has proposed item of manufacture as 'Home furnishing, made ups like bed sheets, table covers, cushion covers, quilts etc., men's, women's and children's clothing wear, apparel, house hold domestic and cotton silk and artificial silk and woolen goods, cloths and fabrics' with a annual capacity of 365000 pieces per annum. Projected investment on plant & machinery has been shown for Rs.40 lacs (indigenous). Requirement of indigenous raw materials for Rs.946.92 lacs has been projected by the applicant. Projected FOB value of exports has been shown as Rs.2695.50 Lacs with NFE earnings of Rs.2695.50 Lacs over a period of five years. The representative of the applicant informed that they will be making fresh investment and they shall be doing a fresh business. It was brought to the notice of the Committee that some of the proposed items are not handicraft items. Further, in Part-II of Form-F against the column of "Sub contracting permission is required for" – the applicant has mentioned Not Required, whereas in the manufacturing process it is submitted that dying of the fabrics will be done from export standard process houses outside the premises. Similarly, the company will then send the cloth to printer house or process house.

After due deliberations, the Committee approved the authorized operation as 'Handcrafted Home furnishing, made ups like bed sheets, table covers, cushion covers, quilts; Handcrafted men's, women's & children's clothing wear. Handcrafted house hold domestic goods of cotton silk/artificial silk/ wool/ cloths/ fabrics', subject to condition that formal approval shall be issued only after submission of Part-II of Form-F giving details of sub-contracting as shown in manufacturing process by the applicant.
