**Minutes of meeting of Unit Approval Committee of Mahindra World City (Jaipur) Ltd. (IT/ITES,
Engineering & related Industry, Handicraft SEZ)
held on 15.05.2014 at Board Room, RIICO, Jaipur (Rajasthan)**

The meeting was chaired by Dr. L.B. Singhal, Development Commissioner, NSEZ. Following members of UAC & representatives of SEZ Developer / Units attended the meeting:-

At the outset Development Commissioner welcomed the members and representatives of SEZ developer & SEZ Units.

1. UAC ratified the minutes of the meeting held on 05.12.2013.
2. **SEZ : Mahindra World City (Jaipur) Ltd. (IT/ITES SEZ)**
 - (i) Proposal of M/s Tweaking Technologies Pvt. Ltd. for setting up of unit in Mahindra IT/ITES SEZ Ltd., Jaipur.

The proposal of M/s Tweaking Technologies Pvt. Ltd. for setting up of unit in the IT/ITES SEZ of M/s Mahindra World City (Jaipur) Ltd. at Village – Kalwara, Tehsil- Sanganer, Distt- Jaipur (Rajasthan) was placed before UAC. The unit shall be engaged in authorized operation viz 'BPO, Customer Support Center, Software Development and allied services related to software development'. The unit has shown fresh investment of Rs. 550.30 Lacs. Projected FOB value of exports has been shown as Rs.9700 Lacs with NFE earnings of Rs. 9209.70 Lacs over a period of five years. The applicant has obtained provisional offer of space for land area admeasuring 17159.28 Sq. mtrs. from the developer. The representative of the applicant given a detailed presentation before UAC about the performance of its sister concern company, M/s Systweak Software. The representative of the applicant company also informed that they will be making fresh investment and they shall be doing a fresh business. After due deliberations, UAC approved the proposal.

- (ii) Ratification of the approval for change of vendor from 'M/s. Jal Pan Hospitality Private Limited' to 'M/s. Bionic Hospitality Private Limited' to operate food court in the processing area of SEZ.

UAC ratified the approval granted to the developer by DC, NSEZ vide letter dated 31.03.2014 for change of vendor from 'M/s. Jal Pan Hospitality Private Limited' to 'M/s. Bionic Hospitality Private Limited' to operate food court in the processing area of IT/ITES SEZ at Jaipur (Haryana)

- (iii) Proposal of M/s Infosys BPO Ltd., Co-developer for approval of list of materials.

After due deliberations, UAC approved the list of materials (as per Annexure-A) required by the co-developer, for a period of six months, to carry on following authorized operations in the IT/ITES SEZ of M/s Mahindra World City (Jaipur) Ltd. at Village Kalwara, Tehsil-Sanganer, Distt- Jaipur :-

- (iv) Proposal of M/s. Infosys Ltd. (Unit) for extension in the validity period of sharing of space with M/s. Infosys BPO Ltd.

After due deliberations, UAC extended the validity period of sharing permission granted vide letter dated 28.04.2012 for further period of 18 months i.e. upto 27.10.2015.

- (v) Commencement of Operation by M/s. Girnar Software Ltd., a unit in IT/ITES SEZ of M/s. Mahindra World City (Jaipur) Ltd.

The issue regarding commencement of operation by M/s. Girnar Software Ltd. was discussed in detail by UAC. It was also brought to the notice of UAC that the LOA of the unit already expired on 29.03.2014. Besides, the unit has submitted intimation for commencement of operation w.e.f. 15.04.2014. The representative of the unit produced copy of first invoice raised by them to M/s. Giant Beverages Ltd., Nigeria on 30.04.2014. Specified Officer informed UAC that they had visited the premises of the unit on 17.04.2014 and it was observed that commercial activities are taking place in the unit and necessary infrastructure stands found there. Since, the LOA was already expired on 29.03.2014 and extension of LOA for fifth year is beyond the powers of DC/UAC, therefore, after due deliberations, UAC decided to recommend the matter with full facts to DOC for consideration by Board of Approval.

- (vi) Review of Annual Performance Report (APR) for the year 2012-13 submitted by M/s. Systweak Software.

After due deliberations, UAC taken note of the Annual Performance Report (APR) for the year 2012-13 submitted by M/s. Systweak Software.

- (vi) Proposal of M/s. Q3 Infotech Pvt. Ltd. for setting up of unit in Mahindra IT/ITES SEZ Ltd., Jaipur.

The proposal of M/s. Q3 Infotech Pvt. Ltd. for setting up of unit in the IT/ITES SEZ of M/s Mahindra World City (Jaipur) Ltd. at Village – Kalwara, Tehsil- Sanganer, Distt- Jaipur (Rajasthan) was placed before UAC. The project envisages investment of Rs. 35 lacs on indigenous plant & machinery. Projected FOB value of exports has been shown as Rs. 3865 Lacs with NFE earnings of Rs.3850 Lacs over a period of five years. The unit has obtained offer of space from the developer for an area of 5747 sq. mtrs. at Plot No. IT-A-018 in SEZ. It was informed to the UAC that documents like copy of PAN, address proof of directors etc. etc. are awaited from the applicant. The representative of the applicant informed that they will be making fresh investment and they shall be doing a fresh business. He also assured to provide above documents in due course. After due deliberations, UAC approved the proposal for the services prescribed in Rule 76 of SEZ Rules, subject to condition that formal approval shall be issued only after submission of requisite documents / information as already communicated to the applicant.


