

3.1.3 Sh. Pushpinder Singh, & Sh. Deepinder Singh Partners, of the company joined the meeting physically in the Conference hall and explained the proposal.

3.1.4 The Approval Committee discussed the proposal in detail and after due deliberations, gave an in principle approval to the proposal. It further empowered office of DC to examine the deficiencies on file on receipt of the documents mentioned at Para 3.1.2 above.

**Item No. 05: Proposal for setting up of 'Cafeteria', Tuck Shop, Kitchen, Executive Lunch/dining area and music room in the unit located in The Oxygen Business Park Pvt. Ltd. IT/ITES SEZ at Plot No. 7, Sector-144, Noida U.P.**

**5.1 M/s. Optum Global Solutions (India) Private Limited**

5.1.1 M/s. Optum Global Solutions (India) Private Limited, vide its letter dated 11.06.2025, has submitted a request to grant permission for setting up the cafeteria, Tuck Shop, Kitchen, Executive lunch/dining area & Music room at Ground floor in the SEZ premises of M/s. The Oxygen Business Park Pvt. Ltd. IT/ITES SEZ at Plot No. 7, Sector-144, Noida U.P. in terms of Instruction No. 95 dated 11.06.2019 read with Rule 11 (5) of the SEZ Rules, 2006. 5.1.2 Sh. Prateek Kukreja and Sh. Harpreet Singh, authorized persons of M/s. Optum Global Solutions (India) Private Limited joined the meeting through video conferencing and explained the proposal. Sh. Harpreet Singh informed the Committee that the space will be used for exclusive use of the employees of the Company. He further informed that the earlier approved space at 7<sup>th</sup> floor admeasuring to 6595 Square feet for cafeteria will now be used for authorized operations of the unit.

5.1.3 The Committee deliberated on Instruction No. 95, wherein it has been stated that the premises for setting up cafeteria, creche, gymnasium and similar facilities in the premises of unit for exclusive use of such units can be granted subject to following conditions:-

- i. The facilities as envisaged under the proviso to Rule 11(5) of the SEZ Rules could also be created by a unit for its exclusive use subject to obtaining a NOC from the Developer as well as necessary NOCs / clearances / approvals from the relevant statutory authorities.
- ii. The units shall not be eligible for any exemptions, drawback, concessions or any other benefit available under Section 7 or Section 26 of the SEZ Act, for creating or operating such facilities.

5.1.4 The Approval Committee discussed the proposal in detail and after due deliberations approved the proposal for setting up Cafeteria, Tuck Shop, Kitchen, Executive lunch/dining area & Music room (as shown in the table above at 5.1.1) at premises of SEZ unit at ground floor, Tower A of M/s. The Oxygen Business Park Pvt. Ltd. IT/ITES SEZ at Plot No. 7, Sector-144, Noida U.P. in terms of Instruction No. 95 dated 11.06.2019 issued by DOC. The UAC also granted in principal approval of the request of the unit for change of usage of earlier approved space at 7<sup>th</sup> floor admeasuring to 6595 Square feet for cafeteria to authorized operations of the unit. Further, UAC also directed the representative of the unit to submit the letter in this regard.

5.1.5 This approval is in terms of Instruction No. 95 dated 11.06.2019 and subsequent clarification dated 03.10.2023 issued by Department of Commerce. The approval is subject to statutory compliance and to the condition that neither the unit nor its vendor(s) shall be eligible for any exemptions, drawback, concessions or any other benefits available under SEZ Act / SEZ Rules, to setup and operate such facilities, except benefits of zero rating on lease / other charges paid by the unit to the developer. The unit shall obtain necessary NOCs/ clearances/ approvals such as fire, health etc. from the relevant statutory authorities, wherever applicable, as required under Instruction No. 95 dated 11.06.2019. Specified Officer shall verify and ensure that statutory compliances and aforementioned conditions are being met in the aforesaid facility in the unit's premises.

**Item No. 06: Proposal for Expansion/Deletion of Area.**

**6.1 M/s TLG India Private Limited**

6.1.1 Sh. Sanjeet Kumar, authorized person, of M/s. TLG India Private Limited joined the meeting through video conferencing and explained the proposal.

6.1.2 The Approval Committee discussed the proposal in detail and after due deliberations **approved** the proposal for expansion of area by addition of area 27069.64 Square feet at 2<sup>nd</sup> Floor, Tower C in the IT/ITES SEZ of M/s. Oxygen Business Park Pvt. Ltd., Plot No. 07, Sector-144, Noida.

**6.2 M/s. Exl Service.com (India) Pvt. Ltd.**

6.2.1 Sh. Raman Bhasin and Sh. Ravindra Lakhanpal, authorized persons, of M/s.Exl Service.com (India) Pvt. Ltd. joined the meeting in the Conference hall and explained the proposal. They informed the Committee that they have already submitted NOC from the Developer to vacate the said incubation space.

6.2.2 The Approval Committee discussed the proposal in detail and after due deliberations **approved** the proposal for surrender of incubation area 7540 Square feet at Ground Floor, Wing B, Building No. B-1 in the IT/ITES SEZ of M/s. Golden Tower Infotech Pvt. Ltd. at Plot No. 08, Sector-144, Noida (U.P.). Further, the unit shall submit the NOC from the Specified Officer in respect of the area to be deleted i.e.7540 Square feet at Ground Floor, Wing B, Building No.B-1.

**Item No. 07: Proposal for regularization of excess Utilization of imported capital goods beyond the approved value-reg.**

**7.1 M/s. NEC Corporation India Pvt. Ltd.**

7.1.1 Sh. Arohan Massey, Senior General Manager, of M/s.NEC Corporation India Pvt. Ltd. joined the meeting through video conferencing and explained about the excess utilization of imported capital goods amounting to Rs. 1396.57 Lakhs against the approved value of Rs. 1127.78 lakhs. He has informed that the additional investment of Rs. 268.79 lakh was made during last block period to upgrade their capital goods. This was essential to enhance their operational capabilities in response to rising global competition and evolving business challenges. Further, representative of the unit has informed that procurement has happened unknowingly. He assured that it will not happen again.

7.1.2 The Approval Committee observed that the originally approved value of capital goods was Rs. 1127.78 lakhs, whereas the unit {M/s. NEC Corporation India Pvt. Ltd. (Unit-II) located in the Seaview Developers Pvt. Ltd. IT/ITES SEZ at Plot No. 20 & 21, Sector-135, Noida(U.P.)} has reported utilized value in Form F-1 amounting to Rs. 1396.57 lakhs. The Committee empowered office of Development Commissioner to take a decision on file in the matter as per precedence.

**7.2 Xavient Software Solutions India Private Limited**



7.2.1 Sh. Ashish Jain, Director of M/s. Xavient Software Solutions India Private Limited joined the meeting through video conferencing and explained about the excess utilization of imported capital goods amounting to Rs. 2824.00 Lakhs against the approved value of Rs. 1559.00 lakhs in the last block period. Unit has reported utilized value in Form F-1 amounting to Rs. 2824.00 lakhs.

7.2.2 The Approval Committee observed that the originally approved value of capital goods was Rs. 1559.00 lakhs, whereas the unit {Xavient Software Solutions India Private Limited a unit in the Seaview Developers Private Limited IT/ITES SEZ at Plot No. 20 & 21, Sector-135, Noida (U.P.)} has reported utilized value in Form F-1 amounting to Rs. 2824.00 lakhs. The Committee empowered Development Commissioner to take a decision on file in the matter as per precedence. Further, the unit will submit the break-up of forex outgo.


1.1.2 This approval is subject to following terms & conditions:-

- Products which are 'Prohibited/Restricted' for import and export under the Foreign Trade Policy (FTP) would not be permitted.
- The scope of authorized operations of the unit will be strictly as per Rule 18(5) of SEZ Rules, 2006.
- All transaction shall be only in convertible foreign currency in terms of proviso to Rule 18(5) of SEZ Rules, 2006.
- Port restrictions as per DGFT notifications/public notice/instructions issued from time to time shall be applicable.
- The unit shall obtain necessary 'NOC' for import/export from the concerned Central/State Ministries/departments and relevant authorities including Import Policy of DGFT.
- The transfer of goods from one FTWZ to another FTWZ should not be allowed except in specific and exceptional cases after consideration by the UAC.
- The unit shall strictly comply with the guidelines for operational framework of FTWZ and warehousing units issued vide Instruction No. 117 dated 24.09.2024.

## 1.2 M/s. Horizon Tradelinks

1.2.1 The Approval Committee discussed the proposal of M/s. Horizon Tradelinks for inclusion of 197 nos. additional items in LOA in light of recommendation of Committee constituted through order dated 07.10.2024 to examine the products in terms of sensitivity of the products for the unit in Arshiya North FTWZ, Khurja. After due deliberations, approved the HS Codes given in the table below for inclusion in the LOA of the unit.

1.2.2 This approval is subject to the condition that Specified Officer shall ensure that procurement of products 'Restricted / Prohibited' for import/export shall not be allowed.

1.2.3 This approval is subject to following terms & conditions:-

- Products which are 'Prohibited/Restricted' for import and export under the Foreign Trade Policy (FTP) would not be permitted.
- The scope of authorized operations of the unit will be strictly as per Rule 18(5) of SEZ Rules, 2006.
- All transaction shall be only in convertible foreign currency in terms of proviso to Rule 18(5) of SEZ Rules, 2006.
- Port restrictions as per DGFT notifications/public notice/instructions issued from time to time shall be applicable.
- The unit shall obtain necessary 'NOC' for import/export from the concerned Central/State Ministries/departments and relevant authorities including Import Policy of DGFT.



- vi. The transfer of goods from one FTWZ to another FTWZ should not be allowed except in specific and exceptional cases after consideration by the UAC.
- vii. The unit shall strictly comply with the guidelines for operational framework of FTWZ and warehousing units issued vide Instruction No. 117 dated 24.09.2024.

1.2.4 Further, The Approval Committee noted that the LOA of the unit was valid upto 24.06.2025, and the unit has commenced its operations w.e.f. 11.12.2024 (date of first shipping bill/inward entry). Accordingly, the LOA of the unit will be valid upto 10.12.2029.

1.3 Further, with regard to inclusion of products under category of alcohol (i.e. HSNs of Ch. 22 : BEVERAGES, SPIRITS AND VINEGAR), Approval Committee mandated the Committee constituted through order dated 07.10.2024 to examine the products in terms of sensitivity of the products for taking a uniform decision on these sensitive items in respect of the warehousing units in NSEZ and Arshiya Northern FTWZ, Khurja.
