

NOIDA SPECIAL ECONOMIC ZONE

Minutes of the Approval Committee meeting in respect of SEZs located in Noida, Greater Noida & Khurja (Uttar Pradesh), held under the Chairmanship of Shri Gopal Meena, Development Commissioner, NSEZ at 11.00 AM on 07.07.2026.

B. Besides, during the meeting (i) Shri Gya Prasad, DDC & (ii). Shri Sushil Kumar, ADC were also present to assist the Approval Committee. It was informed that the quorum was available and the meeting could proceed.

C. At the outset, the Chairman welcomed the participants. After brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken unanimously: -

D. New initiatives / reforms in view of good governance for Viksit Bharat 2047 were taken:-

- Approvals shall be issued during the meeting itself, immediately after the approval of the Approval Committee, if found complete in all respect.
- Approvals at NSDL portal shall be given on same day.
- Calendar for conducting the Approval Committee meeting has been issued.
- Only those proposals which are received before five working days of the next scheduled date of the Approval Committee, shall be placed before the Approval Committee.
- The cases in which the Approval Committee has communicated the observations the representative of the unit and the matter has been deferred due to that, in those cases the unit is required to comply the observations in 5 working days (from the date of issue of the minutes) failing which the proposal may be treated as withdrawn.

H. Item wise decisions on proposals included in agenda:

Item No 01 : Setting up the new unit

1.1 M/s. Flemonte Aviation Private Limited

1.1.1 Ms. Poonam Gaur and Sh. Subham Gaur, Directors of the company joined the meeting and informed that M/s. Flemonte Aviation Private Limited has submitted a proposal for setting up a unit over an "213.60 Sqmtrs." area as warehousing space at Arshiya Northern FTWZ Ltd. Multi Sector SEZ at Village- Ibrahimpur, Junaidpur urf Maujpur, Khurja Distt- Bulandshahr (U.P.), to under service activities namely, " Warehousing activity of items as per list attached except 'Restricted' and 'Prohibited' items.

1.1.2 The applicant has proposed export of Rs.4270.00 lakh and cumulative NFE of Rs. 1708.00 lakh over a period of five years. The projected investment of Rs. 45.00 lakhs & Rs.148.00 lakh towards indigenous and imported capital goods respectively have been proposed. The applicant has also proposed indigenous & imported input services of Rs. 135.00 lakhs & Rs. 72.00 lakhs respectively. The applicant has submitted copy of provisional offer of space dated 19.06.2026 issued to them by SEZ Developer for allotment of proposed space. The proposed employment mentioned by the Unit is 05 persons.

1.1.3 The Approval Committee discussed the proposal in detail and after due deliberations, **unanimously approved** the proposal of M/s. Flemonte Aviation Private Limited for setting up a unit over an area of “213.60 Sqmtrs” as warehousing space at Arshiya Northern FTWZ Ltd. Multi Sector SEZ at Village- Ibrahimpur, Junaidpur urf Maujpur, Khurja Distt- Bulandshahr (U.P.), to under service activities namely, "Warehousing, of items as per list attached except ‘Restricted’ and ‘Prohibited’ items.

1.1.4 This approval is subject to conditions as under:-

- i. The unit will not sell items below the import price.
- ii. Specified Officer shall ensure that any of the above items are not covered under SCOMET list.
- iii. Products which are 'Prohibited / Restricted for import and export under the Foreign Trade Policy (FTP) would not be permitted'.
- iv. The scope of authorized operations of the unit will be strictly as per Rule 18(5) of SEZ Rules, 2006.
- v. All transactions shall be only in convertible foreign currency in terms of proviso to Rule 18(5) of SEZ Rules, 2006.
- vi. The unit shall obtain necessary 'NOC' for import / import from the concerned Central / State Ministries / departments and relevant authorities including Import Policy of DGFT.
- vii. The unit shall strictly comply with the guidelines for operational framework of FTWZ and Warehousing units issued vide Instruction No. 117 dated 24.09.2024.
- viii. Destination related instructions has to be followed by the unit.
