NOIDA SPECIAL ECONOMIC ZONE

Minutes of the meeting of the Unit Approval Committee (UAC) of Private SEZs located in Noida, Greater Noida & Khurja (Uttar Pradesh) held under the Chairmanship of Dr. L.B. Singhal, Development Commissioner, Noida SEZ at 03.30 PM on 06/11/2015 in the Conference Hall of NSEZ.

The following members of UAC were present during the meeting:-

- 2. Besides, during the meeting i) Shri Rakesh Kumar, DDC, NSEZ, ii) Ms. Jyoti Wadhawan, Specified Officer, iii) Shri A.K. Srivastava, Specified Officer and iv) Shri Prakash Chand Upadhyay, ADC were also present to assist the UAC.
- 3. At the outset, DC, NSEZ welcomed the participants. After brief introduction, each items included in the agenda were taken up for deliberation one by one. After detailed deliberations amongst the members of UAC as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken:-
- (i) Ratification of Minutes of last meeting of the Approval Committee:-

It was informed that no reference against the decisions of the UAC held on 07/10/2015 has been received from any of the members of the Committee or Trade and accordingly, Minutes of the meeting held on 07/10/2015 were ratified.

- (ii) Item wise decisions on proposals included in agenda are as under:
- Proposal of M/s. NIIT Technologies Ltd. for approval of list of material to carry on authorized operations in the IT/ITES SEZ at Plot No. TZ-2 & 2A, Sector – Tech Zone, Greater Noida (U.P).

It was brought to the notice of UAC that M/s. NIIT Technologies Ltd., developer of IT/ITES SEZ located at Plot No. TZ 2& 2A, Sector-Techzone, Greater Noida had submitted a proposal for approval of a list of material to carry on following default authorized operations:-

Shri Devendra Gupta, Sr. V.P., appeared before UAC and explained the requirement of proposed material.

After due deliberations, the UAC approved the proposal except S. No. 33 of Annexure-I and S. No. 1 of Annexure-IV. UAC further directed the representative of the developer to submit clarification / justification on the requirement of 'Chlorine Dosing System' proposed at S. No. 33 of Annexure-I and '60 Nos. LED Screens / Digital Display' proposed at S. No.1 of Annexure-IV.

Shri Sunil Agarwal, AVP & Shri Rajesh Oberoi, AGM appeared before the UAC on behalf of the developer and explained the requirement of proposed material. The representative further explained that items proposed under the authorized operation namely 'Power (including power backup facilities) for captive use only' are not required for power generation and these items are electrical items which are required to be used as electrical fittings in the proposed building.

After due deliberations, the UAC approved the proposed list of material except 'Protocol Integrator for water leak detection system' proposed at SI. No. 27 of Annexure-IV. UAC further directed the representative of the developer to submit details / clarification for requirement of 'Protocol Integrator for water leak detection system'.

It was informed to the UAC that the developer had not indicated quantity of all the items proposed against the authorized operation at S. No. 4 above. Further, the items proposed under authorized operation namely 'Electrical, Gas and Petroleum Natural Gas Distribution Network including necessary sub-stations of appropriate capacity, pipeline network etc.' (SI. No. 5 & 8 above) were observed to be related to power supply and hence not found to be covered under the instant power guidelines dated 27.02.2009. Besides, the name of authorized operation given in Annexure-5 of list of material for authorized operation at S. No. 5 was not as per default authorized operations as given in Instruction No. 50 issued by DOC.

It was further informed to the UAC that the developer vide its letter dated 23.10.2015 had submitted a request for approval for change of name of the company consequent to conversion from Public Limited Company to Private Limited Company as 'Seaview Developers Private Limited'. In this regard, the developer had furnished a copy of Certificate of Incorporation consequent upon conversion from Public Limited Company to Private Limited Company issued by ROC, New Delhi on 21.10.2015. The above proposals were submitted by the developer in the new name i.e. 'Seaview Developers Private Limited'. Since, the proposal for change of name requires approval of DOC and it was observed that till such time developer should submit their all proposals in the name already approved.

Shri Jay Kumar, Head-SEZ Compliance, appeared before UAC and explained the requirement of proposed material.

UAC took a serious view on certification of list by the Chartered Engineer in a very casual manner and directed to call for an explanation from the Chartered Engineer & Developer in this regard with a copy to the Institute of Chartered Engineers.

After due deliberations, the UAC approved the proposed list of material except item listed at S. No.66 of Authorised operation at Sl. No.1, S. No. 52,53,56,60,61 of Authorised operation at Sl. No.2, S. No. 10 of Authorised operation at Sl. No.4 and S. No. 18 of Authorised



operation at SI. No.7 above as well as all the items proposed for 'Power (including power backup facilities) for captive use only' & 'Electrical, Gas and Petroleum Natural Gas Distribution Network including necessary sub-stations of appropriate capacity, pipeline network etc.' (S. No. 5 above) keeping in view of the Power Guidelines issued by Deptt. of Commerce, Government of India vide letter dated 06.04.2015, as this request is for processing area. UAC directed the representative of the developer to submit revised proposal in the name of 'Seaview Developers Limited'.
