NOIDA SPECIAL ECONOMIC ZONE

Minutes of the meeting of Unit Approval Committee in respect of SEZs located in Noida, Gr. Noida & Khurja (U.P.) held on 25.07.2012 at Conference Hall, NSEZ, Noida.

The meeting was chaired by Shri C.P.S Bakshi, Development Commissioner. The following officers / representatives also attended the UAC meeting:-

- 1. UAC ratified the minutes of meeting held on 26.06.2012.
- 2. M/s. Arshiya Northern FTWZ Ltd., FTWZ at Khurja (U.P.).
- (i) Annual Performance Report for the year 2011-12 submitted by M/s. Arshiya Supply Chain Management Ltd.

UAC noted that the unit has shown negative NFE during the year. The representative of the unit shown unawareness about the issue and requested to defer the issue. Accordingly, UAC deferred the issue for discussion in next meeting.

(ii) Proposal of M/s. Arshiya Northern FTWZ Ltd., developer for issue of Completion Certificate in respect of structure built in its FTWZ at Village Ibrahimpur, Junaidpur Urf Maujpur, Bulandshahr (U.P.)

The proposal was discussed by UAC. The representative of the developer requested for issuance of occupancy certificate for the warehouse already constructed instead of completion certificate of whole FTWZ. UAC directed the representative of the developer to submit a fresh application for issuance of occupancy certificate in respect of warehouse already constructed in the FTWZ.

- 3. M/s. Aachvis Softech Pvt. Ltd., IT/ITES SEZ at Noida
- (i). <u>Proposal of M/s. Aachvis IT SEZ Infra Pvt. Ltd., co-developer to allot builtup space to M/s. Little Oven to setup food court in the processing are of SEZ</u>

The proposal of M/s. Aachvis IT SEZ Infra Pvt. Ltd., co-developer to allot built-up space at part ground floor, Tower-A in the processing zone of SEZ on lease basis for the period of 09 years to M/s. Little Oven, E-702, Panchsheel Apartment, Plot No. 24, Dwarka, Sector-4, New Delhi to setup & operate a food court was placed before the UAC. After due deliberations, UAC approved the proposal subject to submission of PAN & last three years IT Returns alongwith an undertaking from M/s. Little Oven with effect that they shall not take any direct and/or indirect tax benefits under SEZ scheme to create, operate & maintain such facility in SEZ. UAC also directed the developer to intimate the area proposed to be allotted to M/s. Little Oven.

(ii). Proposal of M/s. ExlService SEZ BPO Solutions Pvt. Ltd. to install ATM facility of HDFC Bank in its Unit premises in the IT/ITES SEZ of M/s. Aachvis Softech Pvt. Ltd. at Plot No. 7, Sector-144, Noida.

The proposal of M/s. ExlService SEZ BPO Solutions Pvt. Ltd. to allot space on free of cost basis to M/s. HDFC Bank Ltd. for creating ATM facility in its unit premises at Ground floor, Tower-B in the processing area of IT/ITES SEZ of M/s. Aachvis Softech Pvt. Ltd. at Plot No. 7, Sector-144, Noida was placed before the UAC. It was brought to the notice of UAC that no such provisions are available in SEZ Act/Rules for allotment of space by a SEZ unit in its premises for creating such facility. However, in terms of Rule 11 (5) read with para 11(8) of SEZ Rules, 2006, the developer may allot space in processing area on lease basis to a person desiring to create infrastructure facilities for use by the prospective Units. After due deliberations, UAC rejected the proposal as the unit is not authorized to create such facility.

(iii). Proposals for approval of list of services.

UAC deferred all the proposals for approval of list of services listed as agenda item in this meeting with the direction to constitute a committee consisting of DDC (RK) & Specified Officers to find-out & prepare a master list of services required for SEZ developers / co-developer & Units in terms of notification no. 40/2012 dated 20th June, 2012.
