2. Besides, during the meeting (i) Shri R. K. Srivastava, Dy. Development Commissioner, NSEZ (ii) Shri Tapan Bhattacharyya, Specified Officer, Moradabad SEZ, (iii) Dr. V. P. Sharma, Asstt. Development Commissioner, Moradabad SEZ were also present to assist the Approval Committee.

3. At the outset, Development Commissioner, NSEZ welcomed the participants. After brief introduction, each item of the agenda was taken up for deliberation one by one. After detailed deliberations as well as interaction with the applicants/ representatives of the units, the following decisions were taken:-

1	Ratification of Minutes of last meeting of the Approval Committee held on 14/12/2018 It was informed that no reference against the decisions of the Approval Committee held on 14/12/2018 has been received, and therefore, Approval Committee ratified the Minutes of meeting held on 14/12/2018.
2.1	Proposal of M/S Global Export House - review of performance as per provisions of Rule 54 of SEZ Rules, 2006 - regarding. It was informed that M/s Global Export House was issued LOA No. NSEZ/4-367/2003-MBD/8579 dated 19.09.2014. The unit has been allotted Plot No. G-28, Pocket-"A". The unit commenced production on 20.01.2016 and the LOA is valid up to 19.01.2021. It was informed to the Approval Committee that remittances in respect of export proceeds amounting to Rs. 38,27,600.00/- pertaining to exports made from 01.04.2015 to 30.04.2018 have not been realized within the prescribed time period of nine months. It was informed that the case of

unit was considered in the Approval Committee meeting held on 14.12.2018 as the unit had Foreign Exchange pending for realization beyond nine months. However, the case was deferred for next Approval Committee meeting as no-one from the unit appeared before Approval Committee. The Approval Committee had taken serious note of absence of the promoters of the unit from the meeting and directed that a communication to promoters be sent through registered/speed post on the official/ residential address asking them to ensure their presence in the next meeting of Approval Committee.

Shri Mohan Maheshwari, CEO, M/s Global Export House appeared before the Approval Committee and informed that Foreign Exchange amounting to Rs. 12,61,600.00 has already been realized and remaining amount of Rs. 25,66,000.00 will be realized in February 2019. He also stated that the NFE of the unit is already positive but due to wrong entry of one Bill Of Entry (BOE) by the unit, NFE is showing negative on SEZ Online system. He informed that he will request the Customs officers, Moradabad SEZ and will get it corrected.

The Approval Committee directed Shri Maheshwari to (i) submit the e-BRC/ Bank Certificate for the Foreign Exchange pending for realization beyond nine months to ADC, Moradabad SEZ, (ii) submit time extension from AD Bank or RBI, as the case may be, for regularization of the Foreign Exchange realized after the stipulated time period of 9 months, and (iii) submit the CA certified Export and Import report for the unit to this office so as to ascertain the exact NFE status.

The Approval Committee, after deliberations, directed that the NFE status in accordance with Rule 54 of SEZ Rules, 2006 and pending Foreign Exchange for the unit may be ascertained by 31st March 2019.

2.2 **Proposal of M/S Guildart Unit-II - review of performance as per provisions of Rule 54 of SEZ Rules, 2006 - regarding.**

It was informed that M/s Guildart Unit-II was issued LOA No. NSEZ/4-169/2003-MBD/443 dated 05.07.2005. The unit has been allotted Plot No. D-08, Pocket-"A". The unit commenced production on 18.05.2009 and the LOA is valid up to 17.05.2019.

It was informed to the Approval Committee that remittances in respect of export proceeds amounting to Rs. 65,224.00/- pertaining to exports made from 01.01.2017 to 30.04.2018 have not been realized within the prescribed time period of nine months. It was informed that the case of unit was considered in the Approval Committee meeting held on 14.12.2018 as the unit had Foreign Exchange pending for realization beyond nine months. However, the case was deferred for next

Approval Committee meeting as no-one from the unit appeared before Approval Committee. The Approval Committee had taken serious note of absence of the promoters of the unit from the meeting and directed that a communication to promoters be sent through registered/speed post on the official/ residential address asking them to ensure their presence in the next meeting of Approval Committee.

Shri Prashant Mathur, authorized Representative appeared before the Approval Committee and informed that Rs. 43,897.00 will be realized in February 2019. He further informed that Foreign Exchange amounting to Rs. 21,327.00 cannot be realized as the amount pertains to Free Trade Samples sent to overseas buyers and the customs certified copies of Shipping Bills of the same have already been submitted to ADC, Moradabad SEZ.

The Approval Committee directed Shri Mathur to (i) submit the e-BRC/ Bank Certificate for the Foreign Exchange pending for realization beyond nine months to ADC, Moradabad SEZ and (ii) submit time extension from AD Bank or RBI, as the case may be, for regularization of the Foreign Exchange realized after the stipulated time period of 9 months.

It was advised by the Committee that in case the unit feels that the pending foreign exchange is not going to be realized, unit have an option of self write off or write off by the concerned AD Bank. For the unrealized export proceeds unit has to pay applicable customs duties with interest. The Committee also directed Specified Officer, MSEZ to look into the matter and ascertain applicable customs duties with interest if unit wants to write off the foreign exchange pending for realization.

The Approval Committee, after deliberations, deferred the case for the next Approval Committee meeting.

2.3 **Proposal of M/S Indian Heritage Perfumers - review of performance as per provisions of Rule 54 of SEZ Rules, 2006 - regarding.**

It was informed that M/s Indian Heritage Perfumers was issued LOA No. NSEZ/4-342/2003-MBD/7069 dated 16.05.2013. The unit has been allotted Plot No. L-05, Pocket-"A".The unit commenced production on 14.05.2015 and the LOA is valid up to 13.05.2020.

It was informed to the Approval Committee that remittances in respect of export proceeds amounting to Rs. 69,76,913.00/- pertaining to exports made from 01.04.2015 to 31.10.2017 have not been realized within the prescribed time period of nine months and is still pending. It was informed that the case of unit was considered in the Approval Committee meeting held on 14.12.2018 as the unit had Foreign Exchange pending for realization beyond nine months. However,

the case was deferred for next Approval Committee meeting as no-one from the unit appeared before Approval Committee. Approval Committee was informed that M/s Jainsons International was issued LOA No. NSEZ/4-207/2003-MBD/978 dated 14.09.2006 for Manufacturing & Export of "Handicrafts made of iron artware, Brass artware, Aluminum artware and other Indian handicrafts" in Moradabad SEZ. The unit has been allotted Plot No. A-3 & 4, Pocket-"A", Moradabad SEZ.

The unit commenced production on 12.04.2007. The first block of 5 years for the unit expired on 11.04.2012. The unit was granted renewal of LOA for the 2nd 5 years block up to 11.04.2017 by the Competent Authority. However, the unit then suspended their production from 01.04.2012. A Show Cause Notice was issued to the unit on 17.11.2014 due to non-operationalization of the unit since 01.04.2012 and the proposal was placed before Approval Committee for personal hearing on 19.06.2015. No one from the unit appeared before the Approval Committee for the hearing so the case was deferred for the next UAC.

Approval Committee was also informed that as per records, the LOA was valid up to 11.04.2017 and no request for renewal of LOA has been received in this office.

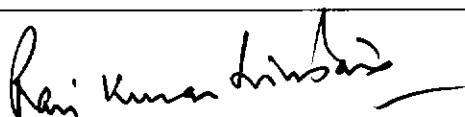

The unit has been allotted Plot No. D-05, Pocket-"A", Moradabad SEZ. It was also informed to the Approval Committee that as per records their LOA was valid up to 16.10.2017 and no request for renewal of LOA has been received. It was informed that the case was placed in the Approval Committee meeting held on 14.12.2018 for review of expired/lapsed LOA of the unit. Shri Upanshu Agarwal, Partner appeared before the Approval Committee and stated that most of the construction work on his SEZ unit is complete. He informed that in the year 2015-16, there was a change in partnership of the firm which was approved by the Approval Committee in its meeting held on 19.06.2015 but the same has not been approved by UPSIDC Ltd. The case of unit was considered in the Approval Committee meeting held on 14.09.2018, as the unit had Foreign Exchange pending for realization beyond nine months. Shri Imran Ahmad, Partner appeared before Approval Committee and informed that they will get extension from RBI for the unrealized remittances by 30.09.2018. The Approval Committee, in light of performance, extended the LOA of the unit up to 31.03.2019 and directed the representative of the unit as under:-

- i. to realize the export proceeds before 30.09.2018 and submit proof thereof to ADC, Moradabad SEZ and Specified Officer, Moradabad SEZ or
- ii. to seek extension from AD Bank or RBI as the case may be and submit the same to ADC, Moradabad SEZ and Specified Officer before 30.09.2018 or
- iii. return the drawback amount availed in the matter before 30.09.2018.

The Approval Committee directed Specified Officer, Moradabad SEZ that if the unit fails to take any of the three actions mentioned above then he will submit a draft Show Cause Notice be forwarded to Jurisdictional Customs Commissioner for approval by 1st week of October 2018. 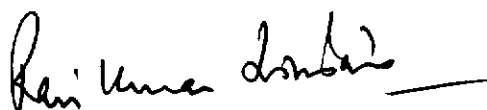

The Approval Committee directed Specified Officer, Moradabad SEZ that if the unit fails to take any of the three actions mentioned above then he will submit a draft Show Cause Notice be forwarded to Jurisdictional Customs Commissioner for approval by 1st week of October 2018. Specified Officer, Moradabad SEZ accordingly sent the draft SCN to Jurisdictional Customs Commissioner vide letter No 1-2/MSEZ/DBK/55/2016/Pt-II/13240 dated 08.10.2018 which were issued by Jurisdictional Commissioner on 15.01.2019.

It was informed that the unit had not submitted any documents in this office till date as directed by the Approval committee in its meeting held on 14.09.2018, but the unit has submitted their request for renewal of LOA in the form F-1 (Annexure-4) as prescribed by the amended SEZ rules notified by Notification No GSR 909(A) dated 19.09.2018.

Shri Ghazi Arif, Partner appeared before the Approval Committee and stated that they are realizing the Foreign Exchange pending for realization on a good pace. He stated that out of Rs. 56.00 Crores pending for realization, they have realized Rs. 8.00 Crores and the remaining Rs. 48.00 Crores will be realized within 3 months.

The Approval Committee directed the representative of the unit to (i) submit the e-BRC/ Bank Certificate for the Foreign Exchange of Rs. 8.00 Crores realized by them to ADC, Moradabad SEZ and (ii) submit time extension from AD Bank or RBI, as the case may be, for regularization of the Foreign Exchange realized after the stipulated time period of 9 months.

The Approval committee, in light of the performance and considering the fact that the unit is making sincere efforts in realizing pending Foreign Exchange, extended the LOA of the unit for one year up to 31.03.2020.

Shri Sameer Khan appeared before the Approval Committee and stated that they have already Commenced Production on 16.01.2019 by exporting their first Shipment.

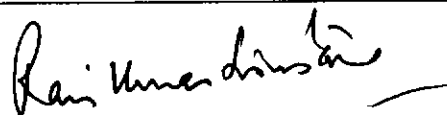

6	Proposal of M/s Ad Print Products Industries – Exit from SEZ Scheme- regarding It was informed to the Approval Committee that M/s Ad Print Product Industries has been issued LOA dated 21.08.2007 for Manufacturing & Export of Packaging items, Stationary and Indian Handicrafts. The unit commenced production on 02.05.2008 and its LOA was valid till 01.05.2018. It was informed to the Approval Committee that the unit has submitted a request for exit from SEZ Scheme. The unit has achieved Negative NFE to the tune of Rs 17.38 Lakhs. Besides Foreign Exchange of Rs. 6.23 Lakhs was also pending for realization. The case of the unit was put up in the Approval Committee meeting held on 30.05.2017. Shri Muti-ur-Rehman, Proprietor had appeared before the Approval Committee and informed that they propose to re-export the machine which was imported in their unit during the year 2015-16. He had also informed that he will receive the Foreign Exchange pending for realization within one month. The Approval Committee, after deliberations, had decided that the unit needs to submit the APR duly certified by the Chartered Accountant after exporting the said machine and proof of realization of Pending Foreign Exchange so as to ascertain the exact NFE status. The Approval Committee had accordingly deferred the proposal for its next meeting. On 15.02.2019, Shri Muti-ur-Rehman came to the Approval Committee and requested that his case may be considered by Approval Committee as he has travelled from Dubai for this. On his request and with permission of the Approval Committee, his case was again placed before Approval Committee. Shri Muti-ur-Rehman stated that he has realized the Foreign Exchange of Rs. 6.23 Lakhs pending for realization and has submitted the proof of realization to ADC, Moradabad SEZ. He also stated that he has re-exported the machine to UAE amounting to Rs. 18.97 Lakhs vide Shipping Bill number 4000034 dated 31.01.2018. He also stated that he will receive the remaining Foreign Exchange of Rs. 18.97 lakhs within a week and thereafter his NFE status will be positive. He stated that only 2-3 documents are pending from the documents required for completing the exit from SEZ scheme which he will submit those documents within a week. Therefore he requested that his request may kindly be considered on file without deferring it to next Approval Committee meeting so that he does not have to travel from Dubai again for completing the formalities. The Approval Committee, after due deliberations, accepted the request of Shri Muti-ur-Rehman and directed him to submit all the documents required for Exit from SEZ Scheme. Once his request along

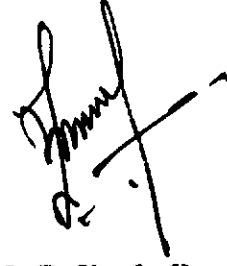
with the required documents is received in this office, the request will be considered on file.
