Minutes of meeting of the Approval Committee of Noida SEZ held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner (DC), Noida SEZ at 10.30AM on 11/11/2024 through hybrid mode.

A. The following members of the Approval Committee were present during the meeting:-

(1) Shri Surender Malik, Joint Development Commissioner, NSEZ (Nominee of Deptt. of Commerce in terms of letter dated 23/09/2008).

(2) Smt. Hemlata Hedau, Assistant DGFT, O/o Addl. DGFT, CLA, New Delhi.

(3) Shri Tanveer Singh, Income Tax Officer, Income Tax Department, Noida.

(5) Shri Vinay Kumar, Representative of New Okhla Industrial Development Authority, Noida.

B. Besides, during the meeting S/Shri (i) Kiran Mohan Mohadikar, Deputy Development Commissioner, NSEZ, (ii) Ravikesh Tripathy, Specified Officer, NSEZ, (iii) Pramod Kumar, Assistant Development Commissioner, NSEZ, (iv) Bharat Bhushan, Assistant, Project Section, NSEZ and (v) Rajeev Kumar, JE, UPPCL were also present to assist the Approval Committee. It was informed that the stipulated quorum for holding the meeting was available and meeting could proceed.

C. At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda were taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the units, following decisions were unanimously taken:-

D. Item wise decisions on proposals included in agenda:

(1) Ratification of Minutes of last meeting of the Approval Committee held on 28/10/2024.

It was informed to the Approval Committee that there were neither any references nor objections against the decisions of the Approval Committee held on 28/10/2024. Hence, the Approval Committee took



note of the same and accordingly, the Minutes of the meeting held on 28/10/2024 were unanimously ratified by the Approval Committee.

(2) R.A. International - Change in partners and profit/loss share ratio of unit.

2.1 Shri Dinesh Verma, partner and Shri Mahesh Kumar Verma, new partner appeared before the Approval Committee and explained the proposal. It was informed to the Committee that unit was required to submit APR for the year 2023-24, currently prevailing ITC(HS) Code of the authorized operations and Bio-data of new partner.

2.2 The Approval Committee discussed the agenda in detail and after due deliberations, took note of change in partners and profit/loss share ratio of firm in terms of Instruction No. 109 dated 18/10/2021. The Approval Committee further directed EM Division, NSEZ to examine the matter regarding levy of transfer charges in respect of change in profit and loss ratio pattern, as per the decision of Noida SEZ Authority. This approval would be subject to submission of documents/ information observed in file/agenda note, by the unit.

(3) Continental Hardware Private limited - Change in Directors and shareholding pattern of unit.

3.1 It was informed to the Committee that unit is required to submit APR for the year 2023-24, PAN, residential address proof and bio-data of new director.

3.2 The Approval Committee discussed the agenda in detail and after due deliberations, took note of change in director and shareholding pattern of the company in terms of Instruction No. 109 dated 18/10/2021. The Approval Committee further directed EM Division, NSEZ to examine the matter regarding levy of transfer charges in respect of change in shareholding pattern, as per the decision of Noida SEZ Authority. This approval would be subject to submission of documents/ information observed in file/agenda note, by the unit.

(4) Maharishi Ayurveda Products Private Limited - Inclusion of additional authorized operations in LOA.

4.1 No one from the unit appeared before the Approval Committee. It was informed to the Approval Committee that some of the HS Codes of



goods proposed to be traded for proposed additional authorized operations do not appear to be correct. Further, unit had also not submitted APR for the year 2023-24.

4.2 The Approval Committee discussed the agenda in detail and after due deliberations, approved the proposal of unit for inclusion of proposed additional authorized operations in LOA. This approval would however be subject to submission of revised & correct HS Code of proposed items, APR for the year 2023-24 and other documents/information as observed in File/Agenda note.

(5) Dilmaz Exports - Monitoring of performance.

5.1 Shri Sushil Jain, partner appeared before the Approval Committee and explained the proposal.

5.2 The Approval Committee monitored the performance of unit and noted achievement of positive NFE Earnings and prescribed value addition by the unit during previous block of five years from 2019-20 to 2023-24. The Approval Committee also noted that no export proceeds have been shown pending for realization as on 31/03/2024.

The meeting ended with a vote of thanks to the Chair.
