



## नौएडा विशेष आर्थिक क्षेत्र

(दिनांक 15/04/2025 को आयोजित अनुमोदन समिति की बैठक का कार्यवृत्त)

### Minutes of meeting of the Approval Committee of Noida SEZ held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner (DC), Noida SEZ at 12.00 Noon on 15/04/2025 through hybrid mode.

**A.** The following members of the Approval Committee were present during the meeting:-

- (1) Shri Surender Malik, Joint Development Commissioner, NSEZ (Nominee of Department of Commerce in terms of letter dated 23/09/2008).
- (2) Shri Saibal Roy, Assistant Commissioner, Customs, Noida Commissionerate.
- (3) Ms. Anjali Meena, Tax recovery Officer, Income Tax Department, Noida.
- (4) Shri Vinay Kumar, Representative of New Okhla Industrial Development Authority, Noida.

**B.** Besides, during the meeting S/Shri (i) Noman Hafiz, Deputy Development Commissioner, NSEZ, (ii) Vinay Malik, Appraiser, NSEZ, (iii) Pramod Kumar, Assistant Development Commissioner; and (iv) Bharat Bhushan, Assistant, Project Section, NSEZ were also present to assist the Approval Committee. It was informed that the stipulated quorum for holding the meeting was available and meeting could proceed.

**C.** At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the units, following decisions were unanimously taken:-

#### **D. Item wise decisions on proposals included in agenda:**

##### **(1) Ratification of Minutes of last meeting of the Approval Committee held on 28/03/2025.**

It was informed to the Approval Committee that there were neither any references nor objections against the decisions of the Approval



Committee held on 28/03/2025. Hence, the Approval Committee took note of the same and accordingly, the Minutes of the meeting held on 28/03/2025 were unanimously ratified by the Approval Committee.

**(2) Skypulse Innovations India Private Limited - Setting up of new unit in NSEZ.**

2.1. Shri Som Dutt Sharma, Director & Shri Vadim Luminov, Project Director of the applicant unit virtually joined the meeting and explained the proposal.

2.2. The Approval Committee discussed the agenda in detail and after due deliberations, "*in-principle*" approved the proposal of the applicant subject to submission of required documents /information by the applicant, including updated 8 digit ITCHS Codes of inputs and finished products duly mentioned in manufacturing process flow chart. The Approval Committee further empowered DC, NSEZ to take final decision on file for issuance of LOA.

**(3) Eclat Ornaments Private Limited - Decision of taking the date of commencement of production on records .**

3.1. The Approval Committee discussed the agenda in detail and after due deliberations decided to take note of the date of commencement of production of the unit as 14/11/2023 [date of Bill of Entry for Home consumption (Zone to Zone transfer)] and accordingly validate their LOA for five years.

3.2 Simultaneously, the Committee directed to check whether supplies made by unit under Chapter 71 were allowed to M/s Srikaram Prescience Private Limited, a FTWZ unit in Arshiya Northern FTWZ Ltd. Besides, the Approval Committee also directed the unit to submit its APR for 2023-24 immediately and avoid such delay in submission of APRs, failing which action under FT(D&R) Act, 1992 may be taken against the unit.

**(4) Sara Trans Industries- Permission for DTA sale of trading goods in DTA.**

4.1 Shri Jasbir Singh, Partner of the unit attended the meeting and explained the proposal. He informed the Committee that recent tariff changes being imposed by the United States had adversely affected

their exports and weakened their ability to conduct business with this key market. As a result, their export shipments to the USA had been halted by their buyers and by the OEM equipment manufacturers in Asia, Europe, who supply to USA, significantly impacting their revenue streams. He further informed the Committee that they have been receiving numerous queries and orders from DTA clients who are eager to purchase their products against payments in foreign exchange, which is in full compliance with the SEZ regulations.

4.2 The Approval Committee was informed that keeping in view the urgency shown by unit, one time approval has been granted with the approval of DC, NSEZ on file for DTA sale of trading goods under HS Codes **4202, 8471 (except 84713010, 84713090, 84714110, 84714120, 84714190, 84714900, 84715000)**, **8518, 8543 (except 85434000, 85437091)**, **8544, 9202, 9205, 9206, 9207, 9209** against payment in foreign currency, subject to ratification by Approval Committee, vide letter dt. 15.04.25.

4.3 The Approval Committee discussed the agenda in detail and after due deliberations, approved inclusion of trading goods falling under ITCHS Code **4202, 8471** and **8543** as additional authorised operations in LOA and allowed DTA sale of Trading goods falling under HS Codes **4202, 8471, 8518, 8543, 8544, 9202, 9205, 9206, 9207, 9209** against payment in foreign currency, subject to the following conditions:-

- i. No items falling under 'Restricted' / 'Prohibited' category of ITC HS policy of DGFT for import & export, shall be allowed for trading.
- ii. The unit shall maintain positive NFE as prescribed under rule 53 of SEZ Rules, 2006 separately in respect of manufacturing and trading.
- iii. The unit shall submit APRs for FY 2022-23 & 2023-24, immediately.

4.4 Besides, Approval Committee ratified the one-time permission dt. 15.04.25 granted for DTA sale of trading goods as mentioned in para 4.2 above.

#### **(5) Proposal of M/s Royal Exports for release of precious**

**metal/diamonds' stock purchased by M/s Royal Exports from M/s Global Diamonds Private Limited (referred to as M/s GDPL) and adjudication of show cause notice dated 28.01.2025 issued to M/s GDPL.**

5.1. Shri Sanjay Srivastava representative of M/s Global Diamonds Private Limited physically appeared before the Approval Committee and explained his case. He informed the Committee that they have received partial payment from M/s Royal Exports and the remaining payment would be received once the diamonds/diamonds jewellery stock presently withheld by NSEZ Customs is released. He confirmed before the Committee that M/s GDPL does not have any objection if the diamonds/diamond jewellery are released by NSEZ Customs subject to export by M/s Royal Exports.

5.2 Shri Ramchander Soni and Shri Manoj Kumar Soni, Partners also physically appeared before the Approval Committee on behalf of M/s Royal Exports and requested to release their diamonds/diamonds' jewellery withheld by NSEZ Customs, This was for the purpose of utilising it for manufacturing of diamond studded gold jewellery for export only.

5.3 The Approval Committee discussed the agenda in detail and after due deliberations taking into account the legal opinion given by YP-Legal of NSEZ and Shri Saurabh Thomas George, advocate on behalf of M/s Surana and Surana International Attorneys (legal firm/legal retainer engaged by NSEZ). Both the opinions were that there was no duty liability on the said transactions of diamonds/precious material happened between M/s GDPL and M/s Royal Exports subject to condition that the said precious material/diamonds are/have been used for manufacturing of jewellery by M/s Royal Exports which are finally exported. Accordingly the Approval Committee directed the Specified Officer to release the withheld diamonds/jewellery of M/s Royal Exports only for exporting abroad after undertaking necessary manufacturing activities, as per SEZ/Customs provisions without being sold in DTA.

5.4 Further the Approval Committee, after giving hearing to the representative of M/s GDPL, adjudicated the SCN dt. 28.01.25 issued to M/s GDPL and imposed a fiscal penalty of Rs. One lakh on M/s GDPL

under section 11(2) of FT(D&R) Act, 1992. This was for carrying out unauthorised transactions and for failing to remit the exemptions availed on the stock available with them and selling those goods to another SEZ entity, when GDPL's LOA was already cancelled. This was in contravention of the statutory provisions of SEZ Act, 2005 and rules made thereunder. The Approval Committee empowered DC, NSEZ for issuance of adjudication order to M/s GDPL accordingly.

The meeting ended with a vote of thanks to the Chair.
