**Minutes of meeting of the Approval Committee of Noida SEZ held under the Chairmanship of Shri Deen Bandhu Singh, Development Commissioner (DC), Noida SEZ at 11:30 AM on 22/12/2025 through hybrid mode.**

A. The following members of the Approval Committee were present during the meeting:-

(1) Shri Paras Mani Tripathi, Jt. Development Commissioner, NSEZ (Nominee of Deptt. of Commerce in terms of letter dated 23/09/2008).

(2) Shri Saibal Roy, Asstt. Commissioner, Customs, Noida Commissionerate.

(3) Smt. Alka Mishra, Income Tax Officer, Income Tax Deptt., Noida.

B. Besides, during the meeting S/Shri (i) Kiran Mohan Mohadikar, Dy. Development Commissioner, NSEZ; (ii) Ravikesh Tripathy, Specified Officer, NSEZ; (iii) Amir Eqbal, Asstt. Development Commissioner; (iv) Rajneesh Kumar, Appraiser, NSEZ (v) Bharat Bhushan, Assistant, NSEZ; and (vi) Kuldeep Singh, Preventive Officer, NSEZ were also present to assist the Approval Committee. It was informed that the stipulated quorum for holding the meeting was available and meeting could proceed.

C. At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda were taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the units, following decisions were unanimously taken:-

**D. Item wise decisions on proposals included in agenda:**

**(1) Ratification of Minutes of last meeting of the Approval Committee held on 08/12/2025.**

It was informed to the Approval Committee that there were neither any references nor objections against the decisions of the Approval Committee held on 08/12/2025. Hence, the Approval Committee took note of the same and accordingly, the Minutes of the meeting held on 08/12/2025 were unanimously ratified by the Approval Committee.



**(2) Hotz Industries Limited - Renewal of LOA.**

2.1 Shri Arun Kumar Jain, Director along with Shri Ajay Goel and Shri Abinash Tripathy, Authorized representative of the company appeared before the Approval Committee and explained the proposal.

2.2 The Approval Committee observed that the unit has not been working since 2020-21. Further, unit has also not submitted any credible business plan & documents in support of their project.

2.3 The Approval Committee discussed the agenda in detail and after due deliberations, directed to issue an SCN as to why their LOA should not be cancelled as per Section 16 of SEZ Act, 2005 read with rule 6(B) of SEZ Rules 2006 for non-performance during last five years.

**(3) Oritex Exports LLP - Monitoring of Performance.**

3.1 The Approval Committee monitored the performance of the unit in terms of Rule 54 of SEZ Rules, 2006 and noted failure to achieve positive NFE Earnings by the unit during 1<sup>st</sup> block (23.06.2020-22.06.2025) to the tune of Rs. 39.69 Lakhs on the basis of APRs submitted upto 22.06.2025. The Approval Committee also noted that no foreign exchange realization has been shown pending as on 31.03.2024.

3.2 The Approval Committee discussed the agenda in detail and after due deliberations, decided to regularize the shortfall in NFE Earnings in terms of Rule 80 of SEZ Rules, 2006 and imposed a penalty of Rs. 39,690/- @ 1% of shortfall in FOB value of exports i.e. Rs. 39.69 Lakhs.

3.3 The Approval Committee further observed that unit has made exports of Rs. 1 Crore during 2025-26 and keeping in view the same empowered DC, NSEZ for renewal of LOA for second block of five years subject to payment of penalty by the unit.

**(4) Harsh Industries - Inclusion of additional authorized operations in LOA.**

4.1 The Approval Committee discussed the agenda in detail and after due deliberations, approved the proposal of unit for inclusion of Manufacturing of 'Nicotine Pouches (24049100)(9331200 pouches/annum)' as additional authorized operations in LOA of unit.

**(5) PJS Overseas Limited - Change of name and change in directors & shareholding pattern of company.**

5.1 The Approval Committee discussed the agenda in detail and after due deliberations, took note of the change of name of company from 'PJS Overseas Limited' to 'Sadashiva Overseas Limited' along with change in directors & shareholding pattern of the company in terms of Instruction No. 109 dated 18/10/2021.

**(6) Bullet International - (i) Monitoring of performance and (ii) Request for final exit from SEZ Scheme and transfer of assets & liabilities including building at Plot No. 187,188,189, NSEZ to M/s. GSR Industries.**

6.1 The Approval Committee observed that as per APRs submitted upto 2015-16, unit has achieved positive NFE Earnings of Rs. 73.50 Lakhs. The Approval Committee further observed that the performance of unit was earlier monitored by the Approval Committee in its meeting held on 04.10.2022 and NSEZ Customs has also issued NOC on 23.01.2015.

6.2 It was informed that the Approval Committee in its meeting held on 04/10/2022 had granted in-principle approval to M/s Bullet International for exit & transfer of assets & liabilities including building at Plot No. 187,188,189, NSEZ to M/s. GSR Industries, under Rule 74A of SEZ Rules, 2006, subject to (i) fulfilment of exit formalities (ii) payment of applicable transfer charges (iii) submission of an undertaking by transferee reg. taking over the assets and liabilities of transferor. The in-principle approval for exit and transfer & assets & liabilities under Rule 74 read with 74A was issued to the unit vide this office letter dated 27.10.2022. Now, the unit has completed the exit formalities and the transferee has also submitted undertaking reg. taking over the assets and liabilities of transferor.

6.3 The Approval Committee discussed the agenda in detail and after due deliberations, decided to grant final approval for transfer of assets & liabilities including building at Plot No. 187, 188, 189, NSEZ to M/s. GSR Industries in terms of Rule 74A of SEZ Rules, 2006.

**(7) Sunglass Palace Pvt. Ltd. - (i) Monitoring of performance, (ii) extension of LOA to file online application; and (iii) Request for final exit from SEZ Scheme and transfer of assets & liabilities including building at Plot No. 129G/64, NSEZ to M/s. Elite Basket Pvt. Ltd.**

7.1 The Approval Committee monitored the performance of unit and





noted achievement of positive NFE Earnings of Rs. 41.95 Lakhs and Rs. 169.96 Lakhs during second block and third block respectively on the basis of APRs submitted upto 30.09.2025. The Approval Committee also noted that no foreign exchange has been shown pending for realization.

7.2 It was informed that the Approval Committee in its meeting held on 14/10/2024 had granted in-principle approval to M/s. Sunglass Palace Pvt. Ltd. for exit & transfer of assets & liabilities including building at Plot No. 129G/64, NSEZ to M/s. Elite Basket Private Limited. This is subject to (i) fulfilment of exit formalities by transferor (ii) payment of applicable transfer charges and (iii) submission of an undertaking by transferee regarding taking over the assets and liabilities of transferor. The in-principle approval for exit and transfer & assets & liabilities under Rule 74 read with 74A was issued to the unit vide this office letter dated 11.11.2024. Now, the unit has completed the exit formalities and the transferee has also submitted undertaking reg. taking over the assets and liabilities of transferor.

7.3 The Approval Committee discussed the agenda in detail and after due deliberations, decided to grant final approval for transfer of assets & liabilities including building at Plot No. 129G/64, NSEZ to M/s. Elite Basket Pvt. Ltd. in terms of Rule 74A of SEZ Rules, 2006.

### **Decision on Supplementary Agenda**

#### **(8) Monitoring of Performance.**

Following cases for monitoring of performance / APRs under Rule 54 of SEZ Rules, 2006 were placed before the Approval Committee. The unit wise decisions are indicated below:-

#### **8.1 Shinpak Overseas Exports:**

8.1.1 It was informed that unit has informed that they have not done any trading activity during previous block of five years.

8.1.2 The Approval Committee monitored the performance of the unit on the basis of APRs from 2020-21 to 2023-24 and noted achievement of positive NFE Earnings during 3<sup>rd</sup> block (18.08.2020-17.08.2025). The Approval Committee further observed that as per ICEGATE data, unit has made exports worth Rs. 273.88 Lakhs during 2024-25. The Approval Committee also noted that no foreign exchange has been shown pending for realization as on 31.03.2024.

#### **8.2 Ebix Technologies Limited (Unit-II):**



8.2.1 The Approval Committee monitored the performance of the unit on the basis of APRs from 2020-21 to 2023-24 and noted achievement of positive NFE Earnings during 2<sup>nd</sup> block (30.09.2020-29.09.2025). The Approval Committee further observed that as per ICEGATE data, unit has made exports worth Rs. 1474.98 Lakhs during 2024-25. The Approval Committee also noted that no foreign exchange has been shown pending for realization as on 31.03.2024.

8.2.2 The Approval Committee also observed that LOA of the unit has expired on 29/09/2025 and directed to issue a reminder to unit for submission of application of renewal of LOA.

### **8.3 Crystal Hues Limited:**

8.3.1 The Approval Committee monitored the performance of the unit on the basis of APRs from 2020-21 to 2024-25 and noted achievement of positive NFE Earnings during 3<sup>rd</sup> block (11.10.2020-10.10.2025). The Approval Committee further observed that as per ICEGATE data, unit has not made any exports during 2024-25. The Approval Committee also noted that no foreign exchange has been shown pending for realization as on 31.03.2025.

8.3.2 The Approval Committee also observed that LOA of the unit has expired on 10/10/2025 and directed to issue a reminder to unit for submission of application of renewal of LOA.

### **8.4 Cenit Inc.:**

8.4.1 The Approval Committee monitored the performance of the unit on the basis of APRs from 2019-20 to 2023-24 and noted achievement of positive NFE Earnings during 4<sup>th</sup> block (26.09.2020-25.09.2025). The Approval Committee further observed that as per ICEGATE data, unit has made exports worth Rs. 257.56 Lakhs during 2024-25. The Approval Committee also noted that no foreign exchange has been shown pending for realization as on 31.03.2024.

### **8.5 Shree Namo Alloys:**

8.5.1 The Approval Committee monitored the performance of the unit on the basis of APRs from 2019-20 to 2023-24 and noted achievement of positive NFE Earnings during 4<sup>th</sup> block (02.01.2020-01.01.2025). The





Approval Committee further observed that as per ICEGATE data, unit has not made any exports during 2024-25. The Approval Committee further observed that foreign exchange of Rs. 3.79 Lakhs & Rs. 4.10 Lakhs have been shown pending for realization during 2019-20 & 2020-21. The Approval Committee directed the unit to submit current status of the foreign exchange pending for realization.

### **8.6 Prabhat Zarda Factory (Overseas):**

8.6.1 The Approval Committee monitored the performance of the unit on the basis of APRs from 2019-20 to 2023-24 and noted achievement of positive NFE Earnings during current 2<sup>nd</sup> block (19.01.2022-18.01.2027). The Approval Committee further observed that as per ICEGATE data, unit has made exports worth Rs. 1460.10 Lakhs during 2024-25. The Approval Committee further observed that foreign exchange of Rs. 150.03 Lakhs has been shown pending for realization during 2023-24. The Approval Committee directed the unit to submit current status of the foreign exchange pending for realization.

8.6.2 The Approval Committee also observed that LOA of the unit has been renewed for shorter period up to 31.12.2025 during current 2<sup>nd</sup> block of five years. The Approval Committee directed to examine the request of unit for renewal of LOA on file.
