



Minutes of the meeting of Approval Committee, NSEZ held on 23/09/2024**नोएडा विशेष आर्थिक क्षेत्र**

(दिनांक 23/09/2024 को आयोजित अनुमोदन समिति की बैठक का कार्यवृत्त)

Minutes of meeting of the Approval Committee of Noida SEZ held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner (DC), Noida SEZ at 10.30AM on 23/09/2024 through hybrid mode.

A. The following members of the Approval Committee were present during the meeting:-

- (1) Shri Surender Malik, Joint Development Commissioner, NSEZ (Nominee of Deptt. of Commerce in terms of letter dated 23/09/2008).
- (2) Shri Jagdish Chander, Assistant DGFT, O/o Addl. DGFT, CLA, New Delhi.
- (4) Shri Ranveer Singh, Income Tax Officer, Income Tax Department, Noida.
- (5) Shri Vinay Kumar, Representative of New Okhla Industrial Development Authority, Noida.

B. Besides, during the meeting S/Shri (i) Kiran Mohan Mohadikar, Deputy Development Commissioner, NSEZ, (ii) Ravikesh Tripathy, Specified Officer, NSEZ, (iii) Pramod Kumar, Assistant Development Commissioner, NSEZ, (iv) Bharat Bhushan, Assistant, Project Section, NSEZ and (v) Rajeev Kumar, JE, UPPCL, Noida were also present to assist the Approval Committee. It was informed that the stipulated quorum for holding the meeting was available and the meeting could proceed.

C. At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda were taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the units, following decisions were unanimously taken:-

D. Item wise decisions on proposals included in agenda:

(1) Ratification of Minutes of last meeting of the Approval Committee held on 09/09/2024.

It was informed to the Approval Committee that there were neither any

references nor objections against the decisions of the Approval Committee held on 09/09/2024. Hence, the Approval Committee took note of the same and accordingly, the Minutes of the meeting held on 09/09/2024 were unanimously ratified by the Approval Committee.

(2) Avisor India Pvt. Ltd. - Ratification of permission granted for updation of production capacity and monitoring of performance..

2.1 Shri Avdhesh Kushwaha and Shri Sameer Narang, Directors of the unit appeared before the Approval Committee and explained the proposal.

2.2 The Approval Committee discussed the agenda in detail and after due deliberations, ratified the permission granted for updation of production capacity. The Approval Committee also monitored the performance of unit and noted achievement of a positive NFE by the unit from 01.04.2018 to 31/03/2023. The Approval Committee also noted that no export proceeds were pending for realization as on 31/03/2023.

(3) P Mittal Manufacturing Private Limited - Amendment in description & ITC(HS) Code of authorized operations and inclusion of additional items in LOA.

3.1 Shri Manoj Arora, Shri A.K. Thakur and Shri Rampal Singh, authorized representatives appeared before the Approval Committee and explained the proposal. The Approval Committee observed that some of the proposed HS Codes either do not appear to be correct or do not exist. Further, no export/ deemed export were available in the NSDL data in line with submitted APRs.

3.2 Shri Thakur informed that they did not do any physical export till date. The unit made supplies to other SEZ units and DTA units.

3.3 The Approval Committee discussed the agenda in detail and after due deliberations, approved the proposal for amendment in description & ITC(HS) Code of authorized operations and inclusion of additional items in LOA. This is subject to submission of correct HS Codes & production capacity of each product. The Approval Committee further directed the unit to submit correct APRs along with details of filing at SEZonline system for DTA sale as well as supplies to other SEZ units.



Minutes of the meeting of Approval Committee, NSEZ held on 23/09/2024**(4) Idemia Syscom India Private Limited - Inclusion of additional authorized operations in LOA.**

4.1 Shri Naveen Kainth, authorized representative of the unit appeared before the Approval Committee and explained the proposal. He also informed the Committee that apart from physical export, supplies of Information Technology Agreement (ITA) were made to DTA units. These were covered under Rule 53A(i) and were counted for NFE. However, the unit claimed that there was no provision in NSDL to indicate such supplies.

4.2 The Approval Committee discussed the agenda in detail and after due deliberations, approved the proposal of unit for inclusion of additional authorized operations in LOA. This is however subject to submission of revised/correct forex balance sheet. Besides, the Committee also directed the Project Division to take up the matter reg. non reflection of supplies of ITA items made by unit against SEZ Rule 53A(i), in the NSDL data.

(5) Shinpak Overseas Exports - Inclusion of additional authorized operations in LOA and Monitoring of performance.

5.1 Shri Kanav Shingla, Partner appeared before the Approval Committee and explained the proposal.

5.2 It was informed to the Approval Committee that as per information ascertained from EM Section, NSEZ, sharing permission allowed to the unit at Plot No. 38, NSEZ is currently not valid. Besides, one of the proposed HS Code 62011290 does not exist. Besides, unit has till date not provided the Customs verified data of supplies made by unit under Rule 53A as requested in 2022.

5.3 The Approval Committee discussed the agenda in detail and after due deliberations, approved the proposal of unit for inclusion of additional authorized operations in LOA. This is subject to submission of correct HS Codes and extension of the sharing permission at Plot No. 38, NSEZ. The Approval Committee further directed the unit to submit Customs verified details of supplies made under SEZ Rule 53A as well as APR for the year 2023-24, at the earliest.

(6) Sterling Ornaments Private Limited - Amendment in

6.1 Shri Vishal Gupta, Director and Shri Prashant Srivastava, Manager appeared before the Approval Committee and explained the proposal.

6.2 The Approval Committee discussed the agenda in detail and after due deliberations, approved the proposal of unit for inclusion of manufacturing of Semi-finished Silver Jewellery (71131141) in authorized operations. This is subject to submission of a clarification on the HS Code proposed for semi finished silver jewellery.

(7) Divya Creations - Request for amendment in LOA Conditions.

7.1 Shri Sumit Gupta, Partner appeared before the Approval Committee and explained the proposal.

7.2 The Approval Committee discussed the agenda in detail and after due deliberations, decided to remove the following conditions from the LOA in respect of Gold Jewellery studded with Lab Grown Diamonds:

"(i) Unit shall maintain one on one correlation between import & export of lab grown diamonds.

(ii) Drawing of sample of the lab grown diamonds by NSEZ Customs for its testing as regard to purity/caratage."

(8) Apodictic Research LLP - Endorsement of Service Invoices and issues related to filing of Softex forms..

8.1 Shri Chinmay Regal, Partner and Shri Deepak Khanna, authorized representative of the unit appeared before the Approval Committee and explained the proposal. The Approval Committee observed that clinical trial activities and subsequent exports were an important sector of focus within the pharmaceutical space.

8.2 The Approval Committee discussed the agenda in detail and after due deliberations, gave an in principle approval for their proposal. However, this is subject to the unit submitting a write-up on the model of working of their SEZ unit especially w.r.t. services availed towards carrying out authorized operations under LOA, and its application submitted for endorsement from Specified Officer. The Approval Committee also directed Specified Officer and Project Section, NSEZ to carry out a physical inspection of unit and submit a report on the

existing infrastructure and personnel. The Committee authorised the office of Development Commissioner to examine these submissions and reports on file for granting the final approval.

8.3 The Approval Committee also observed that services being undertaken by the unit are not 'Software Services' hence filing of Softex is not required. The Committee directed the unit to ensure filing of SERF at SEZonline system and comply with all applicable directions/guidelines of RBI w.r.t. services exported as per LOA and realization of export proceeds .

Meeting ended with a vote of thanks to the Chair.
