

Minutes of meeting of the Approval Committee of Noida SEZ held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner (DC), Noida SEZ at 02:00 PM on 23/12/2024 through hybrid mode.

A. The following members of the Approval Committee were present during the meeting:-

- (1) Shri Surender Malik, Joint Development Commissioner, NSEZ (Nominee of Deptt. of Commerce in terms of letter dated 23/09/2008).
- (2) Shri Saibal Roy, Assistant Commissioner, Customs, Noida Commissionerate.
- (3) Smt. Hemlata Hedau, Assistant DGFT, O/o Addl. DGFT, CLA, New Delhi.
- (4) Shri Vivek Chaudhary, Income Tax Officer, Income Tax Deptt., Noida.
- (5) Shri Mayank Jain, Assistant Manager, DIC, Noida (Rep. of Principal Secretary, Industry, Govt. of UP.).
- (6) Shri Vinay Kumar, Representative of New Okhla Industrial Development Authority, Noida.
- (7) Shri Rajeev Kumar, JE, UPPCL, NSEZ, Noida (special invitee).

B. Besides, during the meeting S/Shri (i) Kiran Mohan Mohadikar, Dy. Development Commissioner, NSEZ, (ii) Ravikesh Tripathy, Specified Officer, NSEZ, (iii) Pramod Kumar, Assistant Development Commissioner; (iv) Bharat Bhushan, Assistant, Project Section, NSEZ were also present to assist the Approval Committee. It was informed that the stipulated quorum for holding the meeting was available and meeting could proceed.

C. At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda were taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the units, following decisions were unanimously taken:-

D. Item wise decisions on proposals included in agenda:


B-01 (H)

(1) Ratification of Minutes of last meeting of the Approval Committee held on 06/12/2024.

It was informed to the Approval Committee that there were neither any references nor objections against the decisions of the Approval Committee held on 06/12/2024. Hence, the Approval Committee took note of the same and accordingly, the minutes of the meeting held on 06/12/2024 were unanimously ratified by the Approval Committee.

(2) Gopal Aromatic Private Limited - Setting up a new unit in NSEZ.

2.1 Shri Manoj Gupta, Director and Shri Sanjay Kumar, GM Finance of the company appeared before the Approval Committee and explained the proposal. Shri Gupta informed that currently they are working from DTA. He further informed that correct ITC(HS) Code of Nicotine Pouch is 24049100.

2.2 It was informed that some deficiencies had been observed in the application, which are required to be rectified by the applicant.

2.3 The Approval Committee discussed the agenda in detail and after due deliberations, approved the proposal of M/s. Gopal Aromatic Private Limited for proposed authorized operations i.e. "Manufacturing of (i) Chewing Tobacco(24039910) (100 Tons/ annum); (ii) Filter Khaini (24039910) (20 Tons/annum); (iii) Nicotine Pouch (24049100) (10 Tons/annum)". This approval would be subject to submission of documents/ information observed in file/agenda note.

(3) Sayan Gems & Jewels Private Limited - Setting up a new unit in NSEZ.

3.1 It was informed to the Approval Committee that some deficiencies had been observed in the application, which were required to be rectified. Further it was informed to the Committee that no ITR/Income details had been submitted by applicant in respect of second Director/Promoter Mr. Sayan Bera and the income of the 2nd Promoter shown in agenda at page number 18 had been mistakenly reflected due to typo. The Committee took note of the typo.

3.2 Shri Saikat Bera, Director of the company appeared before the Approval Committee and explained the proposal. He informed that he

already had a unit in NSEZ namely Bera Enterprise. He further informed that currently they had export orders for Handcrafted jewellery only.

3.3 The Approval Committee discussed the agenda in detail and after due deliberations, approved the proposal of M/s. Sayan Gems & Jewels Private Limited for the following authorized operations:

“Manufacturing of -

- (i) Handcrafted Plain Silver Jewellery (71131141) (300 KGs/annum)
- (ii) Handcrafted Studded with Precious & Semi-precious Stones Silver Jewellery (71131145) (200 Kgs/annum)
- (iii) Handcrafted Plain Gold Jewellery (71131911) (500 Kgs/annum)
- (iv) Handcrafted Studded with Diamonds Gold Jewellery (71131913) (120 Kgs/annum)
- (v) Handcrafted Studded with precious & Semi-precious Stones Gold Jewellery (71131915) (240 Kgs/annum)”

This approval would be subject to submission of documents/information observed in file/agenda note.

(4) La Moda Eleganza - Review of LOA.

4.1 It was informed that LOA of the unit was expired on 24/08/2023. Further, the unit had till date not submitted fresh business plan, copy of export orders & online Form-F1 etc. in compliance with the decision of the Approval Committee held on 07/11/2023. Besides, lease rent amounting to Rs. 22,43,051/- (7 quarters) is also outstanding against the unit.

4.2 It was further informed that various allegations had been received against the unit and its promoters from different persons/complainants. Comments of different departments and agencies had been sought and the same are still awaited.

4.3 Further it was informed to the Approval Committee that the promoter Mr. Sharad Gupta vide his email dt. 20.12.2024 has informed that he was travelling to Mumbai on 23/12/24 for court appearance, hence he had requested to give the next convenient date.



4.4 The Approval Committee discussed the agenda in detail and after due deliberations, deferred the matter with a direction to send a reminder to unit as well as other departments/agencies/bank for compliance/expeditious reply on respective issues.

(5) Omnie Solutions Private Limited - Monitoring of performance.

5.1 Ms. Nidhi Maheswari, authorized representative of the unit appeared before the Approval Committee and explained the proposal. She informed that the company has built its own office at Sector-3, Noida and want to centralise all the operations. Hence, they have decided to close their unit at NSEZ.

5.2 The Approval Committee monitored the performance of unit and noted achievement of positive NFE Earnings during second block (03/02/2017-02/02/2022) and third block (upto 2024-25) of five years. The Approval Committee further noted that no export proceeds have been shown pending for realization as on date. The Approval Committee further directed to take decision on final exit request on file.

(6) MEC Global - Extension in the validity of LOA/BLUT and request to allow DTA sale of trading goods for purpose of exit.

6.1 Shri Dhanpat Ostwal and Shri K. Panday authorized representatives of unit appeared before the Approval Committee and explained the proposal. Shri Ostwal informed that they have some machineries as well as trading goods lying in their NSEZ premises which are required to be removed for completion of exit formalities. However, their LOA is valid only till 31.12.2024. He further stated that they do not have any export orders, hence, permission for removal of trading goods in DTA may be granted.

6.2 The Approval Committee discussed the agenda in detail and after due deliberations, approved the extension in the validity of LOA/BLUT for a period upto 31.03.2025 exclusively to complete exit formalities by the unit subject to condition that no fresh import/ DTA procurement shall be allowed during this extended period. The Approval Committee granted in principle approval for DTA sale of trading material in stock, procured as per LOA by unit and directed Project Section to obtain a legal opinion in the matter of DTA sale of trading goods, on mode of

payment (to be received by unit for such sale in DTA), before allowing final approval. The Approval Committee also empowered office of DC, NSEZ to take final decision on file.

(7) Natron Equipment & Spares Pvt. Ltd. - Inclusion of additional authorized operations in LOA.

7.1 Shri Kirpa Ram Sharma, director of unit appeared before the Approval Committee and explained the proposal. He informed that they have a strong customer base across multiple countries for beverage equipment and related parts, which are a part of their manufactured product range. He further stated that their orders often include multiple products and parts. By incorporating Merchant Trading, they will be able to manage all export orders from a single location, which will greatly streamline their operations.

7.2 It was informed that unit is required to submit revised forex balance sheet correctly. Besides, separate projections for trading along with consolidated projection (manufacturing & trading) also need to be submitted by the unit.

7.3 The Approval Committee discussed the agenda in detail and after due deliberations, approved the proposal of unit for inclusion of trading activities of 106 items as per list attached with agenda note. The trading activities shall be subject to following conditions:

- (i) No DTA sale of trading goods shall be allowed.
- (ii) Unit will maintain separate area earmarked for manufacturing and trading activities and maintain separate records/accounts of NFE for manufacturing and trading activities.
- (iii) NFE status for manufacturing activity and trading activity will be seen separately.
- (iv) Unit shall comply with Section 2(z)(iii) i.r.o. trading activities.

This approval would be subject to submission of documents/information observed in file/agenda note.

(8) Cadence Design Systems (India) Pvt. Ltd. - Request for IGST exemption for electrical connection Infrastructure against increased power load.

8.1 Shri Prawin Kumar, authorized representative of the unit appeared before the Approval Committee and explained the proposal. He informed that they had requested PVVNL/UPPCL for increasing the electricity load for their unit located at Plot No. 57ABC, 10 & 11, NSEZ, Noida, UP-201 305 from existing 2,900 KVA to 3,900 KVA which is approved by the electricity department. However, Bhangel Extension Substation as the NSEZ substation doesn't have the infrastructure for the same. He further stated that they are opting for getting the work done through their contractor under PVVNL/UPPCL supervision and the work is also awarded to a contractor for the same and the work estimated cost is approx. INR 4.55 crores excluding of IGST.

8.2 On being asked, the unit representative informed that most of the materials like cables, pipes, poles, jointers etc. would be installed outside NSEZ but solely for the electrical line dedicated for their unit located inside NSEZ only.

8.3 The Approval Committee discussed the agenda in detail and after due deliberations, directed the unit to submit cost bifurcation/break up of total requirement of electrical connection infrastructure within NSEZ and outside. However, given that the infrastructure outside the SEZ was used only for the purposes of SEZ operations, the UAC felt that there was merit in treating it accordingly in terms of concessions. It was decided to forward the proposal to DOC with the above recommendation of the UAC for their consideration.

Supplementary Agenda:

(9) Sequel Alloys & Wires Pvt. Ltd. - inclusion of additional authorized operations in LOA.

9.1 Shr Asit Kumar, Director appeared before the Approval Committee and explained the proposal. He informed that Copper Sulphate crystals/powder is generated during manufacturing process of Copper Clad Steel. As this is a by-product and has no export potential, it would be sold in DTA. He informed the Committee that the by-product is covered under ITC HS Code 28332500.

9.2 The Approval Committee discussed the agenda in detail and after due deliberations, grant permission for sale of by-product i.e. "Copper Sulphate Crystals/Powder (28332500)" in DTA subject to compliance with all conditions applicable on such sale.

The meeting ended with a vote of thanks to the Chair.
