

Minutes of meeting of the Approval Committee of Noida SEZ held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner (DC), Noida SEZ at 02:00 PM on 28/04/2025 through hybrid mode.

A. The following members of the Approval Committee were present during the meeting:-

- (1) Shri Surender Malik, Joint Development Commissioner, NSEZ (Nominee of Deptt. of Commerce in terms of letter dated 23/09/2008).
- (2) Shri Saibal Roy, Assistant Commissioner, Customs, Noida Commissionerate.
- (3) Ms. Anjali Meena, Tax Recovery Officer, Income Tax Department, Noida.
- (4) Shri Vinay Kumar, Representative of New Okhla Industrial Development Authority, Noida.

B. Besides, during the meeting S/Shri (i) Kiran Mohan Mohadikar, Deputy Development Commissioner, NSEZ, (ii) Ravikesh Tripathy, Specified Officer, NSEZ, (iii) Pramod Kumar, Assistant Development Commissioner; and (iv) Bharat Bhushan, Assistant, Project Section, NSEZ were also present to assist the Approval Committee. It was informed that the stipulated quorum for holding the meeting was available and meeting could proceed.

C. At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the units, following decisions were unanimously taken:-

D. Item wise decisions on proposals included in agenda:

(1) Ratification of Minutes of last meeting of the Approval Committee held on 15/04/2025.

It was informed to the Approval Committee that there were neither any references nor objections against the decisions of the Approval Committee held on 15/04/2025. Hence, the Approval Committee took note of the same and accordingly, the Minutes of the meeting held on 15/04/2025 were unanimously ratified by the Approval Committee.

(2) Amiga Informatics Private Limited – Request for taking DCP on records.

2.1. Shri Dhananjay Pratap Singh, Director of unit virtually joined the meeting and



requested to take the DCP on records. However, he could not give satisfactory answers to the questions put by the Approval Committee to him regarding services provided by the unit against its first Invoice dated 17/01/2025 and other relevant questions w.r.t. implementation of LOA issued to the unit.

2.2. The Approval Committee discussed the agenda in detail and after due deliberations, directed the unit to submit following documents / information at the earliest :-

- i. Reasons for not implementing the business plan for proposed investment of Rs. 0.64 crores submitted at the time of last extension in LOA validity and reasons for not procuring the goods required for implementation of unit, within 10 days / one month after grant of last extension of LOA by the BoA conveyed to the unit vide this office letter dated 20/08/2024.
- ii. What is the exact nature of services provided to 'Genesys India Business', as mentioned in export Invoice dated 17/01/2025.
- iii. What was the employee strength of the unit at the time of DCP.

2.3. The Approval Committee further empowered office of DC, NSEZ to take final decision on file, with the approval of DC, upon receipt of aforesaid information from the unit.

(3) Karna Kusuma Enterprises LLP- Ratification of LOA extension

3.1. Shri Samir Khosla, Partner of the unit appeared before the Approval Committee and explained the matter.

3.2. The Approval Committee discussed the agenda in detail and after due deliberations, ratified the decision taken by DC on file for condonation the delay in submission of acceptance of terms & conditions of LOA and extension of LOA of unit upto 20.04.2025 conveyed to the unit vide letter dated 09/04/2025.

(4) Cenit INC – Ratification of the permission for one time export.

4.1. The Approval Committee discussed the agenda in detail and after due deliberations, ratified the permission granted by DC on file for one time export issued vide letter dated 28/02/2025. Besides, the Approval Committee directed the unit to submit consolidated details of authorised operations along with updated ITC HS code as already requested from office of DC, NSEZ from time to time.

(5) Digiflex India Limited - Ratification of letter dt. 10.03.2025 issued to M/s Knitpro International regarding transfer of assets & liabilities.

5.1. The Approval Committee discussed the agenda in detail and after due

deliberations, ratified the letter issued vide letter dated 10/03/2025 for transfer of assets and liabilities pertaining to LOA dated 05/01/1989 of M/s. Digiflex India Limited in favour of LOA dated 22/05/2013 of M/s. Knitpro International.

(6) Suprajit Engineering Limited–Ratification of the One time permission for removal of unutilised imported goods in DTA.

6.1. The Approval Committee discussed the agenda in detail and after due deliberations, ratified the one time permission granted vide letter dt. 21.02.2025 for removal of unutilised imported goods in DTA.
