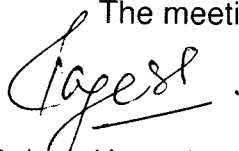

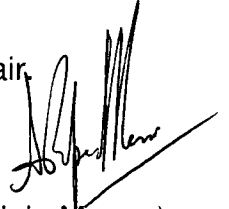
2.4 After due deliberation the Approval Committee approved the list of goods worth Rs. 721.55 lacs for authorized operations of the Co-Developer.
