**2.3 (16) Proposal for setting up 100% EOU by M/s E-Waste Recycler of India, Khasra No. 266, 100 KM Stone, Mauza-Gohari, Tehsil-Chatta, Mathura, U.P.**

The Committee deliberated the proposal and noted that the jurisdictional Central Excise vide its letter C. No. V(30)08/Tech/Misc/2015/2007 dated 11.03.2016 have communicated as under:-

*“As desired, a detailed verification report in respect of premises and Directors along with recommendation for setting up of 100% EOU is as under:*

- (i) *That the place of address, as given in enclosed application, was visited several times by the Range Officer but gate of the premises was found locked.*
- (ii) *The Range Officer again visited at said address on 22.02.2016, Shri Indraj S/o Shri Ram Ji Lal aged about 45 years was present and disclosed his identity as gate keeper of the premises. On being asked about the name of the unit, responsible persons of the unit and its proprietor/directors, he informed that he knows nothing about name of the unit and their owners but he acknowledged the address. So, he could not give any desired information.*
- (iii) *Not only this, some persons, who were available nearby the premises, were also asked in this regard. They replied that they have not heard the name of this unit & their owners and no any activities done in the factory premises is noticed since long. On having entranced in the premises, it's found that the said factory building is very old and broken condition, there is no electric connection and also no plant and machineries were available.*
- (iv) *Due to non-availability of authorized/responsible person, it could not be gather information regarding Director/ownership of the factory premises.*

*In view of the above, setting up of unit under 100% EOU scheme may please be discouraged to avoid the fraudulent activities of the unit, if any.”*

Further the unit has not complied with the deficiencies pointed out to them. Although the proprietor of the firm was contacted and asked to attend the UAC meeting, as the case was listed, nobody appeared for the meeting.

In view of above facts the Committee has decided to reject the proposal.
