**OFFICE ORDER****Subject: Formation of Committee for Disaster Management (CDM)**

In pursuance of the need for effective disaster management and response, it has been decided to form a Committee for Disaster Management (CDM) at NSEZ. .

The committee will comprise the following officers:

1. Joint Development Commissioner – Chairman
2. Deputy Development Commissioner - Member
3. Representative of National Disaster Response Force (NDRF) – Member
4. Any other Member who may be co-opted with the consent of the Chairman

The primary objective of the Committee for Disaster Management is to develop, implement, and oversee disaster management strategies, ensuring the safety and well-being of all personnel within the organization.

The roles and responsibilities of the committee members are outlined as follows:

**Joint Development Commissioner (Chairman):**

- Provide leadership and direction to the Committee.
- Oversee the development and implementation of disaster management plans.
- Coordinate with relevant authorities and agencies for effective disaster response.

**Deputy Development Commissioner (Member):**

- Assist the Chairman in the overall functioning of the Committee.
- Contribute to the formulation of disaster management policies and procedures.
- Liaise with other departments to ensure the integration of disaster management practices.

**Representative of NDRF (Member):**

- Provide expertise on disaster response and recovery.
- Collaborate with the NDRF and other relevant agencies to enhance preparedness.
- Offer guidance on best practices for disaster risk reduction.

**Co-opted Member (with consent of Chairman):**


- Bring specialized knowledge or expertise relevant to disaster management.
- Collaborate with other members to contribute valuable insights and recommendations.

This Committee for Disaster Management is empowered to convene meetings,

This issues with the approval of Development Commissioner, NSEZ.


