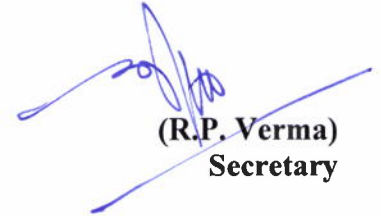
1. The tenderer should have at least three (3) years of experience in the **"tour and travel"** business in providing vehicles for at least 2 years in Government/PSU organizations.
2. Only such transporter/agency/individual may apply whose Taxis have been duly authorized by the concerned RTO.
3. At least two Satisfactory Service Certificate from Government Departments/ public Sector Undertakings/ Autonomous Bodies under Government of India where the bidder has provided taxi hiring service.
4. The vehicles should be insured comprehensively and should have necessary permits from the Transport Department/Authority for commercial use.
5. During the contract period, if the vehicle is seized / detained / impounded by the Police/ Transport Authority for any reason whatsoever, it would be at sole risk/ expenditure/ responsibility of the transporter/individual/agency. During the period detained/ repair alternative vehicle shall be provided.
6. All expenses related to repairs and maintenance etc. shall be borne by the agency/transporter/individual.
7. Charges for hiring of vehicle are fixed for 2500 KM per month and Rs.../- (amount/rates to be mentioned by the bidder) per KM shall be paid in case limit exceeds beyond 2500 KM.
8. Bidder must submit Earnest money deposit (EMD) of Rs. Ten thousand in the form of DD in favour of "Noida SEZ Authority" payable at Noida along with the "Technical Bid"

9. The vehicles to be provided should not be more than 3 years old. The vehicles shall be kept in good running condition and it will have clean upholstery with white covers and other accessories of the vehicles will also be kept in good condition preferably white or silver color. Vehicle with damaged body due to accidents etc will not be acceptable.
10. Change of vehicles/drivers will be allowed only in exceptional circumstances and that too with the prior approval/intimation.
11. The rates quoted in the quotation shall remain fixed for one year and subsequent 2 years if Competent Authority renew this service from same vendor.
12. Work kilometers shall be calculated from the duty point.
13. The payment shall be made against monthly running bills submitted along with log book and as verified by the Security Officer subject to satisfactory performance.
14. The Authority will not be responsible for any challan, loss, damage, injury, accident etc. to the vehicle or to any other vehicle.
15. The service provider has not been convicted, and has not been formally investigated, in corruption/crime and
16. Has not and will not resort to bribery or any other form of corruption in the context of the perspective contract.
17. Misinformation by the supplier/service provider under clause would give NSEZ the right to cancel the contract unconditionally and immediately.
