Instruction to tenders

(1) Online percentage rate tenders are invited from experienced & eligible contractors for Supply, installation testing & commissioning of street light poles with fitting around staff quarters and laying of cable for street light from feeder pillars to various location at NSEZ, Noida.

(2) The estimated cost of work is Rs.20,07,820/-

(3) The tender documents as uploaded can be seen on website www.tenderwizard.com / NSEZ or CPP Portal

(4) **Bid Security**

Bid security of Rs. 40,000/- to be submitted By demand draft drawn in favour of NSEZ Authority payable at Noida.

The original draft to be submitted along with Hard Copy of Technical Bid and a Photocopy to be uploaded with online tender.

(5) **Tender Fee:-** Cost of tender document is Rs.500/- A separate demand draft to be submitted drawn in favour of NSEZ authority Payable at Noida. The original demand draft to be submitted with Hard Copy of Technical Bid and a photo copy to be uploaded with online Bid.

(6) The tender documents (Both online & offline) to be submitted before last date & time of submission as mentioned in tender document.

(7) Before tendering, the tenderers are advised to visit the site.

Scope of Work

1. Supply of street light poles as per BOQ. Installation of the same at the location of existing poles.
2. Removing of existing poles with fittings, stacking of the same in SEZ Premises as per direction.
3. Dismantling of existing foundation, if required & disposal of debris outside the campus /at designated places.
4. Cost of Installation including ,concreting, nut-bolts etc. complete.
5. Supply & installation of fittings as per BOQ.
6. Laying of cable.
7. Connection with existing panel.
8. Testing & commissioning of entire system.
9. Handing over to NSEZ.
10. All warranty, guarantee to be submitted to NSEZ Authority.
11. Removal of Defects observed within Defect liability period of one year.
12. The rate includes all operation as per scope of work and nothing extra shall be paid.
13. Laying of cable as per specification in existing RCC pipes/ in trenches as per requirement.
14. Connecting with street light poles and feeder pillars as per requirement.
15. Testing and Commissioning of cable and illumination of all street lights connected with cable.
16. Making good all road , footpath , etc. dismantled during laying of cable

(9) Eligibility Criteria:-

A. The Agencies who fulfil the following minimum eligibility requirements, shall be eligible to apply.

Should have completed the works as mentioned below during the last seven years ending previous day of last date of submission of tenders.

(i) Three similar works each costing not less than 40% of the estimated cost put to tender.

OR

(ii) Two similar works each costing not less than 50% of the estimated cost put to tender.

OR

(iii) One similar work costing not less than 80% of the estimated cost put to tender.

The “Similar works” shall mean Internal/external electrical work for any Govt. organisation , PSU , Gov. institute etc..

B. Average annual financial turn over shall at least Rs. 30 lacs during last three (03) years ending on 31.03.2025.

C. Must have permanent EPF & ESIC registration

D. It should be a profit making company for last 2 years.

E. The Bidder should have a valid electrical licence.

11. Documents to be submitted (online as well as offline) in Technical Bid.

- A. List of similar works carried out by them for **Central/State Govt. Departments/Agencies indicating** i) Agency for whom executed ii) Value of Work iii) Completion time as stipulated and actual completion date. Completion certificate to be submitted as per eligibility criteria.
- B. Financial Turn Over certified by Chartered Accountant for last 03 years.
- C. Profit & Loss statement certified by Chartered Accountant for last 02 years.

- D. Registration Certificate, if any.
- E. TIN/GST registration certificate.
- F. PAN (Permanent Account Number) Registration, ESIC, EPF registration NO.
- G. Tender Fee (Original with Hard Copy & Photocopy to be uploaded online.)
- H. Bid security (Original with Hard copy & photocopy to be uploaded online).
- I. Tender acceptance letter.
- J. Valid electrical license from appropriate Authority.
- K. Technical Bid to be submitted at reception, Service centre, NSEZ Noida as per NIT

12. Financial Bid- to be submitted online as per format with BOQ. **The Bidder meeting the eligibility criteria shall only be entitled for opening of Price Bid.**

13. Tenders received without tender fee, bid security & requisite documents shall be rejected.

General Condition of Contract

1. **Security deposit:-** Security deposit shall be deducted from Bills of the contractor amounting to 3% (Three Percent) of each Bill. **The Security deposit and Bid Security** shall be released on successful completion of defect liability period.
2. **Defect-liability period:-** The contractor's defect liability period shall be 12 months, which will start from date of Handing over after successful completion of work. Any defect observed during DLP shall be rectified by the contractor at his own cost.
3. **Payment: -** The contractor will submit Bill with all desired documents & test certificate with all measurements.
4. **Taxes: -** The Income tax and other taxes as applicable shall be deducted from the Bills of the contractor.
5. **GST:-** No GST is applicable for the work executed for NSEZ authority, Noida
6. **Time Period-** Work to be completed in all respect within the given time period. In case of delay, NSEZ may enforce LD amounting to 1 (one) percent of contract value for every month of delay subject to maximum of 5 % of contract value.
7. **Termination of Work:-** If work is delayed inordinately or if contractors fails to start the work within 7 day from LOA, the client is at Liberty to terminate the work/contract. All the dues of the contractor shall be forfeited on termination. The decision of NSEZ authority shall be final & Binding on the contractor.
8. **Deviation/variation:-** The quantities given in BOQ are tentative and may vary as per site condition. There is no any deviation limit. NSEZ authority have power to make any alterations in omission from, additions to or substitution for original specification, drawing & design and the same shall be carried out by the contractor on the same rate & condition in all respect.
9. **Extra Item:-** Any extra item not included in the BOQ, shall be paid as per market rates. The contractor shall submit detail justification & rate analysis for such extra items .
10. **Specification of Work:-** The contractor to follow instruction of NSEZ authority with regard to approval of materials. The work shall be executed as per CPWD specifications. Since it is a repair work of existing system, the material used shall be as per requirement and in conformity with existing system.

11. **Safety & Insurance**:- The contractor shall be responsible to follow all safety norms. All necessary safeguard will be taken. The contractor shall also obtain suitable insurance under workmen compensation act.
12. **Labour laws**:- The contractor shall be responsible to follow all prevailing labour laws, ESIC & EPF requirements.
13. Temporary electric connection may be provided to contractor on chargeable basis. However, all materials, cable, meter etc to be arranged by contractor.
14. After completion of work, necessary testing & commissioning will be done by contractor and shall be got verified by clients before taking over.
15. Rates are firm and no escalation shall be payable.
16. Extension of time may be granted to the contractor, if work is delayed due to valid reasons.
17. Cable make:- Havells /finolex/polycab.

18. Street light poles : As per approval of NSEZ octagonal poles. 4m long (Top 70mm, Botttom 13mm, Thickness 3mm Base Plate 220 x 220 x 12mm).
