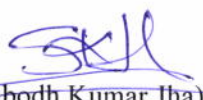
e-Tender for AMC of Data Center

The Development Commissioner Noida SEZ invites e-tenders in two bid system i.e. (1) technical bid, (2) Financial bid from reputed vendors for AMC of Data Center/ Server and other items installed at Noida Special Economic Zone as per the details given at Annexure-I.

1. Terms should be in a 2 bid system i.e. Technical bid and financial bid in e-tender module in the NSEZ Website. Technical bid and financial bid must be submitted separately.
2. EMD amounting to Rs. 25,000/- (Rupees Twenty five thousand only) in the shape of DD in favour of 'D. C. NSEZ' is required to be submitted in this office.
3. The complete address of the firm, name of the contact person along with contact numbers is required to be upload on the website.
4. The tendering firm is advised to visit the site of work at his own cost and collect all information that he considers necessary for proper assessment of the prospective assignment.
5. The items/services should be supplied at Consignee's site within 15 days from the date of issue of order for a period of One year.
6. The firm shall quote their rates in INR for each item/ all items in the annexure-I which include all taxes, transportation, labor charges, installations and nothing extra shall be paid on any account. Service tax, VAT, if any, should be mentioned clearly in rupees.
7. The Payment will be released only after final inspection of items/ services supplied at consignee's site.
8. The items used for replacement of items under AMC should have functional warranty for 1 year from the date of supply/replacement of the defective material, if noticed within the warranty period.
9. Tender duly complete in all respects should be submitted in the e-tender of module of NSEZ Website www.nsez.gov.in by 28.04.2017 up to 03.00 PM. The received Tenders will be opened on same date at 3.30 PM in the Conference room of O/o Development Commissioner, NSEZ, Noida-201305. Technical bid will be opened first and financial bid of only qualified tenderers would be opened thereafter. All bidders are required to bring all document in original along with DD of Rs. 25,000/-.
10. In case last date happens to be a Govt. holiday, then the next working day will be the date of receipt of tenders.
11. Bidder should have PAN and service Tax number.
12. Tender received after due date and time will not be entertained.
