- 4.The tendering firm is advised to visit the site of work at his own cost and collect all information that he considers necessary for proper assessment of the prospective assignment.
5. The items should be supplied at Consignee's site within 15 days from the date of issue of supply order on every 3 month. **This is valid up to 31.03.2017.**
- 6.The firm shall quote their rates in INR for each & every item used for supply of tendered items which include all taxes, transportation, labour charges, installations and nothing extra shall be paid on any account. Service tax, VAT, if any should be mentioned clearly in rupees.
- 7.The Payment will be released only after final inspection of items supplied at consignee's site only.
- 8.The material used for supply of tendered items should have functional warranty for 1 year from the date of supply/installation. The supplier will replace the defective material free of cost, if noticed within the warranty period.
- 9.Quantity quoted in tender notice is approximate.
- 10.Tender duly complete in all respects should be submitted in the e-tender of module of NSEZ Website www.nsez.gov.in by **06.10.2016 up to 03.00 PM**.
