The initial period of deputation is three years and all rules, regulations and provisions issued from time to time for deputation shall be applicable.

A Govt. Officer in a higher grade pay/ scale shall be ineligible for appointment on deputation to post in the lower grade pay/scale in terms of Deptt. of Expenditure's O.M. No. 1/1/2008-LC dt. 26.3.2009 and DOPT O.M. No. 6/8/2009-Estt (Pay II) dt. 17/6/2010.
