


## Report of Zonal NSEZ for the period 2024-25


### Merchandise Exports

The total merchandise exports from SEZs under the jurisdictions of Zonal Noida SEZ during the period 2024-25 was **Rs.26145 Crores**. The breakup of these exports was Rs.12189.9 crores through ICEGATE and Rs 13955crores through SEZonline. The SEZ wisebreakup of these exports is as under:




### Country-wise Merchandise Exports

Among the top countries of total merchandise exports during 2024-25, UAE tops the list with Rs 10,532 crores followed by US (Rs 5546 cr), Hong Kong (Rs 1370 cr), UK (Rs 1150 cr) and France (Rs 810 cr). The break up of these exports made through ICEGATE and SEZonline is as under



## Services


Services Exports from SEZs under the jurisdiction of Zonal Noida SEZ during the period 2024-25 was **Rs. 84580.4 crores**. This is a 16.8% growth from the same period last year wherein exports stood at Rs. 83657.2 crores. The breakup of services is as under:



Therefore, the total exports of goods and services from Zonal NSEZ during the period 2024-25 was **Rs 11,725.4 crores**


### Deemed Exports

The total deemed exports made by all units under Zonal NSEZ for the period 2024-25 was Rs. 344.3 crores. The SEZ wise deemed exports is as under:




### Domestic Procurement (Without Export Benefits)

The total domestic procurement (without export benefits) made by all units under Zonal NSEZ for the period 2024-25 was **Rs. 2354.5 crores**. This is a measure of sourcing of domestic inputs (for manufacturing and service units), thereby promoting the concept of “*Source from India to Make in India*”. The SEZ wise domestic procurement for the said period is as under:




### Sector-Wise Domestic Procurement (Without Export Benefits)

Within this total procurement, the top sector wise domestic procurement (without export benefits) of goods led by the engineering, gems & jewellery, pharmaceuticals, plastics and paper sector is as under:



### Domestic Procurement (With Export Benefits)

The total domestic procurement (with export benefits) made by all units under Zonal NSEZ for the period 2024-25 was **Rs. 421.9 cr.** The SEZ wise domestic procurement for the said period is as under:



Therefore, the total domestic procurement made by units in the Zonal NSEZ during the period 2024-25 was **Rs 2776.4 crores.**

### **SEZ to SEZ supplies**

The total SEZ to SEZ supplies made by all units under Zonal NSEZ for the period 2024-25 was **Rs. 514.4 crores.** (Only if entered by units in SEZ online system) The SEZ wise break up of such supplies is as under:
