## Minutes of 3<sup>rd</sup> Meeting (2013 Series) of Unit Approval Committee for EOU Scheme held under the Chairmanship of Shri Jayant Misra, Development Commissioner, NSEZ, Noida on 12.11.2013 at 04.00 PM at NSEZ, Noida.

3<sup>rd</sup> meeting (2013 Series) of Unit Approval Committee for EOU scheme (UAC) was held on 12.11.2013 under the Chairmanship of Shri Jayant Misra, Development Commissioner, Noida SEZ. The following members of UAC were present in the meeting:

The Chairman welcomed all participants of the UAC and thereafter agenda was taken up for discussion.

3.0(13) Confirmation of minutes of 2<sup>nd</sup> meeting (2013 series) of the UAC held on 06.08.2013

The Committee ratified the minutes of the 2<sup>nd</sup> UAC meeting (2013 Series).

3.1(13) Proposal for setting up a new 100%EOU by M/s. Gold Mint India Ltd. at G-1/34, Gem & Jewellery Zone EPIP, Sitapura Industrial area, Jaipur for manufacture & export Gold/Silver Bars.

The Committee deliberated the proposal. Central Excise, in its report, stated that it would be difficult to monitor disposal of waste in the absence of SION for the commodity. The Committee therefore decided to defer the proposal and make a reference to DGFT/ Department of Commerce regarding monitoring of production and the disposal of waste in view of the sensitive nature of commodity.

3.2 (13) Proposal for conversion of existing DTA unit into 100% EOU by M/s Saffire Polymers (food division) at Plot No. 7 Industrial area, Barotiwala, Distt.-Solan, H.P. for manufacture and export of ready to eat packaged food.

The Committee noted the observation of Central Excise that the Unit is availing the exemption from Central Excise Duty under Notification No. 49-50/2003-CE dated 10.6.2003 and as such is not eligible to withdraw its option during the midst of the financial year 2013-14 and convert to 100% EOU. The Committee, therefore, did not to approve the proposal.

3.3 (13) Proposal for allowing DTA sale and to dispense with the conditions of installing Injection Molding Machine from the LOP by M/s D& Y Technologies (P) Ltd., Plot No. 28, 1st Floor, Udhyog Kendra, Extension-II, Echotech—III, Greater Noida, U.P.

The Committee deliberated the proposal and agreed to dispense with the condition imposed in the LOP of installing Injection Molding Machine. As far as allowing DTA sale on payment of full duties is concerned, the Committee did not agree to the proposal in the absence of the details such as quantum of DTA sale proposed to be made, etc.

3.4 (13) Proposal for allowing DTA sale of organic chemicals under Chapter 29 of ITC (HS) manufactured by the process of "labeling" only and to allow broad-banding of the LOP by including 265 organic chemicals falling under chapter 29 of the CETA to be manufactured on job-work basis by M/s Combitic Global Caplet (P) Ltd., M-15, D-2, D-3, Industrial area, Sonepat-131001.

The Committee discussed the proposal at length and did not agree to the same.
