1.0(14) Confirmation of minutes of 3rd meeting (2013 series) of the UAC held on 12.11.2013

The Committee ratified the minutes of the 3rd UAC meeting (2013 Series).

1.1(14) Proposal for setting up a new 100%EOU by M/s. Gold Mint India Ltd. at G-1/34, Gem & Jewellery Zone EPIP, Sitapura Industrial area, Jaipur for manufacture & export Gold/Silver Bars.

The Committee deliberated the proposal and deferred the proposal since pure gold trading and medallion manufacturing has been disallowed for SEZs and a reply from DGFT is still awaited.

1.2(14) Proposal for setting up 100% EOU by M/s CH Components (P) Ltd. at Plot No. 146, Toy city Mahila Udyami Park –II, Echotech-III, Greater Noida for manufacture and export Mobile Window tape, Sponge LCD tape, Camera Window Tape etc

The Committee deliberated the proposal and noted that the proposal is based on deemed export basis. The unit would export its product to M/s Samsung india. The Committee approved the proposal subject to the condition that no DTA sale would be under taken.

- 1.3 (14) Proposal for conversion of existing DTA unit into 100% EOU by M/s Cometech Components (P) Ltd. Plot No. B 66, Basement and Ground Floor, Phase-II, Sector-80, Noida for manufacture and export Mobile Part (Main Window Tape, Camera Window Tape, Sponge Spker Tape, Sponge LCD Tape, Project Vinyl Tape).**

The Committee deliberated the proposal and decided to approve the proposal.

- 1.5 (14) Proposal to allow broad banding in items of manufacture in LOP by M/s Degania Medical Devices (P) Ltd. situated at 251, Sector-6, IMT Manesar, Gurgaon-122050**

The Committee deliberated the proposal and noted that the unit is engaged in manufacture and export of Medical disposable items and requested for broad banding in their LOP by adding Disposables Medical Drapes (Non woven fabric), Disposable Medical Drape, Disposable Medical Cover and Disposable Medical Gown. The Committee decided to approve the proposal as the items for broad banding have nexus to the items allowed for manufacture.

- 1.6 (14) Ratification of proposal for broad banding of items of manufacture in LOP by M/s Combitic Global Caplet (P) Ltd., M-15, D-2, D-3, Industrial area, Sonapat-131001.**

The proposal of the unit has been approved vide this office letter dated 16.01.2014 and the Committee ratified the proposal.
